The following information outlines some of the many activities staff is engaged in to further the Judicial Council's goals and priorities for the judicial branch. The report focuses on action since the council's January meeting and is exclusive of issues on the March business meeting agenda.

Legislative Advocacy

- The Chief Justice and Administrative Director held meetings with the Governor and legislative leadership to discuss judicial branch budget and legislative priorities.
- At a hearing of Senate Budget Subcommittee 5 (Corrections, Public Safety, and Judiciary), the Judicial Council Budget Services Director was joined by Presiding Judge Denine Guy, Superior Court of California, County of Santa Cruz, and Judge Stephen Manley, Superior Court of California, County of Santa Clara providing testimony in support of judicial branch budget priorities for fiscal year 2017–2018 by highlighting the detrimental human impact of reduced court budgets and services. Several courts were represented in public comment, including those from Solano, San Diego, Contra Costa, and Alameda Counties.
- February 17 was the deadline for introducing bills for the first year of the 2017–2018 legislative session. Judicial Council-sponsored bills introduced are as follows:
 - o AB 689 (Obernolte): Legal competency of juveniles.
 - o AB 789 (Rubio): Release on own recognizance.
 - o AB 976 (Berman): Electronic filing in juvenile law proceedings.
 - o <u>AB 1443 (Levine):</u> Retention of court records in gun violence cases.
 - o SB 38 and 39 (Roth): New judgeships and reallocation of judgeships.
 - o SB 403 (Canella): Disposition of unused courthouses.
 - o SB 670 (Jackson): Multiple county sentencing.

Chief Justice and Key Stakeholder Liaison Meetings

Staff coordinated annual liaison meetings between the Chief Justice and various judicial branch stakeholder organizations: California State Association of Counties, Consumer Attorneys Association of California, California Defense Counsel, California District Attorneys Association, California State Sheriffs Association, and Chief Probation Officers of California.

Branch Accounting and Procurement

- *Tax Year-End:* All year-end compliance reporting activities for trial courts were completed, including submission of electronic files and issuance of forms for taxes and required reporting for the Affordable Care Act.
- *Procurement Symposium:* A council-hosted symposium for appellate and trial court purchasing representatives focused on judicial branch contracting requirements, audits, prevailing wages, the virtual buyer program, insurance, and business warehousing.
- Chief Financial Officer (CFO) Winter Roundtable: A meeting of court CFOs included updates on revised financial policies and procedures, progress and capabilities related to the

- statewide Phoenix financial system, and additional services offered by the council's Branch Accounting and Procurement office.
- Phoenix Financial and Human Resources System Roadmap: Outreach to court stakeholders was completed for the purposes of developing functional improvement requirements for the statewide Phoenix financial system (used by all 58 courts) and the human resources system (used by 12 courts). The required improvements will provide a basis for developing a fiscal year 2018–2019 budget change proposal.

Labor and Employee Relations

Labor negotiations assistance was provided to nine trial courts. Services included successor Memoranda of Understanding negotiations, proposed policy revisions, and modifications to Employer-Employee Relations Rules. Additionally, support was provided on 28 different labor and employee related matters of the courts.

Empirical Study on Jury Instructions

As the council continues to consider and approve updates to its jury instructions, results of an empirical study published in February by the *Open Access Library Journal* found that mock jurors comprehended revised criminal jury instructions (CALCRIM)—spearheaded by the council and adopted in 2005—significantly better than the older version of instructions (CALJIC). Three-hundred and twelve native English speaking participants acted as mock jurors

and read through a trial transcript that varied juror instructions. Jurors were then asked to render a verdict, recommend a sentence, and were questioned on comprehension, legal definitions of reasonable doubt, circumstantial and direct evidence, and intent. Results demonstrated that jurors comprehended the revised instructions significantly better compared with the old instructions.

California Civic Learning Summit

The summit was convened with a focus on the revitalization of civil learning and engagement through the Chief justice's Civic Learning Initiative. Speakers included the Chief Justice, U.S. Supreme Court Justice Anthony Kennedy, Secretary of State Alex Padilla, and School Superintendent Tom Torlakson. More than 250 attendees, including state and federal judicial officers, representatives from organizations including county bar associations, law schools, state and local government leaders, nonprofits, and district superintendents and education leaders focused on civic learning partnerships.

Hack Foster Care Summit Silicon Valley

This national movement started during the Obama Administration, with the first Hack Foster Care event held at the White House. At the Silicon Valley summit, Judicial Council staff helped organize and lead two legal hacks: one on strategies to hear youth voices first in court proceedings, and another on obtaining and organizing information in court reports.

Violence Against Women Services Training Officers Prosecutors (STOP) Grant Advisory Committee

The STOP Grant increases the capacity of local communities to develop and strengthen effective law enforcement and prosecution strategies to combat violent crimes against women and develop and strengthen victim services. Staff facilitated review of federal funding updates and recommendations on new funding areas.

Technical Assistance in Family and Juvenile Court Proceedings

Judicial Council staff provide technical assistance to courts on multiple issues affecting family and juvenile court proceedings and services. Examples of technical assistance provided during this reporting period include: input to the Superior Court of Santa Cruz County on legal issues affecting juvenile delinquency process and procedures including confidentiality, access to records, and sealing; case file reviews at the Superior Court of Los Angeles County Girl's Succeeding through Achievement and Resilience Court, looking at criminal history, outcomes, and demographics of this specialized court, which works solely with human trafficking victims; and visits to juvenile courts in Amador, Butte, Kings, Merced, San Benito, and Yolo Counties to conduct courtesy file reviews and legal analysis of court case files to identify legal issues and training needs.

Appellate Court Clerk/Administrators Quarterly Meeting

The clerk/administrators discussed the planned inclusion of appellate courts in the Judicial Council's recurring audit program schedule, in addition to council human resources services and technology initiatives, and the branch's budget.

Advisory Committees/Task Forces/Working Groups

Judicial Council Advisory Body Leadership Meeting: Chairs and vice chairs of the council's 25 standing committees as well as several task forces and working groups met with Judicial Council internal committee chairs and Executive Office leadership to discuss the role of the advisory bodies in supporting the work of the council.

Meeting Details

Ability to Pay Workgroup

- Held a conference call with the Center for Court Innovation, which provides technical
 assistance to the US Department of Justice "Price of Justice" grantees. Provided a review of
 the project action plan to define current court and partner processes related to fine/fee
 assessment and ability to pay, and data available to analyze related issues.
- Presented at a workgroup meeting on related nationwide efforts, new rules of court, and facilitated a brainstorm session regarding desired components of an efficient, effective, and accessible ability to pay determination process.

• Staff attended and provided an overview of the Price of Justice grant project at the U.S. Commission on Civil Rights briefing on Targeted Fines and Fees against Low-Income Minorities: Civil Rights and Constitutional Implications.

Advisory Committee on Providing Access and Fairness

 Discussed increasing diversity in the branch, improving court services through user-centered design and process simplification, and continuing collaborations with other council advisory bodies.

Appellate Advisory Committee

- Reviewed public comments on proposed rules requiring expedited appellate review of orders in certain elder abuse cases, and recommended adoption of modified rules by the council.
- Reviewed proposals for legislative, rule, and form changes and recommended that several proposals be circulated for public comment, including proposals to amend statute regarding confidentiality of juvenile case files to address access by parties in appellate proceedings; amend rules relating to the use of settled statements in appeals in unlimited civil cases and approve a new form to help appellants prepare proposed statements; amend a rule to address the format of court reporter transcripts delivered in electronic form; and revise the form for designating the record in limited civil appeals to clarify the consequences of not providing a record of the oral proceedings and make other clarifying changes.

California Immigration Resource Workgroup

- Worked on improving the California Courts website to aggregate existing immigration resources available in California, develop new resources where appropriate, and disseminate these resources effectively and efficiently via the courts, legal associations, and other interested businesses and groups.
- Held a design session for the website at Stanford's Legal Design Lab, and attended the CJER training on immigration issues in domestic violence to inform these efforts that seek to address concerns and confusion among many Californians about resources or assistance state courts can and cannot provide, and to direct them to immigration resources that are available to support them.

Center for Judicial Education and Research Governing Committee

- Provided updates on the Advanced Judicial Studies Institute, Educational Needs Assessment Toolkit, leadership certification, and podcasts.
- Approved CJER liaison appointments to other council advisory bodies.

Civil and Small Claims Advisory Committee

- Worked with the Criminal Law Advisory Committee to sponsor a public comment session on the new rule and form to provide guidance to courts and litigants regarding AB 2298 (challenging a law enforcement agency's denial to remove one's name from a shared gang database).
- Recommended approval of several proposals to circulate for public comment, including:

- Amend statutes and rules of court to facilitate electronic filing and modern e-business practices;
- o Revise protective order forms to improve usability and conform to statutes;
- o Create a new default judgment form to ensure compliance with the Fair Debt Buying Practices Act; and
- Revise the writ of execution form to assist litigants with calculating payments due on a judgment.

Collaborative Justice Courts Advisory Committee

- Reviewed legislative updates and discussed how new technologies, such as electronic reminders, can improve court outcomes and reduce failures to appear.
- Veterans and Military Families Subcommittee: Discussed updates to the Veterans Treatment Court webpage to be more user-friendly, timely and accessible to veterans, their family members and those concerned about them.
- Mental Health Subcommittee: Reviewed mental health items on the committee's annual agenda, and discussed priorities, including identifying the effectiveness of mental health courts, and issues relating to juvenile competency.

Court Executives Advisory Committee

- Discussed driver license holds, budget messaging, and the role of advisory body liaisons.
 Updates were provided on audits, and the Judicial Council Technology Committee
 Technology Summit.
- Joint meeting with the Trial Court Presiding Judges Advisory Committee: Included Q&A session with the Chief Justice, and updates on information technology, audits, the Budget Change Proposal process, Language Access Plan implementation, and AB 2839 (Criminal Penalties: Nonpayment of Fines implementation).

Court Interpreter Advisory Panel

• Professional Standards and Ethics Subcommittee: Discussed developing a formal statewide policy on court interpreter skills assessment and ethics.

Criminal Law Advisory Committee

- Developed the following rule, form, and legislative proposals and circulated for public comment:
 - Proposed amendments to update all criminal rules of court to reflect changes to felony sentencing and other relevant laws.
 - Proposed standard of judicial administration to govern court use of information from risk/needs assessments at sentencing.
 - o Proposed amendments to rule 4.130 to identify what information must be included in court-appointed expert reports.
 - Revision to plea form, With Explanations and Waiver of Rights Felony (Criminal), regarding advising defendants on the consequences of violating terms of mandatory supervision and circumstances of the court accepting pleas and court authority to withdraw approval.

- o New forms to implement AB 813: Vacate a conviction or sentence based on: (1) a prejudicial error damaging the defendant's ability to meaningfully understand, defend against, or knowingly accept the actual or potential adverse immigration consequences of a plea of guilty or nolo contendere, or (2) newly discovered evidence of actual innocence.
- O Amendments to the penal code to eliminate several telephonic confirmation requirements between the magistrate and officer for arrest warrants issued electronically.
- Proposition 64 forms: Reviewed public comments received, held work group meetings to consider revisions to forms, and began drafting Judicial Council report.
- Developed proposals to implement Proposition 63; and reviewed other criminal law-related legislation.

Dual-Status Youth Data Standards Working Group

• Evaluated baseline goals for identified and defined outcomes, including research, the costs and benefits of county implementation, and costs if dually involved youth are not tracked. (Assembly Bill 1911 requires the council to convene this prescribed group of stakeholders and report to the Legislature by January 2018.)

Information Technology Advisory Committee

- Launched a new Intelligent Forms Workstream to modernize forms, improve the user experience, and increase interoperability with court case management systems.
- Considered sunsetting the Data Exchange Workstream and the council's Information Technology plan to operationalize and maintain the exchanges.

Judicial Branch Workers' Compensation Program Advisory Committee

- Reviewed and approved program recommendations developed by the Settlement Authority Working Group and the Alternative Deficit Reduction Working Group.
- Discussed member premium allocations for fiscal year 2017–2018.

Language Access Plan Implementation Task Force

- Convened a community outreach meeting, where updates were provided on expanding court interpreter services in civil cases, recruitment and retention of qualified interpreters and bilingual court staff, and use of technology to improve access to court services (video-remote interpreting, electronic signage, online information, etc.).
- Discussed agenda priorities for 2017; reported on translation, signage, and tools for the courts; and, with the National Center for State Courts, jointly presented on California's progress on language access metrics.

Pretrial Detention Reform Workgroup

Representatives from programs in Washington, D.C., Kentucky, New Jersey, and New
Mexico presented on their model programs, and representatives from Humboldt, Imperial,
and Santa Clara Counties shared information about their pretrial programs. The California
Department of Insurance Commissioner spoke about the department's role in regulating the
bail industry.

 Update provided by Criminal Justice Services Director on the workgroup and the Recidivism Reduction Fund pilot programs at a hearing convened by the California State Insurance Commissioner.

Traffic Advisory Committee

- Developed rule, form, and legislative proposals to amend Penal Code section 1209.5 (provide a uniform rate throughout the state for converting infraction fines into community service hours), and circulated for public comment (February 27–April 28).
- Reviewed traffic-related legislation.

Trial Court Budget Advisory Committee

• Discussed the Governor's budget proposal, the Children's Waiting Room Policy, and fiscal year 2018–2019 budget concepts.

Trial Court Facility Modification Advisory Committee

 Reviewed facility modification requests including those on energy efficiency, refined the seismic risk assessment database, and received an informational report on the \$45 million deferred maintenance list.

Trial Court Presiding Judges Advisory Committee

• Discussed budget and operations advocacy, audits, and the process for converting subordinate judicial officer positions.

Tribal Court-State Court Forum

• Reviewed a pilot project on civic learning partnerships relating to enforcement of tribal protection orders, child welfare, child support, civil money judgements, and proposed legislation regarding judge-to-judge communications.

Accountings and Financial Abuse

One-day class provides probate court investigators practice in conducting an accounting and discerning when and how to follow up on evidence of financial abuse of an elder.

Adoption Overview

One-day course provides court staff with a general grasp of the family law adoption process.

Advanced Core 40 for Managers and Supervisors

Three-day course requested by Fresno and Tulare court managers/supervisors included overcoming obstacles, self-awareness, coaching skills, and conflict management.

Adult Drug Court Standards: Equity and Inclusion

Webinar facilitation for the National Association of Drug Court Professionals. 124 registrants participated at sites throughout California and Nevada.

Annual Foster and Kinship Care Curriculum Conference

Focused on Indian Child Welfare Act topics for foster parent and kinship caregiver trainers throughout the state.

Appellate Management Institute

Three-day program for appellate managers and supervisors offered courses on leadership, communication, recruitment, and human resource management.

California Environmental Quality Act Overview

Procedural and substantive framework for judges and court attorneys to analyze and efficiently deal with the issues presented by a challenge made under CEQA to the approval of a public or private project.

Child Support Directors Association Children and Families Policy Symposium

Symposium on how child support professionals can improve the well-being of children and families, and the challenges many fragile families face on pathways to stability.

Civil Law Orientation

Comprehensive orientation to basic civil law and procedure designed for judges and subordinate judicial officers new to civil law, and judges and subordinate judicial officers from smaller courts without a full-time civil law caseload.

Confidential and Sealed Records

Interactive tutorial, recently added to the family law, civil, and probate staff toolkits, assists counter clerks in applying confidentiality requirements and processing requests to seal records.

Core 40: Basic Training for Managers and Supervisors

Provided for the Superior Court of Humboldt County as a local court requested program. Topics included the role of the supervisor, employment law, and performance management.

Core Leadership and Training Skills

Core Leadership regional program for leads/seniors/assistant supervisors at the Superior Court of San Diego County. Topics included effective leadership skills, providing effective feedback, and adult training principles.

Court Clerk Training Institute

Week-long courses on Civil, Juvenile, and Traffic provide formal classroom training for courtroom and legal process clerks.

Criminal Law Orientation

Criminal law and procedure for judges and subordinate judicial officers new to a criminal assignment.

Death Penalty Trials

Intensive course helps judges become familiar with and keep up-to-date on issues that are most difficult, specialized, and likely to present a risk of mistrial or reversal.

Difficult Witnesses

Regional course explores and offers guidance on legal and practical issues that can arise when witnesses take the stand.

Ensuring Equity for LGBTQ Youth in Juvenile Court

Best practices.

Evidence in Civil and Criminal Cases

Overview for judges and subordinate judicial officers of evidentiary issues that commonly arise in civil and criminal cases; includes breakout sessions emphasizing matters exclusive to each assignment.

Exploring Implicit Bias

Video in which moderators explore implicit bias, explain the difference between explicit and implicit biases, demonstrate how this bias impacts us, and discuss how to combat it.

Faculty Development Fundamentals

Four-day course for court staff faculty at the Superior Court of Orange County, reviewing principles of adult education, the structure of effective course development, and best practices for presentation and facilitation skills.

Faculty Development Fundamentals (Judicial)

Teach-back module version of Faculty Development Fundamentals. Faculty apply the principles and skills learned to a course segment they developed in a 20-minute teach-back demonstration.

Family Law Orientation

Comprehensive review of basic law and procedure necessary to handle family law matters in courts of various sizes.

Fundamentals of Felony Sentencing

Sentencing issues from probation grants to Three Strikes, and newly passed Propositions 57 and 64.

Institute for Court Management Workforce Management

Laws affecting human resources (HR) management in court; HR practices, policies and procedures; how to develop good employee relations; the importance of organizational development in a diverse world; and the importance of human development, mentoring, and succession planning.

Juvenile Dependency Orientation

Review of juvenile dependency law and procedure; the philosophy and responsibilities that underlie the child welfare system and the dependency court; child development; substance abuse; mental health; domestic violence; disproportionately high minority contact; issues affecting LGBTQ children and families; psychotropic medication; and the role of the judicial officer in juvenile court, and his or her unique ethical issues.

Juvenile Delinquency Orientation

Examination of all aspects of juvenile delinquency law and procedure, including the philosophy that underlies delinquency law, applicable statutes, rules of court, and case law.

Managing Emotionally Charged Custody Hearings

Video discussion on handling emotionally charged hearings in family court. Additionally four 10-Minute Mentor videos are derived from the full-length video: Characteristics of Parties in Highly Contested Cases; A Method for Avoiding Engagement with the Parties in Highly Contested Cases; Tools for Managing Emotionally Charged Hearings; and Preparing an Order in Highly Contested Cases.

New Judge Orientation

One-week orientation program introduces new judges, commissioners, and referees to their judicial duties and familiarizes them with ethical responsibilities in ensuring fairness in all proceedings, promoting uniform court practices, and improving the administration of justice.

Probate Orientation

Designed for judges, commissioners, probate attorneys, and probate examiners for conservatorship and guardianship education requirements; includes domestic violence education.

Definitions:

Authorized Position (FTE) Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

Filled Authorized Position

Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

(FTE)

Headcount The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or

Employment Agency Temporary Workers.

Vacancy (FTE) The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

Judicial Council Temporary Employees (909) The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement service credit).

Contractor (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where

recruitment issues require the use of a contractor.

Full Time Equivalency (FTE) Full Time Equivalency (FTE) Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would

consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.

Time Base Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

Regular Employee Commonly referred to as "permanent employees" – They receive full benefits.

Limited Term Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.
