### **Executive Summary**

The Legislation Committee represents the Judicial Council's position with other agencies and entities, such as the Legislature, the Governor's Office, local government, statewide and local bar associations, and other court-related professional associations and stakeholders. The committee determines positions consistent with the council's policy goals and oversees advocacy for those positions. This report summarizes the committee's activities since the last Judicial Council internal committee written report, which was submitted for the council's November 17, 2023, business meeting.

#### 2023–2024 Legislative Session

The first year of the 2023–2024 Legislative session ended September 14, 2023.

Governmental Affairs staff are currently tracking over 1,693 bills and have provided technical drafting assistance on over 50 bills so far in the second year of the 2023–2024 Legislative Session.

#### **Overview of Committee Meetings**

- Assembly Bill 2283 (Pacheco), as amended May 2, 2024, Civil actions: electronic service. (Sponsor)
- Assembly Bill 3049 (Bryan), as amended April 17, 2024, Dependency: court hearings. (Oppose unless amended)

At the committee's June 6 meeting, the committee reviewed and voted on the following bill:

• Assembly Bill 2125 (Garcia), as amended May 16, 2024, Judicial officers: disqualification. (Remove opposition)

At the committee's June 20 meeting, the committee reviewed and voted on the following bills:

- Assembly Bill 2347 (Kalra), as amended May 21, 2024, Summary proceedings for obtaining possession of real property: procedural requirements. (Oppose unless amended)
- Assembly Bill 3196 (Stephanie Nguyen), as amended April 11, 2024, Summary proceedings for obtaining possession of real property: demurrers. (Oppose unless amended)

#### **Key Deadlines**

The last day for the Legislature to pass bills is August 31, 2024.

The deadline for the Governor to sign or veto bills is September 30, 2024.
