The report focuses on action since the council's meeting on March 15, 2024, and is exclusive of items on the May business meeting agenda.

Judicial Branch Budget

Details and context on the Governor's proposed May budget revisions relating to the fiscal year 2024–25 budget for the judicial branch were shared with court leaders. The May Budget Revision informs the branch's advocacy efforts leading up to the June 15 constitutional deadline for the Governor to sign the state budget for the new fiscal year that begins on July 1, 2024.

Legislative Advocacy

- The 2024 Legislative Status Chart, published on the California Courts website, lists positions taken by the Judicial Council's Legislation Committee on pending bills.
- Judicial Council senior staff and court leadership shared information on collaborative justice drug courts at an informational Senate subcommittee hearing on healthcare for the justice-involved and reentry population.

Expansion of Online Ability-to-Pay Tool

Statewide expansion of MyCitations, the online tool to submit a fine reduction request for infractions, continued with deployment to the superior courts in Alpine, Contra Costa, Del Norte, Inyo, Kern, Riverside, and Sonoma Counties. Fifty courts are now using the ability-to-pay application.

Pretrial Release Program

Court site visits were conducted for the Superior Courts of Fresno, Mariposa, Merced, Stanislaus, and Tuolumne Counties to observe proceedings related to the pretrial release program, visit probation and jail partners, discuss program features, local guidelines, and address any program challenges.

Community Assistance, Recovery, and Empowerment (CARE) Act

Two convenings of the second CARE Court implementation cohort, (the remaining 50 trial courts), provided the opportunity to work on implementation plans for launching their CARE Courts in December 2024. A site visit was conducted with the Superior Court of San Francisco County and the county's Behavioral Health department and local housing programs. Additionally, the Legal Services Trust Fund Commission's CARE Court Grants Committee approved the request for proposals for fiscal year 2024–25 CARE Act Representation Grants.

Court Facilities Management and Maintenance

- Forty-one real estate transactions were completed, including lease renewals/extensions in 14 counties, event licenses, and Department of Rehabilitation permits.
- As of May 2024, there are 1,254 court facility modifications in progress at an estimated cost of \$443 million.

Audit Services

Fieldwork was completed for audits of the Superior Courts of Calaveras, Contra Costa, Kings, and Plumas Counties.

Diversity in Recruitment

The judicial branch was represented at the 2024 Training Symposium of the Association of California State Employees with Disabilities as well as at virtual career fairs for the Native American and Indigenous Workforce, the Pathways to California State Employment Inclusive Hiring event, and Diversity and Inclusion Government and Non-Profit Jobs.

Labor and Employee Relations

Labor negotiations assistance was provided to 17 trial courts, including side-letter negotiations, impact bargaining, and successor memoranda of understanding. Additionally, support was provided to courts on 25 labor and employee-related matters.

Juvenile Judicial Resources and Technical Assistance Program

Reviews of juvenile case files were conducted in the Superior Courts of Alameda, Imperial, Inyo, and Los Angeles Counties to identify any legal issues and training needs.

Bilingual Interpreter Testing

The certified language examination was conducted at several test locations in Northern and Southern California with 167 Spanish language examinations administered.

Collaboration with Justice Stakeholders

Examples of recent stakeholder collaborations:

- Council of Criminal Justice and Behavioral Health: Mental health diversion and criminal justice projects affecting trial courts.
- Attorney General's Criminal History Record Improvement Advisory Committee: Crossbranch solutions to data improvement.
- Department of State Hospitals: Incompetency to stand trial evaluator training, report quality improvement project, and best practices training for completing quality evaluations.

Staffing Category	Definition
Authorized Position (FTE)	All regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full-time equivalency.
Filled Authorized Position (FTE)	The number of authorized positions filled based on the employee's full-time equivalency.
Headcount	The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1." This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	The number of authorized positions divided by the number of vacant authorized positions, excluding temporary employees ("909" funded employees). See Judicial Council Temporary Employees, below.
Judicial Council Temporary Employees (909)	An employee whose salary is not funded through the Budget Act and who may receive benefits if employed at least half-time and the term of employment is for more than six months. A 909 position is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees because of the unavailability of an authorized vacant position. Types of "909" Temporary Employees include retired annuitants, who are hired by their former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis; they do not receive full benefits (but do receive CalPERS retirement service credit).
Employment Agency Temporary Workers (FTE)	Workers from/employees of an employment agency who provide short-term support.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	The number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full-time job all year would consume one FTE. One employee working for 1,040 hours each year would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits. Intermittent: Employee has no established work schedule and works on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees." They receive full benefits.
Limited Term	A position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employees in limited-term positions may be regular or temporary.
