#### **Executive Summary**

The Trial Court Budget Advisory Committee recommends maintaining the current funding allocation methodology for self-help funding allocated to the trial courts for fiscal year 2024–25 and ongoing. The next allocation changes based on population using this methodology would be made in fiscal year 2027–28. This recommendation will ensure that resources are allocated effectively and will provide adequate notice to courts so they can plan for funding changes.

#### Recommendation

The Trial Court Budget Advisory Committee (TCBAC) recommends that the Judicial Council, effective July 12, 2024, continue the current funding allocation methodology for related to self-help funding to trial courts for fiscal year 2024–25 and ongoing, as follows:

- 1. Maintain a three-year population update schedule using rolling three-year average census data;
- 2. Provide annual population updates to trial courts using rolling three-year average data for informational purposes only; and

3. Maintain the current self-help allocation baseline of \$34,000 per court.

The proposed fiscal year 2023–24 self-help funding amounts are provided in Attachment A.

### **Relevant Previous Council Action**

At its September 2018 meeting, the Judicial Council adopted new policy recommendations for self-help funding to be allocated to trial courts effective for fiscal year (FY) 2019–20 allocations and ongoing.<sup>1</sup> At its July 2021 meeting, the council maintained the policy recommendations for self-help funding to be allocated to trial courts effective for FY 2021–22 allocations and ongoing.<sup>2</sup> These allocations are identical to those presented in the recommendation, above, for FY 2023–24 and ongoing.

# Analysis/Rationale

The current allocation methodology for self-help funding (see Attachment A) has two major components: a baseline level of funding of \$34,000 and a proportionate share of funding that is based on each court's population relative to the state population (see Attachment B). Until the FY 2018–19 budget allocations, self-help funding in trial courts had been allocated based on 2006 population data. To use the most current data available while providing stable funding to the courts, the committee recommended that a three-year average be calculated every three years and that the court allocations be updated at that time.

The baseline level of funding was chosen because it represented the cost of 0.3 FTE (full-time equivalent) of a family law facilitator, the classification most appropriate to staff a self-help center, in 2006.

#### **Policy implications**

The proposed changes are consistent with other council-approved actions to make regular updates to allocation methodologies based on updated data.

#### Comments

Public comments were not solicited for this proposal because the recommendation is within the Judicial Council's purview to adopt without circulation.

## Alternatives considered

The proposal was unanimously approved as is; no alternatives were discussed.

## **Fiscal and Operational Impacts**

Courts may experience changes in their self-help allocations when the allocation data are updated. However, the methodology is designed to give courts ample time to plan for these changes and the operational impact is expected to be minimal.
