The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's meeting on May 17, 2024, and is exclusive of items on the July business meeting agenda.

# Online Ability-to-Pay Tool Now Statewide

Statewide expansion of MyCitations, the online tool to submit a fine reduction request for infractions, was completed for all 58 superior courts by the legislative deadline of June 30, 2024, with final deployments to the superior courts in Lake, Los Angeles, Napa, Orange, Sacramento, San Bernardino, Stanislaus, and Tuolumne Counties. Since April 2019, 174,331 fine reduction requests have been submitted, 86 percent of which were approved for some form or relief. Statewide, 250 judges are registered to review MyCitations petitions.

#### **Youth Court Summit**

The 19th Annual California Youth Court Summit convened approximately 200 youth and adults, including judicial officers, court staff, and juvenile justice stakeholders on ways to better serve justice-involved youth through restorative justice principles. Highlights included the youth court mock trial, and sessions on the California Service Corps; building bonds between law enforcement, youth, and the juvenile justice system; and how to effectively prepare jurors.

#### **Data Analytics Summit**

Approximately 170 court professionals convened for the fourth Data Analytics Summit. The program included sessions led by court staff on topics such as data quality, optimizing business processes through data analytics, and training on the Power BI data visualization platform. The summit supports the judicial branch's focus on improving data management, collection, and data-driven decision making.

#### **Resource Assessment Study**

Briefings were conducted with the 19 courts participating in the Resource Assessment Study update, specifically, the time study for updating caseweights used to measure staff workload need. The representative sample includes small, medium, and large courts, and rural, urban, and suburban courts. A report will be presented to the council at the February 2025 meeting.

# Community Assistance, Recovery, and Empowerment (CARE) Act

Bench officers in the first cohort of courts implementing the CARE Act (Glenn, Los Angeles, Orange, Riverside, San Diego, San Francisco, Stanislaus, and Tuolumne Counties), participated in a roundtable discussion, and a meeting was conducted with the Superior Court of Modoc County and its county partners on preparing for implementation by December 2024.

#### **Pretrial Release Program**

A site visit was conducted at the Superior Court of Alameda County to observe pretrial court proceedings, visit with local probation and jail partners, discuss local guidelines, program features, and address any program challenges with possible solutions. A meeting also was held with leadership from the Chief Probation Officers of California to discuss pretrial reform efforts statewide.

#### **Judicial Resources and Technical Assistance Program**

Reviews of juvenile case files were conducted in the Superior Courts of Mono, Tulare, and Yolo Counties to identify any legal issues and training needs.

#### **Court Facilities Management and Maintenance**

Twenty-five real estate transactions were completed, including event licenses, Department of Rehabilitation permits, and lease renewal/extensions in 12 counties. As of July 2024, there are 847 court facility modifications in progress at an estimated cost of \$458 million.

#### **Emergency and Continuity of Operations Planning**

A review of emergency and continuity of operations plans was provided at the request of two trial courts.

# **Labor and Employee Relations**

Labor negotiations assistance was provided to 17 trial courts. Services included side letter negotiations, impact bargaining, and successor memoranda of understanding negotiations. Additionally, support was provided on 26 different labor and employee-related matters.

# **Digital Modernization**

Redesigned websites were launched for the <u>Courts of Appeal</u> and the Superior Court of <u>Santa Clara</u> County. The website redesigns and migrations are part of ongoing web modernization efforts, with more than 40 trial court websites already launched on the new platform.

# **Language Access Services: Court Interpreting**

- Following the spring, limited administration of the Bilingual Interpreting Examination for Spanish, 20 out of 167 candidates (12 percent) passed the examination. The successful candidates have been invited to enroll with the Judicial Council as California court interpreters. Candidates who were close to passing the examination are tracked and invited to participate in future near-passer trainings, supporting efforts to increase the number of certified court interpreters.
- The <u>application</u> process opened for candidates to participate in a five-year Court Interpreter Workforce <u>Pilot Program</u> to increase the number of court interpreter employees by reimbursing program candidates for costs associated with training, coursework, and examinations. Applications are due by August 1.
- The Judicial Council worked with the National Center for State Courts to create a <u>recruitment video</u> on becoming a California court interpreter. The video features experienced court interpreters discussing why they joined the profession and the importance of interpreter services to the administration of justice.

#### **Justice Partner Collaborations**

- *Mental Health Courts:* Judicial Council staff collaborated with the Council of State Governments Justice Center on a series of mental health trainings. (Judicial officers also were surveyed to better understand the quality of Incompetent to Stand Trial Evaluation Reports.)
- *Mental Health Diversion:* Staff collaborated with the Department of State Hospitals and Council of State Governments to discuss trainings on mental health diversion for local justice partners, use of remote hearings in diversion cases, and improving justice system collaboration to support diversion, county behavioral health, and other community forensic programs.

Collaborative Justice Courts: California was represented by council staff at the annual
meeting of the Council of State Treatment Court Coordinators, held in conjunction with the
25th national All-Rise Conference on addiction, mental health, and justice reform. The
conference provided an opportunity for state treatment court administrators throughout the
country to meet with federal funders, technical assistance providers, and policymakers
focusing on technical assistance and best practice standards.

### **Legislative Advocacy**

Following the deadline for bills to be passed out of the house of origin, Governmental Affairs staff are tracking and reviewing 1,726 bills related to court procedure and administration, out of a total of 5,502 bills that were introduced.

# **Meeting Details**

# Advisory Committee on Audits and Financial Accountability for the Judicial Branch

• Recommended Judicial Council approval of annual updates to the Judicial Branch Contracting Manual, 15th edition, to strengthen fraud reporting controls related to contracting and procurement activities, as recommended by the California State Auditor.

- Approved Audit Services' fiscal year 2024–25 audit plan, which includes initiating eight trial court audits.
- Approved finalization and <u>publication</u> of audit reports for the Superior Courts of Calaveras and Contra Costa Counties.

# **Advisory Committee on Providing Access and Fairness**

• Recommended to the Judicial Council Equal Access Fund distribution for the California Access to Justice Commission.

# **Artificial Intelligence Task Force**

• At its first meeting, the newly established task force discussed its charge and goals and heard a presentation on the use of generative AI.

# **Civil and Small Claims Advisory Committee**

• Approved recommending proposals for council action following the spring public comment period and approved issuing an invitation for public comment regarding debtor's examinations in small claims cases to go out on a special comment cycle.

# **Collaborative Justice Courts Advisory Committee**

- Hosted a diversity, equity, and inclusion training for collaborative court multidisciplinary teams from the Superior Courts of Alameda, Sacramento, San Francisco, and Solano Counties.
- Recommended to the Judicial Council trial court allocations for the Substance Abuse Focus Grant and the Dependency Drug Court funding augmentation.
- Discussed pending legislation with the Criminal Law Advisory Committee that falls under the purview of both committees, including amending criminal procedure and treatment court standards.
- Received a presentation on state mental health services from the Superior Court of Solano County.
- Racial Justice, Equity, and Inclusion, Mental Health, and Veterans and Military Families Subcommittees: Discussed a final report for submission to the Judicial Council, court processing challenges and successes regarding incompetent to stand trial misdemeanor cases, and program collaboration with justice system partners.

• Published the updated <u>Trial Court Records Manual</u>. Updates included references to statutory mandates and streamlining of various sections.

- Reviewed informational reports on the Judicial Branch Courthouse Construction Program and feasibility study findings for the new Hall of Justice project for the Superior Court of San Francisco County.
- Reviewed site selection, including preferred and alternate sites, for the new Santa Clarita Courthouse project for the Superior Court of Los Angeles County.

# **Court Interpreters Advisory Panel**

• Reviewed proposed post-comment revisions on rule and form changes necessitated by Assembly Bill 1032 (Stats. 2023, ch. 556), which made significant changes and improvements to the Trial Court Interpreter Employment and Labor Relations Act.

#### **Criminal Jury Instructions Advisory Committee**

• Reviewed 21 proposals for changes to instructions, including proposed revisions to gang instructions; kidnapping for ransom, reward, or extortion; and violation of a court order.

# **Criminal Law Advisory Committee**

- Discussed legislation, including new criminal procedures related to remote court appearances and incompetency to stand trial procedure.
- Pretrial Policy and Data Subcommittee: Discussed the role of pretrial risk assessments in pretrial determinations and received a risk assessment presentation from Dr. Sharad Goel, a leading expert in the field.

# Remote Access to Electronic Court Records Working Group

# **Shriver Civil Counsel Act Implementation Committee**

Staffing Category	Definition
Authorized Position (FTE)	All regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full-time equivalency.
Filled Authorized Position (FTE)	The number of authorized positions filled based on the employee's full-time equivalency.
Headcount	The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1." This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	The number of authorized positions divided by the number of vacant authorized positions, excluding temporary employees ("909" funded employees). See Judicial Council Temporary Employees, below.
Judicial Council Temporary Employees (909)	An employee whose salary is not funded through the Budget Act and who may receive benefits if employed at least half-time and the term of employment is for more than six months. A 909 position is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees because of the unavailability of an authorized vacant position. Types of "909" Temporary Employees include retired annuitants, who are hired by their former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis; they do not receive full benefits (but do receive CalPERS retirement service credit).
Employment Agency Temporary Workers (FTE)	Workers from/employees of an employment agency who provide short-term support.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	The number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full-time job all year would consume one FTE. One employee working for 1,040 hours each year would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.  Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.  Intermittent: Employee has no established work schedule and works on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees." They receive full benefits.
