Executive Summary

The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's meeting on September 20, 2024, and is exclusive of items on the November business meeting agenda.

Community Assistance, Recovery, and Empowerment (CARE) Act

With a December 1, 2024, deadline and following initial implementation by the eight Cohort One trial courts, the remaining 50 courts that make up Cohort Two are on track to implement the CARE Act. During this reporting period, implementation meetings were held with 19 courts. Pre-launch implementation convenings were also held with county planning teams in Sacramento and San Jose to support and strengthen the rollout of the CARE Act. In the first 12 months of the program, October 2023 to September 2024, early implementing courts received 787 petitions. The courts and the Judicial Council have collaborated closely with state and county partners to ensure successful implementation.

Judicial Officer Data Analytics Summit

Nearly 40 commissioners, judges, and justices in 25 counties and appellate districts across the state convened for the Judicial Officer Data Analytics Summit. During the virtual program, judicial officers explored dynamic data dashboards used by leading courts, learned strategies for data-driven decisionmaking, and gained insights into effective collaboration with analytics teams.

Court Facilities

Twenty-seven real estate transactions were completed, including event licenses and easements in 13 counties. As of October 2024, there are 765 court facility modifications in progress at an estimated cost of \$428 million.

Digital Services Modernization

As part of the deployment of mobile-friendly and customizable trial court website templates with integration to statewide digital services, an intelligent chatbot was launched on the Superior Court of Lassen County's website for Traffic, Small Claims, and Name Change services. Six superior courts are now using the chatbot (Kings, Lassen, San Francisco, San Luis Obispo, San Mateo, and Sutter Counties). The service is scheduled to be launched for the following additional courts beginning in January 2025: Fresno, Napa, San Benito, San Bernardino, and Sonoma Counties.

Judicial Resources and Technical Assistance Program

Reviews of juvenile case files were conducted in three superior courts (Lassen, Nevada, and San Bernardino Counties) to identify any legal issues and training needs. In fiscal year 2023–24, council staff visited 25 courts, including multiple visits to large counties, for a total of 44 site visits. Follow-up training was provided for nine courts. All 58 trial courts are visited on a rotating basis.

Legislation

- The Governor signed Judicial Council-sponsored legislation authorizing the council sale of the Gordon D. Schaber Sacramento County Courthouse and requiring the net proceeds from the sale to be deposited into the State Court Facilities Construction Fund. The council will seek authority for the sale of an additional three court facilities in 2025.
- The Governor also signed the following bills requested for signature by the Judicial Council:

- Assembly Bill (AB) 1785—California Public Records Act. AB 1785 prohibits a state or local agency from publicly posting the home address, telephone number, or both the name and assessor parcel number associated with the home address of any elected or appointed official without that official's written permission.
- Assembly Bill 2929—Dependents: family finding. AB 2929 requires the court, in conducting periodic status reviews of a child or nonminor dependent not residing with relatives, to determine whether the social worker has continued efforts to locate any relatives who could provide family support or possible placement.

Labor and Employee Relations

Labor negotiations assistance was provided to 21 trial courts. Services included impact bargaining and successor memoranda of understanding negotiations. Additionally, support was provided on 33 different labor and employee-related matters.

Workforce Career Fairs

To promote public service employment opportunities with the judicial branch, staff participated in a virtual career fair for the Native American and Indigenous Workforce and an in-person career fair for business and public service at the University of California at Davis.

Federal Grant Funding: Byrne State Crisis Intervention Program

The Judicial Council entered into an agreement with the Board of State and Community Corrections to administer \$17 million in US Department of Justice State Crisis Intervention Program funding. A Request for Proposal was released in May 2024 and in September six courts (Sonoma, Solano, San Joaquin, Sacramento, San Francisco, and Santa Clara) were awarded approximately \$9 million in funding to establish or enhance mental health diversion and veteran's treatment courts with a focus on gun relinquishment processes for program participants prohibited from possessing firearms. A second Request for Proposal seeking to fund additional participating courts will be released in March 2025.

Judicial Branch Education

More than 30 education and training programs and resource tools were created, updated, or delivered for judicial officers, court personnel, and justice system partners during this reporting period. For judicial education, this included the Judges and Psychiatrists Leadership Initiative, a training on courtroom interactions with defendants and other court users with mental illness. Joint education programs for judicial officers, court employees, and justice partner partners included the Pathways to Justice Conference, co-sponsored with the California State Bar and the Legal Aid Association of California. The conference convened court-based self-help center staff, nonprofit legal services providers, and pro bono organizations for three days of training on serving low-income and self-represented litigants. Distance education programs included videos and podcasts addressing sharing best practices for increasing access to justice and supporting judicial officers in family court, and in The Digital Judge series, a session on self-driving cars, the technology behind them, safety concerns, and potential legal implications. Publication updates included the Benchbook on Civil Proceedings Discovery.

Advisory Committee on Providing Access and Fairness

- Approved the draft 2025 annual agenda and draft report on the Equal Access Fund distribution to the California Access to Justice Commission.
- Ad Hoc Racial Justice Working Group: Received a briefing on the Racial Justice Toolkit.

- Reviewed performance criteria and the schematic design for the new courthouse project for the Court of Appeal, Sixth Appellate District.
- Reviewed site selection options for the new Nevada City Courthouse project.

• Reviewed the draft 2025 annual agenda, and approved revisions to the Professional Standards and Ethics for California Court Interpreters and Guidelines for Approval of Certification Programs for Interpreters for Deaf and Hard-of-Hearing Persons.

Court Reporters Working Group

• Provided feedback on proposed changes to the Court Reporter Recruitment, Retention, and Attrition dashboard.

Criminal Jury Instructions Advisory Committee

• Reviewed modifications to the user guide and 19 proposals for instructions change, including a new instruction based on Vehicle Code section 10802 (Vehicle Identification Numbers tampering).

Criminal Law Advisory Committee

- Conducted a court visit with the Superior Court of Santa Clara County and local pretrial services partners to learn more about their early engagement programs: pre-arraignment representation and review, new warrant surrender protocols, and mental health arraignments. Also provided an educational session for the Santa Clara bench on pretrial case law.
- Discussed proposals to revise the felony plea form, amend the rule of court on mental competency proceedings to address newly passed legislation, and create new forms to implement Assembly Bill 3209 (retail theft restraining orders).
- Pretrial Policy and Data Subcommittee: Discussed current case law relating to pretrial procedures and the process of accessing criminal record information in the pretrial phase.

Data Analytics Advisory Committee

- Discussed the components of the Resource Assessment Study model update, including the
 work year value and other model parameters used in the development of the updated
 caseweights.
- Reviewed how court clusters (small, medium, large) impact the workload models and formula.

Family and Juvenile Law Advisory Committee

- Reviewed the draft 2025 annual agenda, oriented new members, and developed recommendations on allocations and reimbursements to trial courts for the Firearm Relinquishment Grant Program (fiscal year 2024–25 through 2025–26).

Remote Access to Electronic Court Records Working Group

• Discussed potential revisions to California Rules of Court to implement the Judicial Council's Remote Access to Electronic Court Records—Policy, Rationale, and Guidance.

Traffic Law Advisory Committee

• Recommended changes to the Uniform Bail and Penalty Schedules, and collaborated on the annual agenda.

Trial Court Budget Advisory Committee

- Approved fiscal year 2024–25 allocations for additional grant funds to current Sargent Shriver Civil Counsel Pilot Program recipients, increased transcript rates for court reporters, Cycle 3 grant awards for the Firearm Relinquishment Pilot Program, and fiscal year 2023–24 final adjustments for year-end fund balances for courts.
- *Fiscal Planning Subcommittee:* Considered requests for the Funds Held on Behalf of the Trial Courts program for the annual submission cycle for fiscal year 2023–24.
- Funding Methodology Subcommittee: Considered court interpreter allocations and expenditures for fiscal years 2023–24 and 2024–25 based on increased program costs, and workload formula allocation methodology options for potential future budget reductions or funding restoration.

Trial Court Facility Modification Advisory Committee

- Authorized expenditures of \$11.7 million and an additional \$105,755 for security-related projects.
- Approved the 2025 annual agenda and the *Trial Court Facility Modifications Report for Quarter 1 of Fiscal Year 2024*–25 for submission to the Judicial Council.
- Received updates on court-funded requests, facility modifications on hold, sustainability updates, facilities maintenance performance, deferred maintenance projects, court facility architectural revolving fund projects, and lactation projects.

Trial Court Presiding Judges Advisory Committee

• Discussed caseflow management, access to a verbatim record, and received updates from the California State Bar on changes to notification to courts on attorney license status.

Staffing Category	Definition
Authorized Position (FTE)	All regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full-time equivalency.
Filled Authorized Position (FTE)	The number of authorized positions filled based on the employee's full-time equivalency.
Headcount	The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1." This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	The number of authorized positions divided by the number of vacant authorized positions, excluding temporary employees ("909" funded employees). See Judicial Council Temporary Employees, below.
Judicial Council Temporary Employees (909)	An employee whose salary is not funded through the Budget Act and who may receive benefits if employed at least half-time and the term of employment is for more than six months. A 909 position is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees because of the unavailability of an authorized vacant position. Types of "909" Temporary Employees include retired annuitants, who are hired by their former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis; they do not receive full benefits (but do receive CalPERS retirement service credit).
Employment Agency Temporary Workers (FTE)	Workers from/employees of an employment agency who provide short-term support for six months or less.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period (one-year or less) or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	The number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full-time job all year would consume one FTE. One employee working for 1,040 hours each year would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits. Intermittent: Employee has no established work schedule and works on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees." They receive full benefits.
Limited Term	A position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employees in limited-term positions may be regular or temporary.
