
CARE Act: Sharing the Community Journey

Superior Court of Orange County Updates

A. Pre-Implementation Date of October 1, 2023:

- Self-Help and internal staff-training
- Substantive and procedural separation from criminal operations
- Cohort 1 regular meetings of judicial officers

Superior Court of Orange County Updates (continued)

B. Post October 1, 2023:

- Number of petitions and breakdown
- Defining and communicating measures of success
- Limitations on eligibility not leading to perceived failure
- Empowering petitioners for the benefit of respondents

C. The Road Ahead:

- Continuing to educate and inform the impacted population
- Increasing engagement by qualifying agencies, institutions, and organizations
- In-custody respondents
- Preparing for impact of Senate Bill 43

Superior Court of San Diego County Updates

A. CARE Act Preparation for Successful Implementation:

- Form Stakeholder Implementation Teams: County and court members work collaboratively on policy, procedures, and practice.
- Schedule monthly meetings with implementation teams to develop action items, assign tasks, schedule completion dates, and track progress.
- Focus on Key Priorities: (SDSC key priories)
 - Access to court process for all participants
 - Collaborative court model
 - Legal support for self help services and supportive decision-making
 - Proactive Community Outreach and Education: website, publications, media, and countywide press conference.

Superior Court of San Diego County Updates (continued)

B. CARE Act Proceedings to Date:

- CARE Act petitions filed, prima facie determinations, and subsequent court hearings.
- Challenges to locating, assessing, and engaging respondents.
- CARE Agreement/CARE Plan components.
- Building community connections for long-term support and services.

C. CARE Act – Building on Success and Moving Forward:

- Communicate successful CARE Act outcomes to build trust and increase participation.
- Expand CARE Act legal support services to our 13 neighborhood community centers.
- Target CARE Act community outreach and education to underutilized areas of the county.
