## **Executive Summary**

The Trial Court Budget Advisory Committee recommends approving a \$1.4 million augmentation to the fiscal year 2025–26 Trial Court Trust Fund allocation for the Sargent Shriver Civil Counsel Program. The additional funding would be taken from program reserves and distributed on a pro rata basis to current Shriver projects to expand and sustain legal representation and court services in housing and other civil cases.

### Recommendation

The Trial Court Budget Advisory Committee recommends the Judicial Council, effective October 24, 2025, approve an increase to the approved fiscal year (FY) 2025–26 Trial Court Trust Fund allocation for the Sargent Shriver Civil Counsel Program of \$1.4 million, which results in a total program allocation of \$19.6 million for the current year. This amount will be allocated and distributed to current Shriver projects, on a pro rata basis according to the award amounts for the 2023–26 grant cycle, for FY 2025–26 as identified in Attachment A.

#### **Relevant Previous Council Action**

On July 21, 2023, the Judicial Council approved the Shriver Civil Counsel Act Implementation Committee's recommendation of 14 three-year grants for a total of \$48.3 million to qualified legal services providers and their court partners for the administration of projects during the 2023–26 grant cycle. The approved grants totaled \$15.8 million for FY 2023–24.

On November 15, 2024, the council approved a one-time midcycle allocation of \$3.569 million of the \$5 million made available to providers from the Sargent Shriver Civil Counsel Act grant program's existing Trial Court Trust Fund (TCTF) reserves to current Shriver projects. The council also approved designating the unrequested amount of \$1.4 million in program reserves for allocation in the 2026–29 grant cycle.<sup>2</sup>

On July 18, 2025, the council approved the FY 2025–26 TCTF local assistance allocation of \$18.2 million for the Shriver program.<sup>3</sup>

## Analysis/Rationale

Funding for the Sargent Shriver Civil Counsel Program has been augmented in recent years by fee revenue and one-time settlement revenue directed to the program by the Legislature. Funding is allocated through a competitive solicitation process every three years to courts and their justice partners. Although the program makes every effort to disseminate the grant opportunity and encourage applications, overall revenues have exceeded expenditures. The total reserve funding for the program before the recommended distribution is \$15.3 million. By statute, unspent funds are held in reserve exclusively for the program and cannot be used for other trial court purposes.<sup>4</sup>

On June 5, 2025, the Shriver Civil Counsel Act Implementation Committee approved allocating the remaining \$1.4 million funding to current Shriver projects in FY 2025–26, rather than reserving it for the 2026–29 grant cycle. This approval was made in response to recent wildfires that caused significant housing loss and cuts in federal funding. The \$1.4 million was the unallocated portion of the \$5 million made available to existing Shriver projects in FY 2024–25, which was held in reserve for the next grant cycle. In support of this request, on June 9, 2025, a request for proposals was issued to current Shriver projects, inviting them to submit revised

project plans, budgets, and budget narratives detailing how they would use a proposed pro rata allocation. Of the 14 Shriver projects, 12 submitted proposals for their full pro rata amount, one submitted a proposal for less than its share, and one project declined its full pro rata share.

On July 18, 2025, the Shriver Committee approved 13 proposals via vote by email recommending the augmentation of up to \$1.4 million from program reserves to support current projects. This augmentation would bring funding allocations for the 2023–26 grant cycle to the total of \$53,033,963.<sup>6</sup> Attachment A displays the \$3.56 million pro rata midcycle allocation amounts and the proposed \$1.4 million midyear augmentation amounts, both based on the pro rata share of the 2023–26 grant cycle allocations. It summarizes total funding for each project, including the initial grant awards, the midcycle allocations, and the proposed midyear augmentations. Following the allocation of \$1.4 million, the remaining reserve balance for the program will be \$13.9 million.

This recommendation to approve an increase to the approved FY 2025–26 TCTF allocation through an augmentation of \$1.4 million was approved by the Revenue and Expenditures Subcommittee of the Trial Court Budget Advisory Committee on August 12, the Trial Court Budget Advisory Committee on August 25, and the Judicial Branch Budget Committee on September 4, 2025.

### **Policy implications**

The recommendation supports Goal I of the Strategic Plan for California's Judicial Branch—Access, Fairness, Diversity, and Inclusion—by increasing representation and court services for low-income persons, regardless of immigration status, in diverse geographic areas of California.

#### **Comments**

Public comments were not solicited for this proposal because the recommendation is within the Judicial Council's purview to approve without circulation.

#### **Alternatives considered**

The program is funded by revenues that are to be used solely by the program; therefore, no alternative funding recommendations were considered.

### **Fiscal and Operational Impacts**

This recommendation is for the allocation of funds designated for the program. No additional costs or impacts are anticipated.
