Executive Summary

Under Government Code section 77202.5(a), the Judicial Council is required to report annually to the Senate Committees on Budget and Fiscal Review and Judiciary, and the Assembly Committees on Budget and Judiciary on allocations and reimbursements to the trial courts. On or before September 30, 2024, Judicial Council staff submitted *2023–24 Allocations and Reimbursements to the Trial Courts*.

Previous Relevant Reporting or Action

This report is submitted annually to the Legislature and is due by September 30 of each year. Reports from previous fiscal years are available on the “Legislative Reports” webpage of the California Courts website at www.courts.ca.gov/7466.htm.

Analysis/Rationale

The Judicial Council is required by Government Code section 77202.5(a) to provide the Legislature with an annual report detailing the allocations and reimbursements from state and federal funds. This report includes (1) fiscal year 2023–24 base allocations for court operations; (2) fee revenue amounts that are distributed directly back to the reporting courts as authorized in statute or by the Judicial Council; (3) reimbursements for specific trial court expenditures including but not limited to court-appointed dependency counsel, jury, self-help center, and court

interpreter costs; and (4) funding awarded to individual trial courts from statewide programs, including state and federal grants.

A total of \$3.1 billion was provided to the trial courts from the following funds (Attachment A):

- Trial Court Trust Fund (\$2.9 billion);
- State Trial Court Improvement and Modernization Fund (\$9.4 million);
- General Fund (\$227.1 million); and
- Federal Trust Fund (\$1.5 million).

The report also includes a statement of the intended purpose for which each allocation or reimbursement was made (Attachment B) and the policy governing trial court reserves, which is authorized under Government Code section 77203 (Link A).

Fiscal Impact and Policy Implications
