The report focuses on action since the council's meeting on May 12, 2023, and is exclusive of items on the July business meeting agenda.

Judicial Branch Budget

Budget discussions and information sharing with the State Department of Finance and legislative staff related to the fiscal year 2023–24 budget continued through the lead up to the passing and signing of the 2023 Budget Act. A memorandum detailing the \$5.2 billion budget for the judicial branch, which included a net increase of \$426.9 million, was disseminated and statewide conference calls were held with court leadership.

Chief Justice Liaison Meetings

The Chief Justice, Chair of the council's Legislation Committee, and Acting Administrative Director participated in liaison meetings with the California Defense Counsel, Consumer Attorneys of California, California Judges Association, California District Attorneys Association, and State Bar. The meetings addressed ongoing collaboration on access to justice issues of common interest and concern.

Legislative Advocacy

Judge Marla Anderson, Chair of the Legislation Committee, testified at a joint hearing of the Assembly Judiciary Committee and Assembly Natural Resources and Committee on the Governor's proposed clean infrastructure plan, addressing how expedited judicial review of California Environmental Quality Act cases affect courts. Judge Lisa Rodriguez, Vice Chair of the Criminal Law Advisory Committee, testified at the Senate Public Safety hearing on Assembly Bill 1214 related to remote criminal proceedings

Environmental Summit

The first Judicial Council Environmental Summit convened judges, court administrators, and subject matter experts to inform, educate, and raise awareness about the effects of environmental changes on courts and litigation, and help identify court needs in this area. Areas of focus included climate science for judicial officers and climate change impacts in California and on the courts; water law; climate change litigation; legal stakeholders; and economic, social, cultural, and environmental impacts.

Youth Court Summit

The 18th Annual California Youth Court Summit convened judicial officers, court staff, and youth and professionals associated with youth courts convened for education on serving justice-involved youth through restorative justice principles.

Data Summit

A data summit was held for court administrators, analysts, and judicial officers on improving the use of data analytics in courts. More than 200 participants represented 42 trial courts as well as several courts of appeal. This was the third such summit designed to foster a community of collaboration and practice around data analytics.

Judicial Branch Statistical Information System

The Superior Courts of Contra Costa, Siskiyou, and Sutter Counties were certified to report data using the Judicial Branch Statistical Information System (JBSIS). Thirty-seven courts are now

using the full system, with 15 additional courts in the process of being certified. JBSIS data is used for statewide statistical reporting and in judicial branch funding allocation methodologies.

Community Assistance, Recovery, and Empowerment (CARE) Court

A meeting of the first CARE Court implementation cohort in the new fiscal year brought together court and county partners from Glenn, Los Angeles, Orange, Riverside, San Diego, San Francisco, Stanislaus, and Tuolumne Counties as well as state partners from Health and Human Services, the Department of Health Care Services, and the Department of Finance. Trainings were also held for court implementation planning teams, judicial officers, court staff, and Self-Help Centers. Site visits relating to Self-Help Center readiness were conducted at seven courts.

Pretrial Release Program

Staff presented on the pretrial release program at the California Association of Pretrial Service Providers Conference.

Court Facilities

Forty-six real estate transactions were completed in nine counties involving permits, new expense and revenue lease/licenses, event licenses, and lease amendments and renewals for court facilities. As of July 2023, there are 1,387 facility modification projects in progress with an estimated cost of \$646 million.

Audit Services

Fieldwork was completed for audits of the Superior Courts of Los Angeles, Marin, Monterey, San Joaquin, San Luis Obispo, Tulare, and Yuba Counties. Audit entrance conferences were held, or fieldwork conducted with the Superior Courts of Fresno, Madera, Plumas, San Bernardino, and Sonoma Counties.

Annual Comprehensive Financial Report

The mandated Annual Comprehensive Financial Report on behalf of all trial courts for fiscal year ending June 30, 2022, was submitted to the State Controller's Office.

Labor and Employee Relations

Labor negotiations assistance was provided to 19 trial courts on 38 matters. Services included side letter negotiations, impact bargaining, and successor memoranda of understanding negotiations. Support was also provided on 54 different labor and employee-related matters, including advising on policies related to remote work and flex schedules.

Information Technology Modernization Projects

The council's Information Technology Modernization Fund Workstream reviewed 135 project proposals across the various categories of the <u>California Courts Connected</u> framework. The approved funding model prioritized case management systems, small court priority-one projects, and a pro rate distribution of remaining funding among courts with approved projects.

Transitions to Modern Case Management Systems

Ten superior courts—Amador, Colusa, Contra Costa, Lassen, Marin, Mariposa, Mono, Nevada, Shasta, and Solano—migrated to a new case management system to ensure a stable platform and increased access to justice. Additionally, the Superior Courts of Orange, Sacramento, and Ventura Counties transitioned from the old state-supported V3 case management system. The final decommissioning of V3 began in June.

Expansion of Online Tool for Adjudicating Infraction Violations

Statewide expansion of the MyCitations application for online ability-to-pay determinations, as required by Assembly Bill 143, continued with deployment to four additional superior courts—Glenn, Alameda, Colusa, and Tehama. Thirty-one courts are now using the application. Interbranch agreements for the next five courts scheduled for implementation activities are being processed.

Collaboration with Justice System Stakeholders

Examples of recent stakeholder collaborations included meetings with the:

- Department of State Hospitals and Groundswell: Launch of the Incompetency to Stand Trial (IST) Evaluator Training Program, and the project to improve the quality of reporting on IST proceedings.
- Center for Effective Public Policy and Council of State Governments: Discussion of programming focused on advancing racial equity for people with behavioral health needs in the justice system.
- Council of Criminal Justice and Behavioral Health: Discussion of projects and policy priorities affecting trial courts.

Meeting Details

Advisory Committee on Audits and Financial Accountability for the Judicial Branch

- Approved the fiscal year (FY) 2023–24 audit plan, which includes initiating five trial court audits during FY 2023–24 and eleven in FY 2024–25.

- Discussed 12 proposals, including drafting a new instruction on implicit bias.
- Reviewed recent case law regarding aiding and abetting second degree murder to inform instruction revisions.

Advisory Committee on Providing Access and Fairness

- Recommended Language Access Signage and Technology Grant Program (Cycle 5) awards for Judicial Council consideration.
- Language Access Subcommittee: Provided feedback concerning Assembly Bill 432 (California Court Interpreter Workforce Pilot Program) and Assembly Bill 1032 (Court Interpreters).

Appellate Advisory Committee

Recommended four proposals for council action following the spring comment period.
Proposals involved amending rules governing time for filing or electing an appendix,
revising forms for requesting an extension of time to file a brief, revising the civil notice of
appeal forms, and amending rules governing petitions for review to the Supreme Court to
permit attachment of the entire trial court order in certain cases.

Civil and Small Claims Advisory Committee

• Considered recommending proposals for council action following the spring comment period. Proposals included revisions to unlawful detainer forms to implement new law concerning partial evictions, a new rule of court to clarify service requirements after remote appearances at a restraining order hearings and related form revisions, and revisions to civil forms to implement new law concerning appointment of guardians ad litem.

Collaborative Justice Courts Advisory Committee

- Discussed interim funding and the reallocation process for the Substance Abuse Focus Grant.
- Provided input on proposed legislation that may impact collaborative courts statewide.

Staffing Category	Definition
Authorized Position (FTE)	All regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full-time equivalency.
Filled Authorized Position (FTE)	The number of authorized positions filled based on the employee's full-time equivalency.
Headcount	The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1." This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	The number of authorized positions divided by the number of vacant authorized positions, excluding temporary employees ("909" funded employees). See Judicial Council Temporary Employees, below.
Judicial Council Temporary Employees (909)	An employee whose salary is not funded through the Budget Act and who may receive benefits if employed at least half-time and the term of employment is for more than six months. A 909 position is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees because of the unavailability of an authorized vacant position. Types of "909" Temporary Employees include retired annuitants, who are hired by their former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis; they do not receive full benefits (but do receive CalPERS retirement service credit).
Employment Agency Temporary Workers (FTE)	Workers from/employees of an employment agency who provide short-term support.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	The number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full-time job all year would consume one FTE. One employee working for 1,040 hours each year would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits. Intermittent: Employee has no established work schedule and works on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees." They receive full benefits.
Limited Term	A position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employees in limited-term positions may be regular or temporary.

Judicial Vacancy Roster Report:
