Executive Summary

As outlined in the California Rules of Court, rule 10.11, the Executive and Planning Committee oversees the Judicial Council's meeting process and operating procedures, including agenda setting for council meetings, development of the council's long-range strategic plan for the judicial branch, and development of policies and procedures related to court facilities and communications with the branch. The committee is also charged with directing the nominations process for vacancies on the council and its advisory bodies and overseeing specific advisory bodies. This report summarizes the committee's activities since the last Judicial Council internal committee written report, which was submitted for the council's March 11 business meeting.

Overview of Committee Meetings

Since the Judicial Council's March 11 business meeting and May 11 action by email via circulating order, the committee held five meetings by videoconference and conducted four actions by email.

Agenda Setting and Other Business

During its April 13 videoconference and its April 25 and April 27 actions by email, the committee set the agenda for the council's May 11 action by email via circulating order. During its June 21 videoconference and June 30 and July 5 actions by email, the committee set the agenda for its July 15 business meeting. Lee, Superior Court of Alameda County During its June 21 videoconference, the committee approved a recommendation for an unpaid sabbatical leave for Judge Jo-Lynne Lee, Superior Court of Alameda County, from January 1 through May 31, 2023, to be submitted to the Judicial Council for its consideration during its July 15 business meeting.
