Equal Access Fund | Distribution of Funds for Equal Access Fund Program (Action Required)

Summary: The Legal Services Trust Fund Commission recommends that the Judicial Council approve a one-time General Fund distribution of \$100,000 to the Legal Services Trust Fund Commission of the State Bar of California for the Equal Access Fund program, as authorized by Assembly Bill 170 (Stats. 2024, ch. 51). The commission will distribute the funds to qualified legal services providers and support centers to improve equal access and the fair administration of justice.

Recommendation: The Legal Services Trust Fund Commission recommends that the Judicial Council, effective February 20, 2026, approve the distribution of \$100,000 to the Legal Services Trust Fund Commission of the State Bar of California for the Equal Access Fund program.

(Action Required)**

Summary: The Advisory Committee on Criminal Jury Instructions recommends approving for publication the new and revised criminal jury instructions prepared by the committee under rule 2.1050 of the California Rules of Court. These changes will keep the instructions current with statutory and case authority. Once approved, the revised instructions will be published in the 2026 edition of *Judicial Council of California Criminal Jury Instructions*.

Recommendation: The Advisory Committee on Criminal Jury Instructions recommends that the Judicial Council, effective February 20, 2026, approve the following changes to the criminal jury instructions prepared by the committee:

1. Revisions to the user guide;
2. Addition of CALCRIM Nos. 1808, 3235, 3238, and 3459;
3. Revocations of CALCRIM Nos. 250 and 251; and
4. Revisions to CALCRIM Nos. 252, 254, 355, 373, 375, 400, 416, 417, 540A, 540B, 540C, 561, 571, 703, 840, 841, 852A, 852B, 853A, 853B, 965, 967, 968, 1000, 1015, 1030, 1045, 1170, 1191A, 1191B, 1300, 1520, 1700, 1751, 2110, 2111, 2112, 2113, 2114, 2410, 2510, 2511, 2512, 2513, 2622, 2656, 2745, 2840, 2931, 3160, 3224, 3225, 3226, 3227, 3228, 3229, 3230, 3231, 3232, 3233, 3234, 3260, 3406, and 3411.

Funding and Expenditures (Action Required)**

Summary: Under Government Code section 69894.2, the Judicial Council is required to submit a report to the Legislature by March 1 of each year on how funds previously appropriated by the Legislature for superior court lactation rooms have been expended. To date, a total of 128 lactation room projects are planned for completion with the expenditure of all \$20.4 million in funds previously appropriated by the Legislature: \$15 million through the passage of the Budget Act of 2022 and \$5.4 million through the passage of the Budget Act of 2025. Judicial Council staff recommends the Judicial Council approve the report to the Legislature.

Recommendation: Judicial Council staff recommends that the Judicial Council, effective February 20, 2026, approve the *Superior Court Lactation Rooms Funding and Expenditures* and direct staff to submit it to the Legislature.

Changes (Action Required)**

Summary: Judicial Council staff recommend revising *Findings and Orders for Pretrial Release or Detention* (form CR-104) and *Retail Crime Restraining Order--Criminal* (form CR-164) to make technical revisions. The revisions are necessary to avoid causing confusion for courts.

Recommendation: Judicial Council staff recommend that the Judicial Council, effective March 1, 2026:

1. Revise *Findings and Orders for Pretrial Release or Detention* (form CR-104) to correct the form title in the footer; and
2. Revise *Retail Crime Restraining Order--Criminal* (form CR-164) to include checkboxes for the item on personal service of the order.

Rules and Forms | Technical Form Revisions to Reflect Federal Poverty Guidelines (Action Required)

Summary: Certain Judicial Council forms contain calculations based on the federal poverty guidelines, which are updated annually in January. Judicial Council staff recommend revising four Judicial Council forms to reflect the 2026 guidelines and ensure these forms remain accurate. Staff also recommend revising a fee waiver information sheet to correct a citation.

Recommendation: Judicial Council staff recommend that the Judicial Council, effective March 1, 2026:

1. Revise the following forms to reflect the 2026 federal poverty guidelines:
 - *Information Sheet on Waiver of Appellate Court Fees--Supreme Court, Court of Appeal, Appellate Division* (form APP-015/FW-015-INFO);
 - *Request to Waive Court Fees* (form FW-001);
 - *Request to Waive Court Fees (Ward or Conservatee)* (form FW-001-GC); and
 - *Financial Declaration--Juvenile Dependency* (form JV-132).
2. Revise *Information Sheet on Waiver of Superior Court Fees and Costs* (form FW-001-INFO) to correct a citation on page 1.

Judicial Branch Technology | Second IT Modernization Funding Allocation, Fiscal Year 2025-26 (Action Required)

Summary: For fiscal year 2025-26, the Judicial Council Technology Committee recommends allocating IT Modernization Local Court Project funding to an additional two courts for technology projects by utilizing funds returned from a court unable to proceed with its approved initiative. The committee also recommends an allocation of IT Modernization Branchwide funding to continue hosting and maintenance of a branchwide technology solution. All recommended allocations align with the judicial branch's strategic goals and reflect the IT Modernization program's continued commitment to advancing court operations through innovative technology.

Recommendation: The Judicial Council Technology Committee recommends that the Judicial Council, effective February 23, 2026:

1. Allocate IT Modernization Local Court Project funding to the Superior Court of Humboldt County in the amount of \$41,273 and to the Superior Court of Nevada County in the amount of \$30,471; and
2. Allocate IT Modernization Branchwide funding to the Superior Court of Los Angeles County in the amount of \$125,000 to continue hosting services for the branchwide Automated Notification Management System, which supports nine courts.

A motion to approve the recommendation was made by Judge Moorman and seconded by Justice Boulware Eurie. Assembly Member Kalra was absent for this vote. The motion was adopted.

Judicial Branch Education | Fiscal Years 2026-28 Education Plan (Action Required)

Summary: The Center for Judicial Education and Resources Advisory Committee recommends approval of a two-year education plan that will authorize the development and delivery of high-quality education programming and resources to enhance the ability of all individuals serving in the judicial branch to achieve high standards of professionalism, ethics, and performance for the benefit of the public they serve.

Recommendation: The Center for Judicial Education and Resources Advisory Committee recommends the Judicial Council approve the fiscal years 2026-28 Education Plan. Approval of this plan will authorize the committee, through the work of its standing curriculum committees, to develop and deliver education programs and resources that will enable its judicial branch constituencies to fulfill the education requirements and expectations outlined in rules 10.451-10.491 of the California Rules of Court.

A motion to approve the recommendation was made by Judge Awoniyi and seconded by Presiding Judge Wood. Senator Umberg abstained and Assembly Member Kalra was absent for this vote. The motion was adopted.

Report to the Legislature | Use of Remote Technology in Civil and Criminal Actions by the Trial Courts (No Action Required.)

Summary: Code of Civil Procedure section 367.8 requires the Judicial Council to submit a report to the Legislature on or before December 31 of each year until January 1, 2027, on the use of remote technology in trial court civil and criminal proceedings. This report provides county-specific data mandated by the bill, which includes (1) the number of proceedings conducted with the use of remote technology; (2) any superior court in which technology issues or problems occurred; (3) the superior courts in which remote technology was used; (4) the types of trial court conferences, hearings, or proceedings in which remote technology was used; (5) the cost of purchasing, leasing, or upgrading remote technology; (6) the type of technology and equipment purchased or leased; and (7) any other information necessary to evaluate the use of remote proceedings by

the courts. This report fulfills these legislative reporting requirements and includes data for a 12-month period from September 1, 2024, through August 31, 2025.

Summary: On December 24, 2025, the Judicial Council's Center for Families, Children & the Courts submitted to the Department of Finance *Equal Access Fund Evaluation Report: Reporting Period January 1, 2024-December 31, 2024*. The report highlights activities, outcomes, and expenditures of Interest on Lawyers' Trust Accounts formula grants, competitive partnership grants, and consumer debt grants and was provided to the Judicial Council by the Legal Services Trust Fund Commission of the State Bar of California, as required by the Budget Act of 2021 (Sen. Bill 129; Stats. 2021, ch. 69).

Summary: Under Government Code section 68086(f), the Judicial Council is required to submit a report on the statewide court reporter fees collected and expenditures for court reporter services in superior court civil proceedings to the Joint Legislative Budget Committee by February 1 of each year. Judicial Council staff submitted *Report of Court Reporter Fees Collected and Expenditures for Court Reporter Services in Superior Court Civil Proceedings for 2024-25*, in January 2026.

According to Race and Ethnicity of Defendant**

Summary: Penal Code section 1170.45 directs the Judicial Council to report annually on the statewide disposition of criminal cases according to defendants' race and ethnicity. The attached report fulfills that mandate. The data used in this report come from the Automated Criminal History System, a data repository maintained by the California Department of Justice. This report describes and analyzes patterns seen in criminal case dispositions of adult felony arrests by race/ethnicity and tests whether any available legal or demographic information can account for the observed patterns.

Summary: Under Government Code section 69958, the Judicial Council is required to report to the Legislature semiannually on the purchase and lease of any electronic recording equipment that will be used to record superior court proceedings. For the reporting period of January 1 through June 30, 2025, 10 superior courts reported a combined total of \$729,435 for the purchase or lease of electronic recording equipment or related items. On or before December 31, 2025, the Judicial Council staff submitted the *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts (January 1 through June 30, 2025)* to the Legislature.

Trust Fund Expenditures**

Summary: Under Government Code section 70352(c), the Judicial Council is required to submit a report on the actual expenditures from the Court Facilities Trust Fund to the Legislature after the end of each fiscal year. On or before December 31, 2025, Judicial Council staff submitted *Fiscal Year 2024-25 Court Facilities Trust Fund Expenditures*, which reported that \$198.3 million was expended in fiscal year 2024-25.

Summary: Under Government Code section 70403(d), the Judicial Council is required to submit a report accounting for all receipts and expenditures from local courthouse construction funds to the Legislature and the Department of Finance by January 1 of each year. On December 16, 2025, Judicial Council staff submitted *Receipts and Expenditures From Local Courthouse Construction Funds for Fiscal Year 2024-25*.

Summary: Under Penal Code section 1463.010(c), by December 31 of each year, the Judicial Council is required to submit a report to the Legislature and the Department of Finance on the information collected and reported as specified in Government Code section 68514(a). On December 24, 2025, Judicial Council staff submitted *Report on Statewide Collection of Court-Ordered Debt for Fiscal Year 2024-25*.

Summary: Government Code section 68515(a) requires the Judicial Council to annually report to the Legislature on the operations of each trial court and include various specified operational and budgetary metrics. *Trial Court Operational Metrics: 2026 Report* is included as Attachment A to this report.

[26-016](#)**Report to the Legislature | Trial Court Trust Fund Revenue, Expenditure, and Fund Balance Constraints for FY 2024-25**

Summary: As required by Government Code sections 68502.5(b) and 77202.5(b), this Judicial Council report to the Legislature presents trial court financial information for fiscal year (FY) 2024-25, including revenues; expenditures at the program, component, and object levels; and fund balance constraints. Judicial Council staff compiled the data from the FY 2024-25 fourth quarter Quarterly Financial Statements submitted by the trial courts.

Summary: Government Code section 68106 directs trial courts to notify the public and the Judicial Council before closing courtrooms or clerks' offices or reducing clerks' regular office hours and the council to post all such notices on its website and relay them to the Legislature. This report lists the latest court notices received by the council under this statutory requirement. Since the previous report, one superior court--the Superior Court of Santa Barbara County--has issued a new notice.
