
The Judicial Diversity Toolkit 2.0 Timeline

JUDICIAL DIVERSITY IN CONTEXT

Demographic	State Population	Law Students	Active Attorneys	Judges
African American	5.5%	5.4%	1.9%	7.9%
Hispanic/Latino	39.1%	20.2%	4.6%	10.8%
Asian/Pacific Islander	14.7%	14.6%	6.2%	8.3%
White	37.0%	53.2%	80.3%	67.7%

Judges
 Although the state bench does not yet reflect the population it serves, it has grown considerably more diverse in recent years. Of the 644 judges Governor Brown appointed from 2011-2019, nearly 40% identified as non-white, 44% were women, and 6% identified as LGBT.

Demographic	State Judges (2018)	State Population (2017)
Men	63.7%	49.7%
Women	36.3%	50.3%
LGBT	4.8%	5.3%
Disabled	7.4%	6.1%
Veterans	2.1%	10.6%
