OPEN MEETING

Call to Order and Roll Call

The chair called the meeting to order at 4:30 p.m., and committee staff took roll call. No written comments were received.

Approval of Minutes

The advisory body reviewed and approved the minutes of the November 17, 2016, Policy Coordination and Liaison Committee meeting.

DISCUSSION AND ACTION ITEMS

Item 1

INVITATIONS TO COMMENT

- a) **Appellate Procedure: Authorizes Fees for Electronic Filing Service**

Clarifies that an appellate court's electronic filing service provider may charge a reasonable fee for its services to allow an appellate court to contract with its electronic filing service provider to receive a portion of the fees collected by that provider, and to authorize the appellate courts to charge a fee to recover costs incurred for providing electronic filing. Persons entitled to fee waivers would not be subject to any of the fees.

Action: Approved for circulation.

b) Appellate Procedure: Content of the Record in Certain Juvenile Appeals

Provides that persons not otherwise entitled to access the juvenile case file under Welfare and Institutions Code section 827 who file a notice of appeal or petition challenging a juvenile court order or who are a respondent in such an appellate proceeding, may, for purposes of those appellate proceeding, access and copy those records to which they were previously given access by the juvenile court. Provides that an order from either the juvenile court or the Court of Appeal is required for such individuals to access any other item in the juvenile record.

Action: Approved for circulation.

c) Criminal Procedure: Electronic Arrest Warrants

Eliminates several telephonic confirmation requirements between the magistrate and officer for arrest warrants issued electronically.

Action: Approved for circulation.

d) Technology: Electronic Service

Codifies certain electronic service provisions.

Action: Approved for circulation.

e) Temporary Emergency Gun Violence Restraining Order

Replaces the requirement for compliance with procedures for the issuance of oral search warrants under Penal Code section 1526 when these orders are "obtained orally" with the requirement that the law enforcement officer memorialize and sign an affidavit under oath reciting the oral statements provided to the judicial officer

Action: Approved for circulation.

f) Traffic: Uniform Hourly Rate for Community Service in Lieu of Infraction Fine

Provides a uniform rate throughout the state for converting infraction fines into community service hours.

Action: Approved for circulation.
