### **Executive Summary**

The Judicial Council's Center for Judicial Education and Research (CJER) Advisory Committee has completed the delivery of its 2022–2024 Education Plan for the judicial branch. The development and delivery of education for the judicial branch as contained in the 2022–2024 Education Plan successfully ensured that all individuals serving in the judicial branch had the opportunity to receive the education they need to achieve high standards of professionalism, ethics, and performance for the benefit of the public they serve.

### **Relevant Previous Reporting or Action**

The Judicial Council approved the 2022–2024 Education Plan on January 21, 2022.

### Analysis/Rationale

Every two years, the CJER Advisory Committee, working with its nine subordinate curriculum committees, produces a two-year education plan for the council's approval. The plan authorizes the development and delivery of high-quality educational programs and products. This education enhances the ability of all individuals serving in the judicial branch to maintain high standards of professionalism, ethics, and performance for the benefit of the public they serve.

During the 2022–2024 Education Plan period, Judicial Council staff followed a reporting and tracking protocol to confirm that the products in the education plan were developed and delivered as scheduled. Any deviations from the delivery schedules or delivery methods in the

approved plan were noted, explained, and, where appropriate, brought to the attention of the relevant curriculum committees for consideration and the CJER Advisory Committee for action.

The development and delivery of education for the judicial branch as directed by the 2022–2024 Education Plan was highly successful. The resources produced met the educational needs of the judicial branch as identified by the subject-matter experts who were appointed to the curriculum committees by the Chief Justice. Furthermore, the council effectively responded to the branch's changed educational needs during the two years of implementing the 2022–2024 Education Plan by delivering to judicial officers and court staff more resources and serving more participants than initially planned.

Educational products that were included in the education plan effectively accomplished their learning objectives according to participants' verbal feedback and written course evaluations. More judicial officers and court personnel than anticipated were served by the council's educational offerings in 2022–2024; class sizes of live programs were expanded to meet higher-than-anticipated demand when learning objectives and space permitted.

The most significant expansion of education during the delivery of the 2022–2024 Education Plan was the provision of new-judge education for a higher number of judicial appointments than in previous plan periods. To meet the need of all newly appointed judges to receive education that will assist them in transitioning to their roles on the bench, the availability of new-judge educational offerings was greatly increased. For example, twice as many "New Judge Orientation" courses were delivered during the plan period than had been included in the 2022–2024 Education Plan. This resulted in 280 new judges being trained each year rather than the historic average of 100 new judges requiring training per year. Furthermore, for "Primary Assignment Orientation" courses, the number of offerings and class sizes was increased when possible. Finally, a second session of the B. E. Witkin Judicial College was added in 2022.

Environmental law education was expanded to fulfill the judicial branch's changing needs. For instance, double the number of courses were delivered on the California Environmental Quality Act during the 2022–2024 Education Plan period. Moreover, multiple educational offerings on water law and other environmental law topics were delivered, including in-person classes and distance education such as videos and podcasts.

Similarly, the number of educational offerings provided to court leadership, including court executive officers, and to court staff increased 15 percent during the 2022–2024 Education Plan period.

The educational products in the 2022–2024 Education Plan were delivered using modern technological tools, when learning objectives allowed, to ensure that judicial officers and court staff had maximum access to effective educational opportunities. An increased amount of education for experienced judicial officers and court staff, including managers and supervisors, was delivered using hybrid or remote models. These models allow for expanded class sizes compared with previous in-person offerings of the same education and enabled the council to

serve over 400 more participants in these courses than had been served in the prior education plan cycle.

The flexibility in implementing the two-year education plan allowed the Judicial Council to provide judicial officers and court staff statewide with education that responds to existing and ongoing needs identified by subject-matter experts, as well as to address new educational needs resulting from law changes, systemwide trends, and current events. The responsiveness of the council's judicial education means that judicial officers have access to information to help them decide cases accurately, fairly, and uniformly. Likewise, court staff are provided with the resources they need to serve the public courteously, efficiently, and fairly. In sum, all individuals who are a part of the judicial branch are provided with the education they need to achieve high standards of professionalism, ethics, and performance for the benefit of the public they serve.

### **Fiscal Impact and Policy Implications**

During fiscal year 2023–24, the Judicial Council authorized two separate one-time increases of \$150,000 each to the judicial education program allocation from the State Trial Court Improvement and Modernization Fund. This allowed the increased number of newly appointed judges to receive new-judge education that is required by court rules and effectively assists courts and their newer judicial officers in providing high-quality service to the public.
