Negotiations concerning legislation.

a) AB 900 (Levine), as amended June 24, 2015 – Juveniles: special immigrant juvenile status

Establishes a new and unprecedented form of guardianship for certain youth between ages 18 and 21 who may qualify for federal Special Immigrant Juvenile (SIJ) status. Among other things, this bill allows, with the consent of the proposed ward, a probate court to establish a guardianship of the person for an unmarried individual, who is at least 18 years of age, but not yet 21, in connection with a petition to make necessary findings regarding SIJ status, as specified. Authorizes the petition for guardianship to be filed by the proposed ward, a relative, or any other person on behalf of the proposed ward. Allows, with the consent, or at the request, of the ward, a court to extend a guardianship of the person beyond 18 years of age in order to allow the ward to complete the application process with United States Citizenship and Immigration Services (USCIS) for classification as a special immigrant juvenile, as specified. Prohibits the guardianship from extending beyond the ward reaching 21 years of age. Provides further that the bill does not authorize the guardian to abrogate any of the rights that a person who has attained 18 years of age may have as an adult under state law, including, but not limited to, decisions regarding the ward's medical treatment, education, or residence, without the ward's express consent. Requires the court, upon petition of a ward who is 18 years of age or older, to make an order terminating the guardianship. Requires the Judicial Council to adopt implementing rules and forms by July 1, 2016.

Executive Summary

As outlined in the California Rules of Court, rule 10.11, the Executive and Planning Committee (E&P) oversees the council's meeting process and operating procedures, including agenda setting for council meetings, development of the council's long-range strategic plan for the judicial branch, and development of policies and procedures related to court facilities and communications with the branch. The committee is also charged with directing the nominations process for vacancies on the council and its advisory bodies and overseeing specific advisory bodies. This report summarizes the committee's activities since the last Judicial Council internal committee presentation during the council's August business meeting.

Overview of Committee Meetings

Since the August council meeting, the committee has met once by conference call on October 8. The committee also conducted an e-mail action on October 16, which was completed on October 19. The committee will also meet in person before the council meeting on October 26 to hold an orientation session for its new members.

Agenda Setting and Other Business

During its October 8 meeting and October 16 e-mail action, the committee set the agenda for the council's October 27 business meeting. The committee also confirmed that Judge Brian L. McCabe will deliver a liaison report during the open business meeting on his visit to the Superior Court of Madera County.

The committee also conducted additional business as summarized below.

Amendment to the 2015 Annual Agenda of the Workload Assessment Advisory Committee
The committee approved amendments to the 2015 annual agenda of the Workload Assessment
Advisory Committee reflecting the need to revise the timeline in relation to the update of the
Resource Assessment Study.

Conversion of Two Subordinate Judicial Officer Positions in the Superior Court of San Diego County The committee confirmed the conversion of two vacant subordinate judicial officer positions in the Superior Court of San Diego County to judgeships effective October 8, 2015, and acknowledged that the court may temporarily fill these converted positions until judges are named and sworn to fill them.

Invitation to Comment: Revision of the Conflict of Interest Code for the Judicial Council

The committee approved a proposal to be circulated for comment that would adopt amendments to the Judicial Council Conflict of Interest Code aligning it with the Judicial Council's new classification and compensation structure. In accordance with Government Code sections 87303 and 87306, the code must be updated "when change is necessitated by changed circumstances, including the creation of new positions" and the council must review and approve proposed amendments to the code or direct that it be further revised and resubmitted for approval.

Trial Courts Security Grants Program

At the April 17, 2015, meeting, the Judicial Council approved eliminating, reducing, and deferring expenditures for specified projects funded from the State Trial Court Improvement and Modernization Fund (IMF) and directed staff to explore other funding sources to support programs funded from the IMF. During its June 15, 2015, meeting, E&P reviewed this report identifying other funding sources and directed the Legal Services office to review and comment on the report. During the committee's October 8 meeting, Finance staff reported that Legal Services concurred with the analysis and conclusion.
