Executive Summary

The Civil and Small Claims Advisory Committee and Court Executives Advisory Committee jointly recommend adding new case categories and case types to *Civil Case Cover Sheet* (form CM-010). Specifically, the committees recommend adding a "Comprehensive groundwater adjudication" case type to ensure consistency with both Code of Civil Procedure section 838(b) and the associated pending amendment to rule 3.400(c) of the California Rules of Court. Additionally, adding "Asbestos" and "Employment Development Department (EDD)" case categories will help fulfill forthcoming data reporting requirements in the Judicial Branch Statistical Information System and reduce manual data reporting by courts.

Recommendation

The Civil and Small Claims Advisory Committee and Court Executives Advisory Committee jointly recommend that the Judicial Council, effective January 1, 2026, revise form CM-010 to

add "Comprehensive groundwater adjudication" as a case type and add "Asbestos" and "Employment Development Department (EDD)" as case categories.

Relevant Previous Council Action

The initial version of *Civil Case Cover Sheet* (form 982.2) was adopted by the council in 1996. Subsequent versions of the form were published at various times, but the last time the council adopted a new case type on *Civil Case Cover Sheet* was in 2003, when "Uninsured motorist" was added under the "Auto Tort" case category.¹

Effective January 1, 1998, the council adopted rule 996 of the California Rules of Court (renumbered as rule 10.400), which established the Judicial Branch Statistical Information System (JBSIS) and requires automatic reporting by each trial court pursuant to the JBSIS manual.² The council first approved the JBSIS manual effective July 1, 1998³ and has updated it several times since.⁴ In July 2022, the Judicial Council approved new data reporting standards referred to as JBSIS 4.0,⁵ which includes adding "Asbestos" and "Employment Development Department (EDD)" as new case types to the Civil Limited and Civil Unlimited reports.

Analysis/Rationale

The Civil and Small Claims Advisory Committee (CSCAC) and Court Executives Advisory Committee (CEAC) recommend the addition of two new case categories and three new case types to *Civil Case Cover Sheet* (form CM-010). These changes will make the form consistent with section 838 and help ensure that the data necessary to meet the data reporting standards in JBSIS 4.0 is collected from litigants. Additionally, some minor technical changes were made as indicated in highlights on the attached proposed form.

Comprehensive groundwater adjudication

One case category on *Civil Case Cover Sheet* is "Provisionally Complex Civil Litigation (Cal. Rules of Court, rules 3.400–3.403)." The case types listed in this category reflect those that receive a provisional designation of "complex" under rule 3.400(c). Code of Civil Procedure section 838 provides that comprehensive groundwater adjudications are presumed to be complex under rule 3.400. To conform the rules to section 838, CSCAC recommends (in a separate

report) amending rule 3.400(c) to add "Comprehensive groundwater adjudication" to the list of case types that are provisionally designated as complex.⁶ Consistent with that recommendation, the committees recommend revising *Civil Case Cover Sheet* to include such case types under the form's provisionally complex case category.

Asbestos and Employment Development Department

The committees recommend adding "Asbestos" and "Employment Development Department (EDD)" as distinct case categories on *Civil Case Cover Sheet*. Currently, *Civil Case Cover Sheet* includes "Asbestos" as a case type under the "Other PI/PD/WD (Personal Injury/Property Damage/ Wrongful Death) Tort" case category, and EDD cases fall under the "Other employment" case type within the "Employment" case category. However, JBSIS does not capture data on the number of asbestos or EDD cases because it collects data from the case categories on form CM-010, not the case types. Given this limitation, Judicial Council staff manually collect this data annually from courts for use in the Resource Assessment Study and the Judicial Needs Assessment. The addition of "Asbestos" and "Employment Development Department (EDD)" as distinct case categories will enable JBSIS 4.0 to collect these data points and eliminate the need for additional manual data reporting by court staff.

Adding case categories also requires adding case type checkboxes for each new case category to maintain consistent formatting within *Civil Case Cover Sheet*. The recommended case type for the "Employment Development Department (EDD)" case category is "EDD decision review," and the asbestos case type would be "Asbestos." Although the "Asbestos" case category and case type share the same title, the same is already true for the "Enforcement of Judgment" category and case type.

Policy implications

The committees recommend revising *Civil Case Cover Sheet* to ensure the JBSIS 4.0 data reporting standards are met. This will reduce operational demands by eliminating the need for manual data reporting of asbestos and EDD cases by court staff. The revisions will also ensure the form is consistent with Code of Civil Procedure section 838(b), which represents a policy decision made by the Legislature.

Comments

The committees solicited public comments on this proposal from April 14 to May 23, 2025, as part of the council's regular spring invitation-to-comment cycle. Of the four comments received, two were from courts, one was from the Trial Court Presiding Judges Advisory Committee and the Court Executives Advisory Committee Joint Rules Subcommittee (Joint Rules Subcommittee), and one was from an individual. The commenters agreed with the proposal or did not indicate a position. The substantive comments and the committees' responses are summarized below.

To accommodate the new case categories and types and to improve readability of the form, the committees recommend adding a third page to the form containing the informational section with case type examples that is currently on page two of the form. The Joint Rules Subcommittee suggested that the form remain two pages because litigants may forget to print the third page, which could cause confusion and delay if court staff receive only the first two pages of a three-page form. Because the third page is for information purposes only, the committees considered recommending that the case types and examples be moved to an online location to keep the form to two pages. However, because some self-represented litigants may lack internet access, the committees chose to recommend adding language at the bottom of the second page that reads, "SEE PAGE 3 FOR INFORMATION PURPOSES ONLY."

An individual commenter suggested changing the form's reference to the collections case limit from \$25,000 to \$35,000 because CSCAC is proposing an increase to this limit.⁷ The committees agree with this comment and recommend that the form, which is anticipated to go into effect on the same date as the increased collections case limit (January 1, 2026), reflect this increased limit.

Alternatives considered

As stated above, the committees considered the alternative of moving the information on the third page of the proposed form to an online webpage but concluded that it was best to retain the information as part of the form and to recommend language on the bottom of page 2 stating that page 3 is for information purposes only.

Because the additions to *Civil Case Cover Sheet* are for the form to serve its purpose of accurately reporting case types and to streamline data reporting under approved JBSIS standards, the committees did not consider the alternative of no form revision.

Fiscal and Operational Impacts

The committees anticipate that this proposal could require training for court staff and judicial officers. The addition of the "Asbestos" and "Employment Development Department (EDD)" case categories will eliminate the need for manual data reporting by court staff, reducing operational demands.

Additionally, revision of *Civil Case Cover Sheet* will require coordination between the Judicial Council, the courts, and case management system (CMS) vendors to ensure that data for the new case categories are correctly reflected in the CMS and configured in Judicial Council data reporting. Any changes required in the CMS for asbestos and EDD data reporting will be

integrated into the implementation of JBSIS 4.0.8 Courts will likely incur costs to incorporate the revised forms into paper or electronic processes.

INSTRUCTIONS ON HOW TO COMPLETE THE COVER SHEET

To Plaintiffs and Others Filing First Papers. If you are filing a first paper (for example, a complaint) in a civil case, you must complete and file, along with your first paper, the Civil Case Cover Sheet contained on pages 1 and 2. This information will be used to compile statistics about the types and numbers of cases filed. You must complete items 1 through 6 on the sheet. In item 1, you must check one box for the case type that best describes the case. If the case fits both a general and a more specific type of case listed in item 1, check the more specific one. If the case has multiple causes of action, check the box that best indicates the primary cause of action. To assist you in completing the sheet, examples of the cases that belong under each case type in item 1 are provided below. A cover sheet must be filed only with your initial paper. Failure to file a cover sheet with the first paper filed in a civil case may subject a party, its counsel, or both to sanctions under rules 2.30 and 3.220 of the California Rules of Court.

To Parties in Rule 3.740 Collections Cases. A "collections case" under rule 3.740 of the California Rules of Court is defined as an action for recovery of money owed in a sum stated to be certain that is not more than \$35,000, exclusive of interest and attorney's fees, arising from a transaction in which property, services, or money was acquired on credit. A collections case does not include an action seeking the following: (1) tort damages, (2) punitive damages, (3) recovery of real property, (4) recovery of personal property, or (5) a prejudgment writ of attachment. The identification of a case as a rule 3.740 collections case on this form means that it will be exempt from the general time-for-service requirements and case management rules, unless a defendant files a responsive pleading. A rule 3.740 collections case will be subject to the requirements for service and obtaining a judgment in rule 3.740.

To Parties in Complex Cases. In complex cases only, parties must also use the Civil Case Cover Sheet to designate whether the case is complex. If a plaintiff believes the case is complex under rule 3.400 of the California Rules of Court, this must be indicated by completing the appropriate boxes in items 1 and 2. If a plaintiff designates a case as complex, the cover sheet must be served with the complaint on all parties to the action. A defendant may file and serve no later than the time of its first appearance a joinder in the plaintiff's designation, a counter-designation that the case is not complex, or, if the plaintiff has made no designation, a designation that the case is complex.
