## **Executive Summary**

The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's meeting on March 24, 2023, and is exclusive of items on the May business meeting agenda.

#### **Judicial Branch Budget**

- Judicial Council senior staff and court leadership participated in budget subcommittee hearings for both the Assembly and the Senate, presenting on judicial branch proposals included in the Governor's budget for fiscal year 2023–24 and providing testimony at an informational hearing on eviction filings and access to legal services.
- The spring budget change proposal for increased Appellate Court Trust Fund expenditure authority was submitted to the Legislature.
- The State Public Works Board bond sale to refinance debt on three courthouse projects in Kings, Santa Clara, and Sutter Counties closed in April and resulted in net savings of \$52.6 million.

#### **State of the Judiciary Address**

Chief Justice Guerrero delivered her inaugural State of the Judiciary Address during a joint session of the Legislature. Members of the judicial branch and justice partners, including leaders from the bar, legal aid, law enforcement, and the executive branch attended. The Chief's remarks can be accessed here. On the same day, Bench-Bar Coalition members met with more than 40 legislative offices to advocate on key issues facing the courts, including remote access and the need to address the statewide shortage of court reporters.

## **Technology Summit**

Almost 250 court leaders and technology professionals convened for a branchwide summit to share information and learn about solutions for using technology to improve access to justice. Areas of focus included information security and data analytics as well as other local and branchwide technology solutions.

## **Expansion of Online Tool for Adjudicating Infraction Violations**

Statewide expansion of the MyCitations application for online ability-to-pay determinations, as required by Assembly Bill 143, continued with deployment to six additional superior courts—Butte, Lassen, Mendocino, San Mateo, Siskiyou, and Yolo. Twenty-seven courts are now using the application.

#### **Labor and Employee Relations**

Labor negotiations assistance was provided to 15 trial courts on 28 matters. Services included side letter negotiations, impact bargaining, and successor memorandums of understanding negotiations. Support was also provided on 37 different labor and employee-related matters. Additionally, six trainings were hosted on topics such as recruiting and hiring lawfully.

#### **Court Facilities**

Twenty-seven real estate transactions were completed in 11 counties, involving permits, event licenses, and disposition of court facilities. As of April 2023, there are 1,307 facility modification projects in progress with an estimated cost of \$6.8 million.

#### **Pretrial Release Program**

- Site visits were conducted at superior courts in the northern region (Glenn, Lake, Lassen, Nevada, Plumas, Shasta, Siskiyou, and Tehama Counties) to observe pretrial practices.
- Fiscal year 2023–24 funding recommendations were presented to the Trial Court Budget Advisory Committee.

#### **Judicial Resources and Technical Assistance**

File reviews of juvenile cases were conducted in the Superior Courts of Kern, Siskiyou, and Sutter Counties to identify any legal issues and training needs.

#### **Collaboration with Justice Stakeholders**

Examples of recent stakeholder collaborations with the Judicial Council included meetings with the:

- Council on Criminal Justice and Behavioral Health Work Group: Discussion of projects of interest to adult criminal courts, including mental health diversion, policy priorities for trial courts, and the review of competency to stand trial data.
- California Victim Services Coordination Council: Review of a draft report on state-level resources for victims of crime.
- Public Policy Institute of California Criminal Justice Advisory Committee: Presentation on findings from the Institute's study on the impact of pandemic policies on criminal justice court outcomes.
- Access to Justice Commission: Discussion on proposals for fiscal year 2023–2024 State Legal Aid Infrastructure and Innovation grants.

- Approved recommendations for current year Trial Court Trust Fund allocation adjustments for three programs: information technology data center and cloud services, electronic courts of appeal record and transcripts, and elder abuse program reimbursements to trial courts.
- Approved a second cycle award recommendation for the Firearms Relinquishment program for the Superior Court of Orange County.

- Reviewed and supported fiscal year 2024–25 budget change proposal concepts of other advisory bodies for consideration by the Judicial Branch Budget Committee, and subsequently the council.
- Considered fiscal year 2023–24 allocations for the CARE Act, Court-Appointed Dependency Counsel, AB 1058 Child Support Program, pretrial, court reporters, and special fund allocations from the State Trial Court Improvement and Modernization Fund and Trial Court Trust Fund.
- *Fiscal Planning Subcommittee:* Approved recommendations for \$7.5 million in new and amended "Funds Held on Behalf Of" requests from trial courts for subsequent consideration by the council.

## **Trial Court Facility Modification Advisory Committee**

- Authorized expenditures of \$8 million for facility modifications.
- Approved ongoing operations and maintenance costs for electric vehicle charging stations at the San Bernardino Justice Center as a pilot project to inform future decisions on similar projects.

**Definitions:** 

Authorized Position (FTE)

Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

Filled Authorized Position (FTE) Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

Headcount The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or Employment

Agency Temporary Workers.

Vacancy (FTE)

The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

**Judicial Council Temporary** 

The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

Employees (909)

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months.

Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement system).

Contractor (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment

issues require the use of a contractor.

one employee working for 1,040 hours each would consume .5 FTE.

Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE.

One employee working for 1,040 hours each would consume .5 FTE.

**Time Base** Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

**Regular Employee** Commonly referred to as "permanent employees" – They receive full benefits.

Limited Term Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.
