The report focuses on action since the council's meeting on April 25, 2025, and is exclusive of items on the July business meeting agenda.

Judicial Branch Budget

Following enactment of the Budget Act of 2025, a memorandum detailing the \$5.3 billion budget for the judicial branch for fiscal year (FY) 2025–26 was distributed branchwide, together with the Chief Justice's statement on the budget, and conference calls were held with trial and appellate court leadership to share additional information and address questions.

Legislative Advocacy

Judicial Council staff testified at the Assembly Budget Subcommittee on Public Safety's informational hearing on the California Community Corrections Performance Incentive Act of 2009 (Sen. Bill 678). A meeting was held with the Legislative Analyst's Office to discuss the courts' implementation of Proposition 36, which allows felony charges and increased sentences for certain drug and theft crimes. Following the passage of new bills from the houses of origin in June, the council's Office of Governmental Affairs is reviewing and tracking 777 bills moving through the legislative process.

Community Assistance, Recovery, and Empowerment Act

A moderated judicial panel on Practices in Community Assistance, Recovery, and Empowerment (CARE) Act Proceedings focused on strategies for working with individuals with psychotic disorders, the role of the judicial officer, and overlap with other case types. Additionally, quarterly "office hours" were held for courts to address issues relating to CARE Act implementation. As of June 1, 2025, a reported 2,008 CARE Act petitions have been filed.

Immigration Resources

The Judicial Council continued to monitor immigration enforcement relating to courts in order to provide any necessary updates to court leadership and maintain information available to the public through the California Courts website's <u>Immigration Resource Guide</u>.

Youth Court Summit and Restorative Justice

Chief Justice Guerrero addressed participants at the 20th annual Youth Court Summit focused on ways to better serve justice-involved youth through restorative justice principles. The summit was held at the University of California at Riverside and attended by approximately 250 youth and adults associated with youth courts, including judicial officers, court staff, and juvenile justice stakeholders.

Juvenile Case Reviews

As part of the ongoing statewide review schedule, Judicial Council staff with the Judicial Resources and Technical Assistance Program conducted reviews of juvenile case files for the Superior Courts of Humboldt, Los Angeles, Placer, and Sierra Counties to identify any legal issues and training needs.

Court Facilities

• The Menifee Justice Center of the Superior Court of Riverside County was selected as a 2025 Project Achievement Award winner by the Construction Management Association of America's Southern California Chapter. The project was recognized in the Government (Federal/State/Local)

- Category for professionalism, innovation, and excellence in the management of the construction process. The new courthouse, which opened in July 2024, addressed overcrowding, security, accessibility, and energy efficiency challenges of the court's previous facility.
- As of July 2025, there are 748 court facility modifications in progress at an estimated cost of \$328 million. Repairs are underway for water damage at the Shasta County Courthouse, with four courtrooms requiring significant renovations. Forty-nine real estate transactions were completed in 18 counties, including acquisitions, dispositions, permits, event licenses, and new or renewed leases.

Human Resources Payroll System Upgrade

An upgrade of the payroll processing system was completed for the 20 user courts, including employee and manager self-service applications. Updated training materials, release notes, and real-time user assistance labs were provided to support users with this change.

New Workers' Compensation Clinical Consultation

The Judicial Branch Workers' Compensation Program began a one-year pilot program to introduce a new clinical consultation service for court members, offering employee access to medical providers for minor workplace injuries.

Labor and Employee Relations

Labor negotiations assistance was provided to 27 trial courts, including successor memoranda of understanding negotiations, side-letter negotiations, and impact bargaining. Additional support was provided on 40 labor and employee-related matters.

Judicial Branch Technology Security

The annual information technology disaster recovery exercise was conducted—testing infrastructure, network services, and branchwide court applications. Additionally, cybersecurity webinars were held for judicial branch employees on protecting the court system from cyberattacks.

California Courts Self-Help Guide

Integration of the Courts of Appeal and California Courts Self-Help websites was completed, including Spanish translation of content and a virtual customer service center intelligent chatbot that provides the public with easier access to plain-language resources and 24/7 automated assistance.

Virtual Customer Service Center Intelligent Chatbot

The virtual customer service center intelligent chatbot was launched for name change, small claims, and traffic case types in the Superior Courts of Napa, San Benito, and Sonoma Counties. The technology provides essential support when in-person assistance is limited. Nine courts are now participating in this pilot program that was launched in 2021. In the last year, 130,000 chatbot sessions were held and 261,000 questions were asked and answered.

MyCitations Online Trial by Declaration

The Online Trial by Declaration module of the <u>MyCitations ability-to-pay determinations tool</u> was deployed in the Superior Courts of Imperial and Siskiyou Counties. A total of four courts are now using this module, including the Superior Courts of San Francisco and Nevada Counties.

Judicial Branch Education

More than 50 education programs and resource tools were created, updated, or delivered for judicial officers, court personnel, and justice system partners during this reporting period.

- Training programs included the B. E. Witkin Judicial College and the Cow County (Rural Courts) Judges Institute.
- Distance education programs included videos and podcasts on mental health diversion, trauma, and juvenile dependency.
- Publication updates included benchbooks and benchguides addressing civil proceedings and preliminary hearings.

Collaboration with Stakeholders

- *Firearms legislation:* Judicial Council staff participated in a meeting of law enforcement, elected leaders, and gun violence prevention advocates to discuss the importance of domestic violence restraining orders and firearm access with a focus on creating an easier process for survivors of domestic violence to seek help and receive protection from abusers.
- Federal grant funding: Byrne State Crisis Intervention Program: The Judicial Council announced the second-round awardees for the Byrne State Crisis Intervention Program grant. This grant provides funds to assist courts with implementing or enhancing state crisis intervention court proceedings relating to mental health courts, drug courts, treatment mandated felony courts, veteran treatment courts, and programs with a focus on improving firearms relinquishment procedures for people at a high risk for gun violence.

Judicial Fellows Program Inspiring Public Service

In June, 10 judicial fellows completed their 10-month assignments working in Judicial Council offices and courts across California on initiatives related to court services, public policy, legislative analysis, language access, and community outreach. Each fellow is mentored by court executive officers and senior court and council staff, offering work experience and training to inspire career pathways in California's judicial branch. Established in 1997, the full-time, paid judicial fellowship is co-sponsored by the Judicial Council and Sacramento State University's Center for California Studies.

Meeting Details

Advisory Committee on Audits and Financial Accountability for the Judicial Branch

- Approved the public <u>invitation to comment</u> for proposed revisions to the *Judicial Branch Contracting Manual* to add provisions regarding generative artificial intelligence (GenAI), so that the manual will remain substantially similar to the *State Contracting Manual* and *State Administrative Manual*, as required by the Judicial Branch Contract Law.
- Approved Audit Services' FY 2025–26 audit plan, which includes initiating nine trial court audits.
- Approved audit reports for the Superior Courts of <u>Butte</u> and <u>Humboldt</u> Counties.

Advisory Committee on Providing Access and Fairness

- Discussed annual agendas for the committee and the Racial Justice Ad Hoc Working Group.
- Language Access Subcommittee: Reviewed resources for court staff on the use of machine translation tools.

Appellate Advisory Committee

- Considered rule changes for the spring cycle regarding remote appearances at oral argument.
- Considered adoption of a new form on extension-of-time applications in misdemeanor and infraction appeals.

Artificial Intelligence Task Force

- Reviewed and approved to send forward for Judicial Council consideration the rule of court and standard of judicial administration on the use of GenAI in courts, including changes to address public comments received.
- Began exploring how to address issues related to GenAI and evidence.

• Discussed the application of policy, practices, and standards for faculty, and the pretrial education recommendation from the Criminal Law Advisory Committee.

• Approved for Judicial Council review a draft of the *Judicial Branch Five-Year Infrastructure Plan* and capital outlay budget change proposals for FY 2026–27, including cost reduction relating to the future project for the Superior Court of San Joaquin County.

Criminal Law Advisory Committee

- Discussed public comments received on rule and form proposals, including pretrial release or detention and criminal protective orders.
- Discussed the proposal from the Advisory Committee on Providing Access and Fairness to implement AB 1899 (Gender-inclusive juror questionnaires and juror identification).

- Discussed pending legislation, including AB 366 (Ignition interlock devices), AB 704 (Criminal records: destruction), AB 938 (Human trafficking and intimate partner violence vacatur relief), AB 994 (Inmate detention relocation), AB 1483 (Supervision: violations), SB 396 (Corrections: supervision), and SB 537 (Parole: revocation).

Family and Juvenile Law Advisory Committee

- Approved funding allocations for AB 1058 (Child Support Commissioner and Family Law Facilitator program) and Court Appointed Special Advocates.
- Reviewed rules and forms proposals on family, juvenile, and domestic violence law.

Information Technology Advisory Committee

- Reviewed and approved 147 local court projects recommended for the Information Technology Modernization Program for FY 2025–26, some of which include an artificial intelligence component.
- Approved proposed awards for the Language Access Signage and Technology Grant Program for FY 2025–26.

Probate and Mental Health Advisory Committee

• Reviewed rules and forms proposals and revisions to the *Handbook for Conservators*.

Remote Access to Electronic Court Records Working Group

 Approved the public invitation to comment for a proposal for Judicial Council—sponsored legislation on remote access to electronic court records.

Shriver Civil Counsel Act Implementation Committee

 Reviewed the forthcoming report to the Legislature on Shriver Civil Counsel Act funding, services, and outcomes.

Traffic Advisory Committee

- Discussed an issue regarding litigants who want to attend traffic violator school and use the MyCitations portal, and potential legislative or rules of court changes.
- Discussed pending legislation impacting traffic courts, including AB 289 (State highway work zone speed safety) and SB 720 (Automated traffic enforcement systems programs).

Trial Court Budget Advisory Committee

• Approved FY 2025–26 funding allocations for AB 1058 (Child Support Commissioner and Family Law Facilitator program), court-appointed juvenile dependency counsel, and court reporters.

- Approved FY 2025–26 allocations from the Trial Court Trust Fund and General Fund, totaling \$3.1 billion to support trial court operations.
- Approved updates to the Funding Methodology Subcommittee's annual work plan for FY 2025–26.

- Approved the FY 2024–25 Facility Modification Program budget action and preapproval for planned facility modification projects over \$100,000K for FY 2025–26.

- Met jointly with the Executive Committee of the Court Executives Advisory Committee to receive
 updates on the state budget, the Resource Allocation Study, and an overview of the Judicial

| Authorized Position (FTE) | All regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full-time equivalency. |
| Filled Authorized Position (FTE) | The number of authorized positions filled based on the employee's full-time equivalency. |
| Headcount | The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1." This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers. |
| Vacancy (FTE) | The number of authorized positions minus the number of filled authorized positions. |
| Vacancy Rate (FTE) | The number of authorized positions divided by the number of vacant authorized positions, excluding temporary employees ("909"-funded employees). See Judicial Council Temporary Employees, below. |
| Judicial Council Temporary Employees (909) | An employee whose salary is not funded through the Budget Act and who may receive benefits if employed at least half-time and the term of employment is for more than six months. A 909 position is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees because of the unavailability of an authorized vacant position. Types of 909 Temporary Employees include retired annuitants, who are hired by their former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis; they do not receive full benefits (but do receive CalPERS retirement service credit). |

| Time Base | Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees who work more than 20 hours per week receive full benefits. Intermittent: Employee has no established work schedule and works on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees. |
