## **Executive Summary**

The Trial Court Budget Advisory Committee recommends a \$150,000 increase to the fiscal year 2023–24 approved Judicial Education program allocation from the State Trial Court Improvement and Modernization Fund due to the significantly high number of judicial appointments in recent months. The increased budget, from \$984,000 to \$1.1 million, will provide the resources necessary for the Judicial Council's Center for Judicial Education and Research to offer six additional New Judge Orientation training programs this fiscal year and to increase the capacity of each of the Primary Assignment Orientations. This will ensure that newly appointed judicial officers receive the education they need and are able to meet the new judge education requirements of California Rules of Court, rule 10.462.

#### Recommendation

The Trial Court Budget Advisory Committee recommends that the Judicial Council, effective November 17, 2023, approve an increase of \$150,000 to the fiscal year 2023–24 Judicial Education program allocation from the State Trial Court Improvement and Modernization Fund.

#### **Relevant Previous Council Action**

At its meeting on July 21, 2023, the Judicial Council approved State Trial Court Improvement and Modernization Fund (IMF) allocations of \$45.2 million. Of the total amount approved, \$984,000 was allocated to the Center for Judicial Education and Research (CJER) for judicial education (see Attachment A).

This recommendation for a \$150,000 increase in the allocation was presented to the Judicial Branch Budget Committee on September 18, 2023, and approved for consideration by the Judicial Council.

## Analysis/Rationale

The Judicial Council of California's Center for Judicial Education and Research (CJER) provides education courses, products, and resources for the state's approximately 2,500 justices, judges, and subordinate judicial officers and nearly 20,000 court staff as required by California Rules of Court, rules 10.451–10.491. California's judicial officers and court personnel participate in mandatory and elective in-person and distance education to perform their responsibilities competently, impartially, and efficiently. Judicial branch education supports standardizing court practices and procedures to ensure that all Californians have equal access to participate in court proceedings and are treated fairly.

The CJER Advisory Committee consists of judicial officers and court executives who direct nine curriculum committees to identify educational needs and develop content priorities. The committee designs and delivers its offerings on a two-year planning cycle to meet the judicial branch's shifting educational needs. The two-year education plan is developed based on historical needs and current information available at the time of development. The current two-year education plan was developed in 2021. At that time, it was not anticipated that judicial appointments would increase by such a significant number.

For the past several years, CJER has offered 10 New Judge Orientation (NJO) programs each year to provide new judicial officers with the skills they need, and to meet the rule requirement of job training for new judges within six months of appointment. Historically, 10 NJO sessions have met the demand. However, due to the significant increase in the number of judges appointed by Governor Newsom, 10 NJO sessions will not be sufficient to serve all of the newly appointed judicial officers this fiscal year. Based on current estimates, CJER will need to offer at least 6 additional NJO programs this fiscal year and will also need to increase the number of participants at each Primary Assignment Orientation offered to accommodate all the new judges who will need to take courses to orient them to their new assignments.

#### **Comments**

#### **Alternatives considered**

CJER staff considered submitting a request for additional funding from the General Fund through the Judicial Council to obtain the necessary funding. However, it was determined that requesting additional IMF funding would be more appropriate to address the need for additional new judge education programs.

## **Fiscal and Operational Impacts**

The fiscal impact to the IMF would be a one-time \$150,000 increase to CJER's Judicial Education allocation in order to provide all new judge appointees access to new judge education programs that are both necessary and required. Based on current revenue estimates, the fund is estimated to have a sufficient balance for the requested allocation increase (see Attachment B).
