Executive Summary

Judicial Council staff have noted a minor error in *Memorandum of Garnishee* (form AT-167/EJ-152), in which a party is misidentified in item 2. Judicial Council staff recommends making a correction to that form to avoid causing confusion for court users, clerks, and judicial officers.

Recommendation

Judicial Council staff recommend that the Judicial Council, effective September 1, 2022, revise *Memorandum of Garnishee* (form AT-167/EJ-152), item 2, to replace the incorrect reference to "Judgment Creditor" with "Judgment Debtor

The text of the proposed form is attached at pages 3–4.

Relevant Previous Council Action

Although the Judicial Council has acted on this form, this proposal recommends only a minor correction unrelated to any prior action.

Analysis/Rationale

The change to this form is technical in nature and necessary to correct inadvertent use of an incorrect party title in item 2.

Policy implications

There are no policy implications to this proposal.

Comments

This proposal was suggested by several members of the public to fix the error in the form. It was not circulated for public comment because the change is noncontroversial, involves a technical revision, and is therefore within the Judicial Council's purview to adopt without circulation. (See Cal. Rules of Court, rule 10.22(d)(2).)

Alternatives considered

None.

Fiscal and Operational Impacts

Operational impacts are expected to be minor. The proposed revisions may result in reproduction costs if courts provide hard copies of the form recommended for revision. Because the proposed change is a technical correction, case management systems are unlikely to need updating to implement them.
