The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's July 15, 2022, meeting, and is exclusive of items on the September business meeting agenda.

Redesigned Online Self-Help Portal

The Pew Charitable Trusts cited the Judicial Council's redesigned <u>online self-help portal</u> as a model for other state courts. The report pointed to the value of seeking direct feedback from litigants and court staff for the redesign. Pew's analysis highlighted that, "From September 2021 through July 2022, the site served more than 1.1 million users total, and the number of monthly users has more than quadrupled. When comparing the new portal with the separate self-help pages on the court's website, more users return to the portal and are less likely to leave the website without viewing additional pages."

Judicial Administration Fellowship Program

The 2022–23 class of 10 judicial administration fellows began their year of service with the judicial branch. This years' fellows will serve at the Superior Courts of Butte, Los Angeles, Nevada, Orange, Placer, Sacramento, San Bernardino, San Francisco, and San Mateo Counties, and at the Judicial Council. The program, now in its 26th year, is led by the Center for California Studies at Sacramento State University with the Judicial Council serving as the judicial branch sponsor.

Judicial Branch Budget

Ten budget change proposals, seven capital outlay budget change proposals, and 12 capital outlay concept papers, approved by the council, were submitted to the Department of Finance for consideration in the 2023–24 Governor's Budget.

Judicial Resources and Technical Assistance

File reviews of juvenile cases were conducted in the courts at El Dorado, Mendocino, Merced, and San Luis Obispo Counties to identify any legal issues and training needs.

Labor and Employee Relations

Labor negotiations assistance was provided to 23 trial courts on 48 matters. Services included side letter negotiations, impact bargaining, and successor memoranda of understanding negotiations.

Court Facilities

- Fifteen real estate transactions were completed involving new or renewed leases and licenses, event licenses, terminations, joint occupancy agreements, and permits for 17 courts: San Bernardino, Stanislaus, Los Angeles, Butte, Alameda, Riverside,

Collaboration with Justice Stakeholders

- California Department of State Hospitals: Develop an interagency agreement focused on improving the quality of forensic evaluator reports used by the courts to make determinations about a defendant's competency to stand trial.
- Probation Advisory Committee of the Chief Probation Officers of California: Answered questions on court process and procedures for foster youth specifically related to the Family First Prevention and Services Act.

 Received updates on the concepts referred to applicable advisory committees and reviewed recommendations of the Code of Civil Procedure Section 367.9 Working Group on civil remote proceedings.

Advisory Committee on Audits and Financial Accountability for the Judicial Branch

• Recommended revisions to the Judicial Branch Contracting Manual to (1) align court procurement practices with comparable state standards pertaining to Disabled Veteran

Business Enterprise firms, and (2) update information on encumbering spending authority when preparing and executing contracts.

Advisory Committee on Providing Access and Fairness

- Discussed allocation of the Equal Access Fund and the work of the Language Access Subcommittee.
- Legislative Working Group: Received briefings from Judicial Council Governmental Affairs on regulation of legal document assistants and unlawful detainer assistants, Sargent Shriver Civil Counsel Act funding, and use of technology to appear in court (Senate Bill 848).
- Racial Justice Working Group: Continued evaluation of sources for an online Racial Justice Toolkit to assist trial courts.

Appellate Advisory Committee

• Approved the annual agenda for 2022–23.

Center for Judicial Education and Research Advisory Committee

- Received a report on the July Judicial College program, and an update on the proposed modifications to education-related rules of court.
- Considered proposed revisions to streamline and clarify objectives, roles, and responsibilities of the advisory committee and its curriculum committees.
- Discussed modifying membership of the Judicial Branch Access, Ethics, and Fairness Curriculum Committee to include court administrators and staff.

Civil and Small Claims Advisory Committee

- Approved an Invitation to Comment to recirculate name change forms with proposed revisions needed with the passage of Assembly Bill (AB) 421 (Change of gender and sex identifier).
- Considered two protective order forms proposals on a special cycle to implement the provisions of AB 1621 (Prohibits individuals subject to civil restraining orders from having firearm parts).

Civil Jury Instructions Advisory Committee

• Considered proposals to revise *Judicial Council of California Civil Jury Instructions* based on public comments, proposals from judges and lawyers, and developments in the law over the last six months. These included potential new instructions on meal and rest breaks under the Labor Code.

Code of Civil Procedure Section 367.9 (Remote Civil Proceedings) Working Group

- Members presented challenges and successes of remote proceedings in various case types, including general civil, family law, juvenile delinquency and dependency, small claims, unlawful detainers, and use of court interpreters.
- Received updates on the Internet Technology Advisory Committee's Hybrid Workstream, Court Reporters Board of California, and the \$30 million allocated to the Judicial Council to address the court reporter shortage in civil and family cases.

Collaborative Justice Courts Advisory Committee

- Discussed proposed legislation, including AB 1630 (Competence to Stand Trial) and Senate Bill (SB) 848 (Use of technology to appear in court).
- Received updates on a webinar re: Assisted Outpatient Treatment Due Process.
- *Juvenile Subcommittee:* Provided guidance for a series of planned webinars on mental health concerns for court-involved and at-risk youth.

Court Executives Advisory Committee

- Discussed a proposed joint subcommittee with the Information Technology Advisory Committee to review and comment on security-related recommendations.
- Received updates on court technology modernization funding and the Franchise Tax Board memorandum of understanding relating to SB 592 (Jury service).

Court Security Advisory Committee

- Discussed the Security Systems Program on installation and maintenance of electronic security equipment.
- Approved 10 new and two amended projects for service calls, consultant contracts, and asbestos and lead paint surveys.
- Approved an out-of-cycle proposal to request that the Judicial Council Legislation Committee consider an official comment on Commercial Surveillance and Data Security Rulemaking.

Considered a draft report on legislative changes needed to bring California into compliance
with federal child support regulations, amendments to guidelines for the dependency

Treatment Facility Offense-Based Classification Matrix, and the annual agenda for the
upcoming year.

Information Technology Advisory Committee

• Received updates on (1) the project to migrate the Computer-Aided Facilities Management System to the Cloud, and (2) the California Courts Translator Program, which provides real-time voice-to-text transcription and translation outside the courtroom at court clerk windows and self-help centers.

Probate and Mental Health Advisory Committee

• Legislative Subcommittee: Received a briefing from Judicial Council Governmental Affairs on SB 1338 (Community Assistance, Recovery, and Empowerment (CARE) Act).

Definitions:

Authorized Position (FTE) Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

Filled Authorized Position

Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

(FTE)

Headcount The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or

Employment Agency Temporary Workers.

Vacancy (FTE) The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

Judicial Council Temporary

The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

Employees (909)

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement service credit).

Employment Agency
Temporary Worker (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Contractor (FTE)

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.

Full Time Equivalency (FTE)

Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.

Time Base Full time: Er

Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

Regular Employee

Commonly referred to as "permanent employees" – They receive full benefits.

Limited Term

Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.
