The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's meeting on January 20, 2023, and is exclusive of items on the March business meeting agenda.

Judicial Branch Budget

Judicial Council senior staff and court leadership participated in budget subcommittee hearings for both the Assembly and Senate to present judicial branch proposals included in the fiscal year 2023–24 Governor's Budget. The council submitted a spring budget change proposal to the Department of Finance for increased Appellate Court Trust Fund expenditure authority in the 2023–24 fiscal year budget. Meetings were also held with the Department of Finance on a State Public Works Board bond sale to refinance debt on three courthouse projects in Kings, Santa Clara, and Sutter Counties. The bond sale was approved, although the final savings will not be known until the sale closes in April.

Legislative Advocacy

The Judicial Branch: Protecting Access to Justice as the COVID-19 State of Emergency Expires was the focus for the Joint Oversight Hearing, Senate Judiciary and Senate Public Safety Committees. Judge Marla O. Anderson, Chair of the Judicial Council Legislation Committee, Judge Maria Lucy Armendariz of the Superior Court of Los Angeles County, Judge Lawrence G. Brown of the Superior Court of Sacramento County, and Judicial Council Chief Policy and Research Officer Shelley Curran testified on behalf of the Judicial Council regarding remote proceedings, court interpreting, and court reporter services. The hearing agenda, committee background paper, and video archive are available on the Senate Judiciary Committee's website.

Annual Summary of Court-Related Legislation

The 2022 Summary of Court-Related Legislation was published on the California Courts website. The summary consists of new laws affecting the courts or of general interest to the judicial branch.

Court Statistics Annual Report

The 2023 Court Statistics Report for fiscal year 2021–2022 was published and posted on the California Courts website. Data shows overall filings have stabilized in the trial courts. For fiscal year 2021–22, there were 4,407,174 filings, representing a small decrease of one percent from 2020–2021 (4,464,380).

Judicial Officer Demographics Annual Report

For the 17th year, California's judicial bench has grown more diverse, according to new data released by the Judicial Council. As of December 31, 2022, responding female judicial officers constitute 39.9 percent of judicial officers across all court levels, an increase of more than 12 percent since 2006—the first year that data was collected. The bench also has continued to become more racially and ethnically diverse, with the percentage of Asian, Black, and Hispanic judicial officers doubling over the same period. The Judicial Council is required to collect and release aggregate demographic data relative to the gender, race/ethnicity, sexual orientation, gender identity, and veteran and disability status of California state court justices and judges, by specific jurisdiction, each calendar year. Responding to the questionnaire is voluntary for judges.

Audit Services

Audit entrance conferences were held with the Superior Courts of Tulare and Sonoma Counties. Five trial court audits are currently under way.

Expansion of Online Tool for Adjudicating Infraction Violations

Statewide expansion of the MyCitations application for online ability-to-pay determinations, as required by Assembly Bill 143, continued, with three additional superior courts—Amador, Merced, and Nevada—launching the tool. Twenty-one courts are now using the application.

Trial Court Website Accessibility

Collaborating with the Judicial Council, the Superior Courts of Lake, San Francisco, and Sonoma Counties migrated to a modern, mobile-friendly ADA accessible web platform. The sites are ADA-compliant, allowing users to navigate, find content, and use all features and functionalities of the sites with ease. To date, 35 trial courts have successfully transitioned to the updated platform. All remaining courts will migrate to the updated platform over time.

Labor and Employee Relations

Labor negotiations assistance was provided to 16 trial courts on 30 matters. Services included side letter negotiations, impact bargaining, and successor memorandums of understanding negotiations. Support was also provided on 21 different labor and employee-related matters.

Court Facilities

Thirty-nine real estate transactions were completed involving new or renewed leases and licenses, as well as permits for court facilities, in 20 counties.

Pretrial Release Program

A site visit to the Superior Court of San Francisco County's jail intake center was conducted to observe how the Pretrial Diversion Project is operating and using allocated funding. Judicial Council staff also convened a meeting of the Pretrial Pilot Group for a presentation to court staff on data collection capabilities.

Incompetent to Stand Trial Program

The Judicial Council entered into a three-year, \$15 million agreement with the California Department of State Hospitals to enhance the quality of forensic evaluator reports and increase the pool of qualified evaluators used to make determinations about a defendant's competency to stand trial. This project will involve training and recruitment efforts, research, and development

of resources for courts on identifying and scheduling evaluators, as well as activities to increase collaboration between the department and the judicial branch.

Community Assistance, Recovery, and Empowerment (CARE) Court

Staff participated in the second convening by the California Health and Human Services Agency of the initial cohort of implementing courts and counties (Glenn, Los Angeles, Orange, Riverside, San Diego, San Francisco, Stanislaus, and Tuolumne) to discuss implementation.

Judicial Resources and Technical Assistance

File reviews of juvenile cases were conducted in the Superior Courts of Calaveras, Los Angeles, and Placer Counties to identify any legal issues and training needs.

- Recommended technical amendments to multiple record cleaning forms.
- Discussed public comments received on proposals to revise a military resentencing form, amend the rule of court on mental competency in relation to recommending antipsychotic medication, and revise the defendant's financial eligibility form based on statutory changes repealing reimbursement to the county for attorney's fees.
- Reviewed and provided feedback on pending legislation.

Family and Juvenile Law Advisory Committee

- Completed proposals for rules and forms for youth committed to secure youth treatment facilities, requirements for family finding, domestic violence and civil protective orders, and veterans in family law.

Definitions:

Authorized Position (FTE) Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

Filled Authorized Position (FTE) Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

Headcount The actual count of persons employed by the Judicial Council Temporary Employees (909) or Employment

Agency Temporary Workers.

Vacancy (FTE) The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

Judicial Council Temporary

Employees (909)

The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due tot he unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement service credit).

Employment Agency Temporary Worker (FTE) Contractor (FTE)

Full Time Equivalency (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.

Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE.

One employee working for 1,040 hours each would consume .5 FTE.

Time Base Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

Regular Employee Commonly referred to as "permanent employees" – They receive full benefits.
