The following information outlines some of the many activities staff is engaged in to further the Judicial Council's goals and priorities for the judicial branch. The report focuses on action since the council's July meeting and is exclusive of issues on the August business meeting agenda.

Trial Court Resource Assessment Study

Judicial Council Office of Court Research and Criminal Justice Services staff visited courts in Merced, Placer, San Francisco, Contra Costa, and Sacramento Counties to review and validate data collected for the Resource Assessment Study, which identifies funding needs across courts based on workload composition and filing patterns over time.

Labor and Employee Relations

Labor negotiations assistance was provided to 14 trial courts covering 17 different bargaining units. Services included successor Memoranda of Understanding negotiations, proposed policy revisions, and modifications to Employer-Employee Relations Rules. Additionally, support was provided to 12 courts in responding to labor and employment related matters.

Traffic Fines and Fees

Legal assistance was provided to superior courts regarding traffic procedure and local forms, notices, and website language. Staff presented to the council's Rules and Projects Committee for circulation for public comment rule/form proposals regarding improving notice and opportunity to be heard on ability to pay, installment plans, and community service.

Capital Program

The new Family Justice Center of the Superior Court of Santa Clara County, housing 20 courtrooms, opened to the public on August 15, 2016.

Real Estate and Facilities Management

Twenty real estate transactions were completed including lease renewals and event licenses as follows:

Court Security

Staff partnered with the Superior Court of Tulare County, the Tulare County Sherriff's Department, and other local departments on an active shooter drill.

California Courts Protective Order Registry

A new data exchange was delivered to key case management vendors to enable the electronic exchange of protective order data and forms. Use of the data exchange eliminates the need for manual routing, reduces errors and duplicate data entry, and speeds up processing time for both the registry and the California Department of Justice. This registry currently serves 43 courts and their respective law enforcement agencies, as well as read-only access 13 tribal courts throughout the state.

Court Interpreter Usage

Interpreter usage data by case type and language was compiled for the second quarter of fiscal year 2015–2016 including tracking the expansion of interpreter usage in civil proceedings. Individual reports were provided to each court.

Legislative Advocacy

The Governor signed the Judicial Council-sponsored bill AB 2232, Court records: misdemeanors. The bill corrects drafting errors in the rules governing retention of court files for certain misdemeanor traffic offenses. Collaborative Justice Court

An assessment was conducted for the youth court and girls' Succeeding through Achievement and Resilience court program in Compton, Los Angeles. The court provides intervention for girls involved in sex trafficking. The program assessments will help in the overall evaluation of this specialized collaborative court.

Mentally Ill Offenders

Staff attended a meeting of the California Department of Corrections and Rehabilitation's Council on Mentally III Offenders' Committee on Diversion and the Department of State Hospitals' Incompetent to Stand Trial Workgroup, where participants discussed promoting effective practices for justice-involved youth and adults with mental illness.

National Drug Court Standards

Staff represented California at a meeting of the National Association of Drug Court Professionals' Drug Court Standards Implementation Advisory Group. The group was created to assist in the development, prioritization, and implementation of drug court standards throughout the country and to make recommendations related to training and technical assistance to the states.

National Child Access and Visitation Grant Program

Staff attended a leadership symposium of Federal Office of Child Support Enforcement, Access and Visitation Coordinators and the National Child Support Enforcement Association. Access to

Visitation Grant programs in 45 states and three territories were represented at the meeting. The agenda covered programmatic changes in the federal fiscal years 2017–2019 grant program that reflect a stronger emphasis on program efficiency, coordination of services, increased attention to family safety, and working with states and local child support regarding enactment of Public Law 113-182, which encourages states to establish parenting time orders through coordination of state grant services and the courts.

Advisory Committees/Task Forces/Working Groups

The Chief Justice appointed 49 new members to the Judicial Council's 25 standing advisory bodies as part of the annual appointments process. More than 500 members volunteer their time and expertise to service on the advisory groups.

2017–2018; implementation of the Strategic Plan for Language Access in the California
Courts; the Department of Child Support Services audits of the Superior Courts of Napa and
Placer Counties; and reestablishment of regular meetings for trial court chief financial officers.

Court Facilities Advisory Committee

- Reviewed the status of the active SB 1407 capital projects in the Judicial Branch Courthouse Construction Program.
- Received presentations from 16 local courts regarding funding for safe and secure courthouses statewide.
- Voted to recommend to the Judicial Council that all 23 current judicial branch projects continue based on the availability of funding.

Criminal Law Advisory Committee

- Reviewed rule and form proposals for improving notice and opportunity to be heard on ability to pay, installment plans, and community service that will circulate for public comment.
- Reviewed comments on a proposal to amend rule 4.530 re inter-county transfer: file transfer procedures.
- Reviewed criminal law-related legislation.

Information Technology Advisory Committee

- Considered updates to three rules and four legislative proposals following public comment. The proposals focused on modernizing rules and related legislation in the areas of e-filing practices, probate and juvenile case types, and appellate court rules. Recommended proposals will be brought to the Judicial Council at both its August and October meetings.
- Workstreams continue on e-filing manager procurement, a self-represented litigant e-services strategy, and disaster recovery framework planning.
- Issued Request for Proposals for technology vendors to provide video remote interpreting solutions for the courts during a six-month pilot project to be launched during the first quarter of 2017.

• Settlement Authority Working Group: Reviewed options for a proposed claims settlement authority policy for all program members.

Probate and Mental Health Advisory Committee

- Reviewed a draft of the third edition of the *Handbook for Conservators*.
- Reviewed public comments on proposals for revision of forms used in a decedent estate and
 for adoption of a new form required by statute to be used in probate conservatorships to
 notify interested persons that the conservatee has died and recommended these proposals for
 approval by the Judicial Council.
- Recommended for Judicial Council sponsorship a proposal for legislation governing storage
 of original wills and codicils deposited with courts and a proposal for revisions in the Probate
 Code to permit electronic service of papers in probate proceedings

 Reviewed and approved the fiscal year 2017–2018 Deferred Maintenance Report and the Court-Funded Facilities Request Policy for consideration by the Judicial Council at the August meeting.

Detail

B.E. Witkin Judicial College

Eighty-eight judicial officers attended this year's Judicial College. Plenary sessions included Making an Effective Record; Trials; Evidence; Experts 101; Working with Self-Represented Litigants; Domestic Violence; Judicial Ethics; and Alcohol, Drugs and Mental Illness in the Court System. The Chief addressed participants and council members met with participants in their seminar groups. Concurrent sessions during the second week included Documentary and Electronic Evidence; Search and Seizure; Civil Settlement; Introduction to Felony Sentencing; Mental Health and the Courts; High Conflict Personalities; Criminal Discovery; and Introduction to Juvenile Dependency.

Budget

WebEx budget training was provided for 31 trial courts on the budget template preparation for 2016–2017.

CJER Podcasts

This service was launched in August. New podcasts will be added each month. Current programs include: Best practices for expedited civil litigation; Science and Technology—judicial implications for medication assisted treatment for opioid addiction; and Legal updates in family law.

Core 40

This is an intensive five-day program for managers and supervisors to improve the overall performance of their staff. The course focuses on the role of the supervisor; leadership skills; group development; employment law; and performance management.

Employee Leave

This broadcast seeks to answer many of the questions managers and supervisors have when an employee requests an extended medical leave. Topics include: the Family and Medical Leave Act, California Family Rights Act, Pregnancy Disability Leave, accommodations, and confidentiality.

Family Law Contempt Procedures

This broadcast is designed to introduce family law courtroom clerks and judicial assistants to the procedures for a contempt hearing.

Fundamentals of Substance Use Disorders and Principles of Effective Treatment with Justice-Involved Populations

Two nationally and internationally regarded experts presented two offerings of a five-hour course on the nature of substance abuse disorders and its relationship to criminality. The course also examined treatment interventions among those under criminal justice supervision and suggested practices that data show to be effective in reducing recidivism.

Orientation to the Judicial Branch

This video uses interview clips to introduce new judicial branch employees to the state court system. It is divided into seven chapters: Introduction, Branches of Government, Branch Administration, Superior Courts, Supreme Court and Courts of Appeal, Principles, and Opportunities to Grow.

Training to Train One-on-One

This course, provided at the request of Superior Court of Sacramento County, included adult learning styles, planning and preparation techniques, and instruction on various teaching methods.

Definitions:	
Authorized Position (FTE)	Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.
Filled Authorized Position (FTE)	Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.
Headcount	The actual count of persons employed, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". It does not include Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of vacancies is the number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees ("909" funded employees). See definition of temporary employees below.
Temporary Employees (909)	The 909 category is the State Controller code used to reference a temporary position or temporary employee. A 909 position may not be funded through the Budget Act. It is categorized as a temporary position in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position and may receive benefits if employed at least half-time for more than six months. Types of "909" Employees include: Retired Annuitants: A retiree hired by a former employer or other employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who previously retired and currently receives retirement benefits. Temporary Employees: Employed on a temporary basis - they do not receive full benefits (but do receive Calpers retirement service credit).
Employment Agency Temp. Worker (FTE)	These are workers from an employment agency who provide short-term support for workload.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits. Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees" – They receive full benefits.
Limited Term	Limited Term Position – A position funded through the Budget Act with a specific end date and counted as an authorized position. Employee in limited term positions may be regular or temporary.
