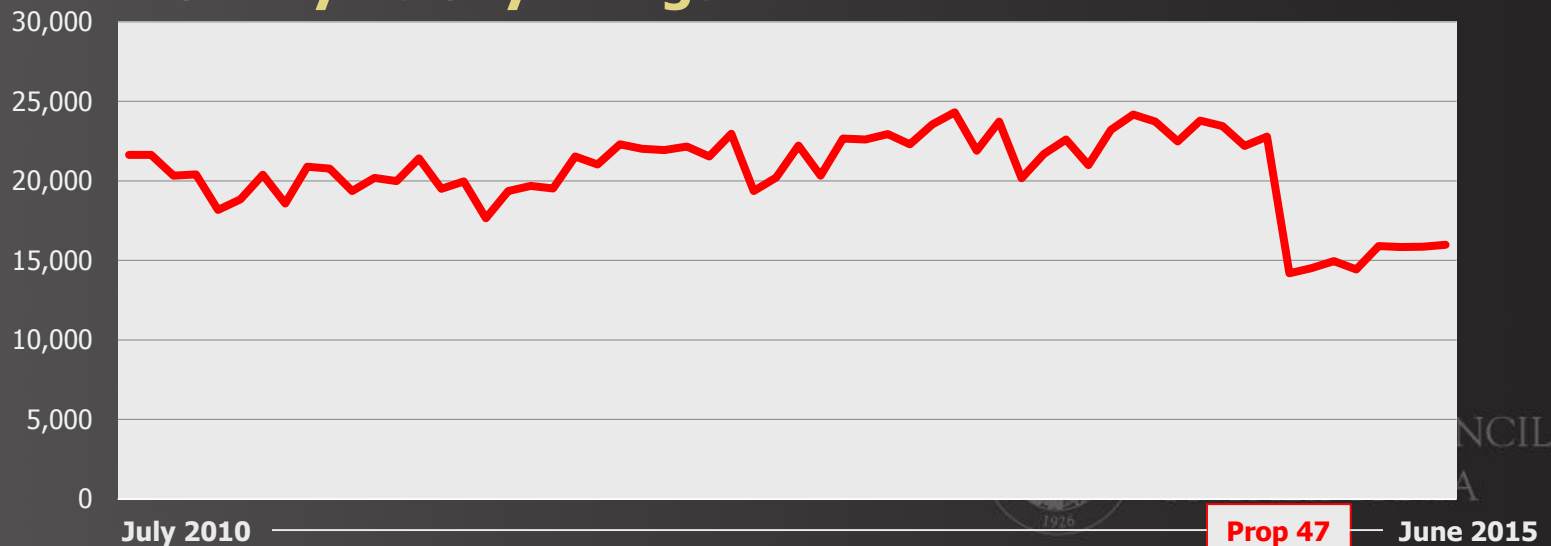

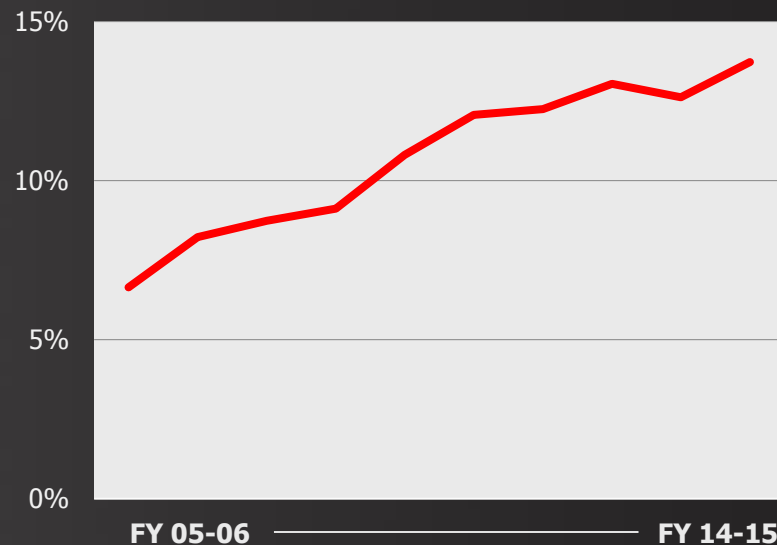
# Fines and Fees: Fee Waiver Requests

Percent of cases with request for fee waiver

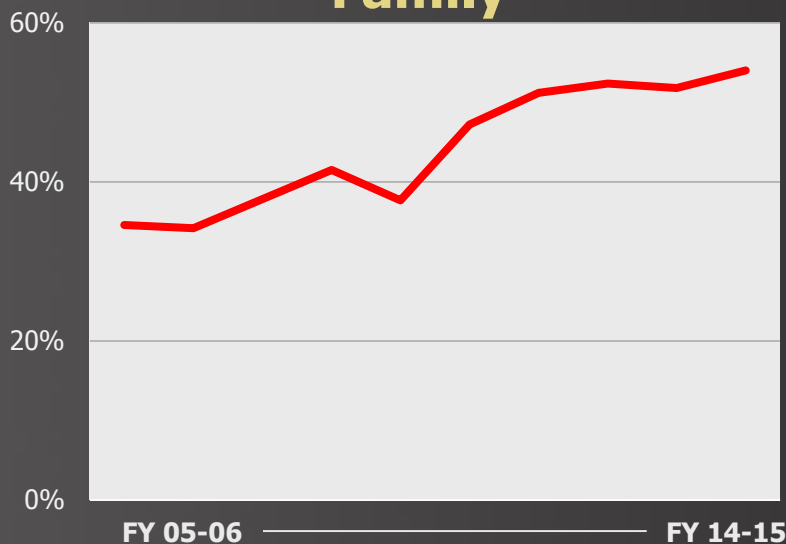
