#### **Executive Summary**

The Governing Committee of the Center for Judicial Education and Research (CJER) has completed the final report on its 2014–2016 Education Plan for the judicial branch (see Attachment A). The education plan, which was developed by the CJER Governing Committee for all the judicial branch audiences that CJER serves, contains training and education programs and products that enable those audiences to fulfill the education requirements and expectations outlined in rules 10.451–10.491 of the California Rules of Court. This final report provides an overview of the education plan's execution and the extent to which it met the educational objectives established by the CJER Governing Committee.

#### **Previous Council Action**

Since 2009, when the CJER Governing Committee changed its committee structure and the process of developing and implementing judicial branch education, the Governing Committee, working with its nine curriculum committees, has developed an education plan every two years for submission to the Judicial Council. The 2014–2016 Education Plan was submitted to and approved by the Judicial Council on April 24, 2014.

#### Comments, Alternatives Considered, and Policy Implications

The education plan was developed during months of work conducted by the Governing Committee's nine curriculum committees and included their prioritized recommendations for fiscal years 2014–2015 and 2015–2016, including additional analysis of all high-cost education programs. These recommendations were then assessed by staff to determine whether funding and staffing resources were sufficient to implement them. Finally, the Governing Committee reviewed, vetted, prioritized, and finalized the entire plan. The process provides a high degree of transparency and review by judicial officers as well as by court leadership members of the both the Governing Committee and the curriculum committees.

Alternatives were considered throughout the education plan development process, beginning with the curriculum committees. These committees reviewed their respective curricula (civil, juvenile, family law, etc.) and determined whether there were gaps in education and, if so, the content that should be provided and the delivery method. The CJER Governing Committee, in reviewing the education recommendations from its curriculum committees, considered several alternative content and delivery proposals. When the Governing Committee first met to begin reviewing the 2014–2016 Education Plan, staff noted that available resources were insufficient to deliver all of the committees' highest priorities. The Governing Committee noted and discussed thoroughly those programs that could not be resourced before making determinations regarding priorities.

To ensure that the education plan was being executed properly, CJER staff followed an existing reporting and tracking protocol to confirm that all of the items in the plan were being developed and delivered as scheduled and that any deviations from the plan—of either the delivery schedule or the delivery method—were noted, explained and, where appropriate, brought to the attention of the relevant curriculum committee and the Governing Committee for appropriate action.

#### **Summary of Findings**

In sum, the development and delivery of education for the judicial branch as contained in the 2014 – 2016 Education Plan was highly successful. The vast majority of all the educational programs and products included in the 2014–2016 plan were delivered on schedule. These products included statewide live events, regional programming, online courses, broadcasts, webinars, and CJER's extensive array of legal publications. The plan's final report also illustrates the flexibility of the current education development model, as when education products had to be redesigned in response to extenuating circumstances. The 2014–2016 Education Plan also demonstrates how the education development model lends accountability and transparency to the development and delivery of education to the audiences within the judicial branch.

#### Scale of the education plan

Over 200 separate statewide and regional in person courses and programs for judicial branch audiences were scheduled during 2014–2016, as were nearly 200 distance mediated education products, including videos, broadcasts, webinars, and online courses. In addition, CJER maintained over 75 judicial publications during this period. Updating these resources is

important to maintaining them as accurate tools that bench officers can turn to for reference when needed.

During the past several years, with reductions in live, face-to-face programs, distance education has played a larger role in providing education to judges and court staff. The *CJER Online* website has become the most frequently used delivery mechanism for judicial branch education, and distance education products have proved to be extremely valuable in providing just-in-time training and education for the judicial branch.

#### Scope of the education plan

The 2014–2016 Education Plan contains an enormous amount of variety in content and subject areas, including the standard programs and products CJER has delivered for many years: the Judicial College, the judicial institutes, the statewide and regional court staff classes, and broadcasts. The education plan introduced some new topics, such as an appellate procedures course held at the Court Clerk Training Institute. This new course was requested by the previous Governing Committee chair and was a part of the Governing Committee's 2014 Annual Agenda.

Video lectures produced during this plan and posted on *CJER Online* covered a number of timely topics: *Judicial Ethics: Internet Usage and Social Media; LGBTQ Issues in Juvenile Court; ICWA As It Relates to Probate; Effects of Trauma, Including Domestic Violence; Emotional Intelligence; Timeliness of Juvenile Petitions; and <i>Using Court Interpreters*. The Continuing the Dialogue broadcast series included productions such as *From Oscar Grant to Trayvon Martin—A Dialogue about Race, Public Trust and Confidence in the Justice System* and *ADA Awareness: Non-apparent Disabilities*.

For court staff and leadership, many programs, broadcasts, and other education products were delivered on topics such as caseflow management in various court assignments, basic procedures in traffic and felony sentencing, and employee motivation, leadership, and professional ethics for court management. Programs for presiding judges, supervising judges, and court executive officers continued to feature faculty with national reputations in leadership development, as well as innovative sessions in ethics.

#### Relevant Strategic Plan Goals and Operational Plan Objectives

This report furthers Goal V, Education for Branchwide Professional Excellence, by providing relevant and accessible educational and professional development opportunities for all judicial officers and court staff.
