Executive Summary

Since 2014, the Legal Services Trust Fund Commission has been engaged in work to streamline and improve the efficacy of its grant making, including instituting new data collection protocols designed to determine the outcomes of the legal services provided through the Equal Access and Interest on Lawyers' Trust Account Funds. This report describes this effort to document the impact of legal services and demonstrate accountability in use of resources. The multiyear transition to a new grant-making platform also resulted in short-term challenges, and this report also contains technical corrections to previous reports prepared for the Judicial Council regarding the distribution of the Equal Access Fund.

Recommendation

The State Bar's Legal Services Trust Fund Commission (the "Commission") recommends that the Judicial Council:

1. Endorse ongoing efforts by the Commission to enhance efficiency and document the impact of the Equal Access Fund; and

- 2. Approve the following technical corrections to previously approved reports entitled *Equal Access Fund: Distribution of Funds for Partnership Grants and IOLTA-Formula Grants*:
 - A) For the report submitted for the October 27, 2014 Judicial Council business meeting, accept revised Attachment C that inadvertently did not include one of the grantees whose funding was approved by the Judicial Council.
 - B) For the report submitted for the October 26, 2015 Judicial Council business meeting, accept Attachment D that sets out the individual grant awards for each recipient of IOLTA-formula grants, which was inadvertently not included in the report. The report should be further corrected to note that the approved amount for the partnership grant award for the Alameda County Bar Volunteer Legal Services Unlawful Detainer Project was \$25,000, not \$55,000. Lastly, because of the tight timing of the grant cycles, the report did not include subsequent adjustments to a requested IOLTA-formula grant of \$23,000; the distribution amount should be reduced from \$12,773,000 to \$12,750,000 to reflect that fact.
 - C) For the report submitted for the October 27, 2016 Judicial Council business meeting, approve the revised Attachment E that has been corrected to remove an allocation to a grantee that withdrew its application after the report to the Judicial Council was submitted. The total recommended distribution of IOLTA-formula grants is \$17,199,592.

Previous Council Action

The Judicial Council has approved the total amount of distribution of the grants in its proposed distribution for each of the past 16 years based on the recommendations of the Legal Services Trust Fund Commission. The Commission provides information to the Judicial Council each year regarding the process and procedures for determining its grant recommendations as well as its monitoring procedures.

Rationale for Recommendation

Since 1999, the state Budget Act has contained a provision for the allotment of \$10 million to an Equal Access Fund "to improve equal access and the fair administration of justice." For fiscal year 2016–2017, an additional \$5 million was added to the fund. (Sen. Bill 826, Stats. 2016, ch. 23, pp. 16–21.)

In 2005, the Uniform Civil Fees and Standard Fee Schedule Act was approved by the Legislature and the Governor. That act established a new distribution of \$4.80 per filing fee to the Equal Access Fund. The estimated revenue from filing fees for the fund is approximately \$4 million per year. Those revenues have been collected by the trial courts since January 2007.

The Budget Act requires the Judicial Council to distribute the Equal Access Fund monies to legal services providers through the State Bar Legal Services Trust Fund Commission. The State Bar

created the commission to administer the law regulating Interest on Lawyers' Trust Accounts (IOLTA). (Bus. & Prof. Code, § 6210 et seq.; State Bar, *Rules Regulating Interest-Bearing Trust Fund Accounts for the Provision of Legal Services to Indigent Persons* [Sept. 1982, amended Mar. 2002], rule 4.)

The Budget Act states that "[t]he Judicial Council shall approve awards made by the commission if the council determines that the awards comply with statutory and other relevant guidelines...." (The Budget Act is Attachment A.)

The Chief Justice, as chair of the Judicial Council, appoints one-third of the voting members to the Commission: five attorney members and two public members, one of whom is a court administrator. The Chief Justice also appoints three nonvoting judges to the Commission: two trial court judges and one appellate justice. (The membership roster is in Attachment B.)

Improved Measurement and Streamlined administration

For some years now, the Trust Fund Program has been working to (1) improve the measurement and collection of outcome data, and (2) leverage available resources by streamlining grant administration for grantees, staff, and the Commission while maintaining fairness and consistency in application of statutory mandates. Significant progress has been made toward those objectives.

1. Improve the measurement of outcome data

In order to address the challenges of a drop in funding and to better articulate unmet need and accomplishments to policymakers, lawmakers, and funders to increase funding, the Commission has developed a set of metrics to demonstrate the outcome of services provided by its grantees. The Commission has always required the grantees to provide Case Services Report (CSR) data, which compiles information on the number of clients served and the number of cases closed—classified by broad areas of substantive focus (such as housing)—with detailed reports on impact cases. That data is very useful for counting services, but does not provide any information about the results achieved, the value of the services provided to clients, the benefit to society, or the extent to which grantees are able to meet clients' needs.

By working closely with subject matter experts in the legal services community, the Commission developed a series of metrics in eight different case types in which legal services agencies typically provide services. These areas are Housing, Consumer/Finance, Immigration, Family, Education, Domestic Violence, Health, Individual Rights, Juvenile, Conservatorship/Guardianship, Employment, Income Maintenance, and Miscellaneous. These measurements have been informed by similar tools in other states and are designed to more clearly show the results achieved, and value of services to the clients and society at large.

On January 30, 2017, the Commission held a meeting of the grantees to review findings from the first months of data collection (April–October 2016). Initial results are very promising.

They show that in 2015, grantees provided extended legal services to 47,767 persons and limited services to an additional 202,264 persons. The majority of those services were in housing, with 47,176 persons receiving limited services and an additional 11,515 receiving limited assistance. Health and Long Term Care had the next highest number of services with 5,026 receiving extended services and 27,049 receiving limited services. Another key area was income maintenance, where 7,272 received extended services and an additional 16,736 persons received limited services.

In domestic violence, programs provided extended representation to 3,735 persons and limited services to 13,978 additional persons. Of those who received extended services, 3,113 received a temporary restraining order protecting them from abuse, 350 received other services designed to protect them from abuse, and 17 prevented issuance or obtained termination of a protective order. In income maintenance, the programs were able to achieve over \$12,268,282 in back awards and lump-sum settlements for their clients, with a reduction or elimination of \$751,624 in claimed amounts.

A very preliminary analysis of the benefits suggests that for every dollar spent on legal aid in California, the state receives a multiplier effect of 1.47. That would indicate that the states' investment of \$17,199,592 in 2017 would produce a benefit of \$25,283,400.

The Commission is pleased to note that legal services organizations have benefitted already from the collection of outcome data, and look forward to continuing to work with the Trust Fund Program to standardize, expand, and enhance the data collection to improve its accuracy and completeness. Through these efforts, the Commission can continue to ensure the judicious use of Equal Access and other funds.

2. Streamline application process for administrative effectiveness

Effective calendar year 2015, all grants were fully transitioned to a single calendar year, with a bridge process for IOLTA from July 1–December 31, 2014, and EAF from October 1–December 31, 2014. While it had been envisioned that this additional process would be managed by new online grant software, the vendor selected was not able to deliver the product as promised, and because the existing system could not manage the data for an additional half-year grant, much of the grant administration was handled manually.

A new vendor was selected for 2015. While the new application has significantly simplified administration of the projects, routine build-out challenges and the learning curve for the report-generation feature contributed to the technical errors that this report seeks to correct. With a better understanding of how the report builder on the new software pulls information, the Trust Fund Program has put into place controls to avoid inaccurate reports in the future.

Ultimately, the new grant-making software provides phenomenal opportunity to improve efficiencies and enables grantees to prepare online applications through which data can be saved from year to year. It facilitates record keeping, enables access and sharing of grant

information offsite, streamlines monitoring, enables reporting on data collected, and utilizes other best practices for grant making.

Technical corrections

Each year, the Commission provides a report to the Judicial Council on its recommendations, providing the rationale for those recommendations and background on its grant making and review process. This report is normally about 50 pages long including attachments. In the course of reviewing past Judicial Council reports, problems were identified with the attachments that included the list of the specific programs that were recommended for funding. While these errors do not affect the amounts allocated by the Judicial Council, the council is asked to accept a correction of each of these attachments to ensure that the amounts match the recommendations of the Commission and the amount allocated to the programs for each of those years.

- For the October 27, 2014 report, accept revised Attachment C that inadvertently did not include one of the grantees whose funding was approved by the Judicial Council.
- For the October 26, 2015 report, accept Attachment C that sets out the individual grant awards for each recipient of IOLTA-formula grants inadvertently not included in the report. The report should be further corrected to note that the approved amount for the partnership grant award for the Alameda County Bar Volunteer Legal Services Unlawful Detainer Project was \$25,000, not \$55,000. Comments, Alternatives Considered, and Policy Implications

The recommendations have been approved by the Legal Services Trust Fund Commission and its Partnership Grants Committee as required by law. The statutory scheme does not contemplate public comment.

There are no viable alternatives to distributing the funds according to the recommendations of the Commission. The Budget Act requires the council to approve the distribution if it finds that the statutory and other relevant guidelines are met.

Implementation Requirements, Costs, and Operational Impacts

Council staff will work with the staff of the Commission to oversee administration of the Equal Access Fund, including fulfillment of requirements for reports on the Commission's

administration of the fund and will develop procedures to avoid future technical errors. Council staff will also work with the Commission to support its efforts to document the impact of the Equal Access Fund.

The recommendation contained in this report will have no direct fiscal effect on the courts; nevertheless, the courts will indirectly benefit from assistance provided to self-represented litigants. Council staff support will be covered by the provision for administrative costs in the Budget Act appropriation.

Relevant Strategic Plan Goals and Operational Plan Objectives

This recommendation helps implement Goal I of the Judicial Council's strategic plan—Access, Fairness, and Diversity—by increasing representation for low-income persons.

THE PEOPLE OF THE STATE OF CALIFORNIA DO ENACT AS FOLLOWS:

SECTION 1.00.

This act shall be known and may be cited as the "Budget Act of 2016." [....]

Provisions

qualified legal services projects and support centers as defined in Sections 6213 to 6215, inclusive, of the Business and Professions Code, to be used for legal services in civil matters for indigent persons. The Judicial Council shall approve awards made by the commission if the council determines that the awards comply with statutory and other relevant guidelines. Ten percent of the funds in Schedule (8) shall be for joint projects of courts and legal services programs to make legal assistance available to pro per litigants and 90 percent of the funds in Schedule (8) shall be distributed consistent with Sections 6216 to 6223, inclusive, of the Business and Professions Code. The Judicial Council may establish additional reporting or quality control requirements consistent with Sections 6213 to 6223, inclusive, of the Business and Professions Code.

2. The amount appropriated in Schedule (1) is available for reimbursement of court costs related to the following activities: (a) payment of service of process fees billed to the trial courts pursuant to Chapter 1009 of the Statutes of 2002, (b) payment of the court costs payable under Sections 4750 to 4755, inclusive, and Section 6005 of the Penal Code, and (c) payment of court costs of extraordinary homicide trials.

In order to improve equal access and the fair administration of justice, the funds appropriated in Schedule (7) are available for distribution by the Judicial Council through the Legal Services Trust Fund Commission in support of the Equal Access Fund Program to qualified legal services projects and support centers as defined in Sections 6213 to 6215, inclusive, of the Business and Professions Code, to be used for legal services in civil matters for indigent persons. The Judicial Council shall approve awards made by the commission if the council determines that the awards comply with statutory and other relevant guidelines. Upon approval by the Administrative Director, the Controller shall

transfer up to 5 percent of the funding appropriated in Schedule (7) to Item 0250-001-0932 for administrative expenses. Ten percent of the funds remaining after administrative costs shall be for joint projects of courts and legal services programs to make legal assistance available to pro per litigants and 90 percent of the funds remaining after administrative costs shall be distributed consistent with Sections 6216 to 6223, inclusive, of the Business and Professions Code. The Judicial Council may establish additional reporting or quality control requirements consistent with Sections 6213 to 6223, inclusive, of the Business and Professions Code.

8. Funds available for expenditure in Schedule (7) may be augmented by order of the Director of Finance by the amount of any additional resources deposited for distribution to the Equal Access Fund Program in accordance with Sections 68085.3 and 68085.4 of the Government Code. Any augmentation under this provision shall be authorized not sooner than 30 days after notification in writing to the chairpersons of the committees in each house of the Legislature that consider appropriations, the chairpersons of the committees and appropriate subcommittees that consider the State Budget, and the Chairperson of the Joint Legislative Budget Committee, or not sooner than whatever lesser time the chairperson of the joint committee, or his or her designee, may determine.
