### **Executive Summary**

Government Code section 68106 directs (1) trial courts to notify the public and the Judicial Council before closing courtrooms or clerks' offices or reducing clerks' regular office hours, and (2) the council to post all such notices on its website and also relay them to the Legislature. This is the 42nd report to date listing the latest court notices received by the council under this statutory requirement; since the previous report, **five** superior courts—Tulare, Stanislaus, San Diego, San Joaquin, and Siskiyou Counties—have issued new notices.

#### **Previous Council Action**

In 2010, the Legislature enacted a Judiciary Budget Trailer Bill with fee increases and fund transfers for the courts that also added section 68106 to the Government Code. Section 68106 requires trial courts to notify the public and the Judicial Council in advance of any closures or reductions in service, and the council in turn to post all such notices on its website and report them to the Legislature. Since the enactment of section 68106, a total of 48 courts have issued

notice under its requirements.<sup>2</sup> The Judicial Council has received 41 prior informational reports listing such notices as they have been received.

### **Notice Received From Five Courts Since Last Report**

This is the 42nd report provided to date on trial court notices submitted under Government Code section 68106. Since the previous report, the Judicial Council has received new notices from three trial courts:

- 1. The Superior Court of **Tulare County** provided public notice of the court's decision to change courtroom hours at the Pretrial Facility. Currently, the Pretrial Facility Courtroom hours are from 8:00 a.m. to 5:00 p.m., excluding court holidays and weekends. Effective July 3, 2017, the Tulare County Superior Court's Pretrial Facility Courtroom hours will be 8:00 a.m. to 4:00 p.m., Monday through Friday. (**Attachment B**)
- 2. The Superior Court of **Stanislaus County** provided public notice that effective Monday, July 3, 2017, all Stanislaus County Superior Court offices will reduce service hours for the public windows only. The changes in public service will not limit public access to the building, courtroom calendars or schedules. Due to the lack of available staff, public service hours at filing windows will be 8:15 a.m. to 4:00 p.m., Monday through Friday. (**Attachment C**)
- 3. The Superior Court of **San Diego County** provided public notice of the closure of the following courthouse buildings:
  - Central Courthouse at 220 W. Broadway, San Diego, California 92101,
  - Family Court Building, 1555 Sixth Avenue, San Diego, California 92101
  - Madge Bradley Building, 1409 Forth Avenue, San Diego, California 92101

The Central Courthouse closure will result in various courtrooms and associated staff moving out of the facility between July 20, 2017 and August 20, 2017. All courtrooms will be relocated to the new San Diego Central Courthouse at 1100 Union Street, san Diego, California 92101, with the exception of Departments 7 (unlawful detainers) and 22 (small claims). Departments 7 and 22 will move to the Hall of Justice at 330 W. Broadway, San Diego, California 92101, and become Departments 60 and 61 respectively.

The Family Court and Madge Bradley Buildings will close on July 12, 2017. Family and Probate court operations and hearings in Family and Probate cases will resume on July 17, 2017, in the new Central Courthouse at 1100 Union Street. (**Attachment D**)

- 4. The Superior Court of **San Joaquin County** provided public notice that effective July 28, 2017, the Stockton Courthouse located at 22 E. Weber Avenue and the Family Law Courthouse located at 540 E. Main Street will be permanently closed. All services currently provided to the public by the San Joaquin Superior Court at the Stockton and Family Law Courthouses will be relocated to the new Stockton Courthouse at 180 E. Weber Avenue in Stockton. Public services will resume at the new Stockton Courthouse on July 31, 2017 at 1:00 p.m. (**Attachment E**)
- 5. The Superior Court of **Siskiyou County** provided public notice that effective August 7, 2017, public service window hours will be reduced at the Dorris Branch. Current public service hours of 9:30 a.m. to 3:30 p.m. on the first Monday of the month will be reduced to 9:30 a.m. until court is completed for the day, first Monday of the month. If the first Monday of the month is a judicial holiday, court will be held on the second Monday of the month. (**Attachment F**)

### **Mandate in Government Code Section 68106**

In providing fee increases and fund transfers for the courts in the Judiciary Budget Trailer Bill in 2010, the Legislature expressly declared its intention that trial courts remain open to the public on all days that are not judicial holidays and that access to court services for civil litigants be preserved to the extent practicable. Statements in Government Code section 68106 affirmed this intent, and the recent amendment of the statute strengthened it.

Section 68106 imposes the following requirements on trial courts and the Judicial Council:

• Trial courts must provide written notice to the public at least 60 days before closing any courtroom or closing or reducing the hours of clerks' offices, although "[n]othing in this section is intended to affect, limit, or otherwise interfere with regular court management decisionmaking, including calendar management and scheduling decisions." The trial court is to provide this notice "by conspicuous posting within or about its facilities, on its public Internet Web site, by electronic distribution to individuals who have subscribed to the court's electronic distribution service, and to the Judicial Council . . . . "4 The notice must describe the scope of the closure or reduction in hours, state the financial constraints or other reasons that make the closure or reduction necessary, and invite public comment. Courts expressly are *not* obligated to respond to comments received. If a court changes its plan "as a result of the comments received or for any other reason" during the 60-day notice period, it must "immediately provide notice to the public" by posting and distributing "a revised notice"

using the procedure previously described, including distribution to the council.<sup>7</sup> The change in plan does not require notification, however, beyond the original 60-day period.<sup>8</sup>

• The Judicial Council must, within 15 days of receiving a notice from a trial court, "conspicuously" post the notice "on its Internet Web site" and forward a copy to the chairs and vice-chairs of both houses' Committees on the Judiciary, the chair of the Assembly Committee on Budget, and the chair of the Senate Committee on Budget and Fiscal Review.<sup>9</sup>

### **Implementation Efforts**

Judicial Council staff notified all trial court presiding judges and court executive officers of the enactment of this statutory mandate, and the Judicial Council Legal Services (LS) staff provided legal guidance to help courts comply with the requirements of the statute. Trial courts have been requested to e-mail such notices to Charles Perkins, LS Supervising Attorney, who has provided legal review of the courts' notices since Government Code section 68106 first took effect in 2010.

To fulfill the Judicial Council's obligations under section 68106, the Judicial Council staff has placed on the home page of the California Courts website a prominent link to the Reduced Court Services page (<a href="www.courts.ca.gov/12973.htm">www.courts.ca.gov/12973.htm</a>), which contains a summary of Government Code section 68106 and all notices received from trial courts about closures of courtrooms or clerks' offices or reductions in clerks' office hours. Since the previous report to the council, the notices from the courts detailed above have been added to the web page. The Judicial Council staff has also forwarded the notices from these courts to the designated legislative leaders.

#### **Government Code section 68106:**

- (a) (1) In making appropriations for the support of the trial courts, the Legislature recognizes the importance of increased revenues from litigants and lawyers, including increased revenues from civil filing fees. It is therefore the intent of the Legislature that courts give the highest priority to keeping courtrooms open for civil and criminal proceedings. It is also the intent of the Legislature that, to the extent practicable, in the allocation of resources by and for trial courts, access to court services for civil litigants be preserved, budget cuts not fall disproportionately on civil cases, and the right to trial by jury be preserved.
- (2) Furthermore, it is the intent of the Legislature in enacting the Budget Act of 2010, which includes increases in civil and criminal court fees and penalties, that trial courts remain open to the public on all days except judicial holidays, Saturdays, and Sundays, and except as authorized pursuant to Section 68115.
- (b)(1) A trial court shall provide written notification to the public by conspicuous posting within or about its facilities, on its public Internet Web site, and by electronic distribution to individuals who have subscribed to the court's electronic distribution service, and to the Judicial Council, not less than 60 days prior to closing any courtroom, or closing or reducing the hours of clerks' offices during regular business hours on any day except judicial holidays, Saturdays, and Sundays, and except as authorized pursuant to Section 68115. The notification shall include the scope of the closure or reduction in hours, and the financial constraints or other reasons that make the closure or reduction necessary.
- (2)(A) The notification required pursuant to paragraph (1) shall include information on how the public may provide written comments during the 60-day period on the court's plan for closing a courtroom, or closing or reducing the hours of clerks' offices. The court shall review and consider all public comments received. If the court plan for closing a courtroom, or closing or reducing the hours of clerks' offices, changes as a result of the comments received or for any other reason, the court shall immediately provide notice to the public by posting a revised notice within or about its facilities, on its public Internet Web site, and by electronic distribution to individuals who have subscribed to the court's electronic distribution service, and to the Judicial Council. Any change in the court's plan pursuant to this paragraph shall not require notification beyond the initial 60-day period.
- (B) This paragraph shall not be construed to obligate courts to provide responses to the comments received.
- (3) Within 15 days of receipt of a notice from a trial court, the Judicial Council shall conspicuously post on its Internet Web site and provide the chairs and vice chairs of the Committees on Judiciary, the Chair of the Assembly Committee on Budget, and the Chair of the Senate Committee on Budget and Fiscal Review a copy of any notice received pursuant to this subdivision. The Legislature intends to review the information obtained pursuant to this section to ensure that California trial courts remain open and accessible to the public.
- (c) Nothing in this section is intended to affect, limit, or otherwise interfere with regular court management decisionmaking, including calendar management and scheduling decisions.

Pursuant to Government Code § 68106 and Rule 10.620 of the California Rules of Court, the Superior Court of California, County of San Diego, is providing over 60 days' notice that it will be closing the Family Court Building at 1555 Sixth Avenue, San Diego, CA 92101 and the Madge Bradley building at 1409 Fourth Avenue, San Diego, CA 92101 (including both business operations and courtrooms), and transferring the operations therein to the new San Diego Central Courthouse at 1100 Union Street, San Diego, CA 92101 (the "Central Courthouse"). These actions are due to the completion of the building project to construct the new Central Courthouse.

Pursuant to California Government Code Section 68106, effective August 7, 2017, the Superior Court of California, County of Siskiyou hereby gives notice of its intent to reduce public service window hours at the Dorris Branch from its *current* 9:30am to 3:30pm, first Monday of the month; to *new* hours of 9:30am until court is completed for the day, first Monday of the month. If the first Monday of the month is a judicial holiday, then court will be held on the second Monday of the month.

The Court finds this action is necessary due to the significant and continuing cuts to the State Judicial Branch Budget. Since 2009, state funding for the judicial branch has been significantly reduced, with those reductions impacting the budgets of individual superior courts.
