

# Video Interpreting & Remote Video Proceedings

- The Fresno County Superior Court has taken a leading role in the use of video interpreting services and remote video proceedings.
- Weekly remote video proceedings allow rural residents to access traffic court services without travel to Fresno.



## **E Citation Program**

Fresno County Superior Court in partnership with the California Highway Patrol and the Fresno Police Department started an E Citation program that allows police officers t file tickets with the court electronically.

The court has also started using an "electronic dashboard" to allow Probation to upload reports, risk assessments scores and now generate texts to drug court participants.

### - Drug Court:

 In 2014 after the passage of Proposition 47, Fresno County revamped Drug Court. The court adopted an innovative partnership model leveraging services and navigating defendants to recovery and supportive services.

### - Family Dependency Treatment Court:

- This collaborative effort assists families struggling with child neglect and drug dependency.

### - Human Trafficking Court:

- In March 2017, Fresno County Superior Court was awarded a grant to implement a new calendar to assist juvenile victims of human trafficking.
