The report focuses on action since the council's July meeting and is exclusive of issues on the September business meeting agenda.

# **Advisory Body Appointments**

At the end of the nominations cycle, the Chief Justice made and council staff coordinated 175 appointments to 28 Judicial Council advisory committees, effective September 15, 2018.

# **Judicial Council-Sponsored Legislation**

Assembly Bill 2710 (Obernolte) and Assembly Bill 2532 (Jones-Sawyer), Judicial Council-sponsored bills, were signed into law by the Governor. AB 2710 promotes procedural efficiencies by streamlining and modernizing the warrant process, and AB 2532 provides a uniform rate for converting infraction fines to community service. The latest status of sponsored bills is posted on the California Courts website at: 2018 Legislative Status Chart.

# **Labor and Employee Relations**

Labor negotiations assistance was provided to 17 trial courts, at their request. Services included advice on proposed policy revisions, decertification, and successor memoranda of understanding negotiations. Additionally, support was provided on 14 different labor and employee-related matters.

# **Language Access Services**

- Court Interpreters Program: Five examinations were held for more than 350 candidates in several certified languages including Arabic, Spanish, Mandarin, Cantonese, Farsi, Punjabi, Portuguese, Russian, Vietnamese, and Japanese.
- Video Remote Interpreting: The pilot program concluded in the three superior courts and special demonstrations were held at the Superior Court of Sacramento County. Assembly Member Richard Bloom, Legislative Analyst's Office staff, Department of Finance staff, and interested presiding judges and court executive officers attended. Following an assessment of the pilot program, a final report and recommendations will be presented to the council in March 2019.

# **State-Tribal Joint Jurisdictional Court Opening**

The Superior Court of Humboldt County and the Yurok Tribal Court opened a joint jurisdictional court for families involved in juvenile dependency. This collaborative project is supported by a court innovations grant and may serve as a model for other dual-jurisdiction courts. The Yurok Tribe is the largest in California with a population of almost 7,000 people.

#### **Self-Assessment for Court Compliance**

Self-assessment checklists have been made available to superior courts to evaluate court compliance with council policies in areas such as cash handling and payment processing.

# **Judicial Council Visitors Program**

A delegation of international judges and mediators from eight countries (Cyprus, Estonia, Japan, Krygz Republic, Lebanon, Pakistan, Taiwan, and Uzbeckistan) visited the Judicial Council to learn about court-related alternative dispute resolution (ADR) through the UC Hastings College of the Law, International Court ADR Institute.

• Fifty-three real estate transactions were completed, including three lease renewals for the Superior Court of Mariposa County; 15 license terminations, including BuzzFeed, Inc. at the Stanley Mosk Courthouse and California Dining Services at the Chatsworth Courthouse in Los Angeles County, and 34 short-term event licenses.

#### **Local Court Assistance**

Judicial Council staff provide daily assistance to courts on a multitude of judicial administration issues. Examples include:

- File reviews were conducted at the juvenile courts in El Dorado and Stanislaus Counties to identify any issues and training needs relative to maintaining federal foster care funding.
- In-person and remote technical assistance was provided to Superior Courts of Amador, Kings, San Diego, and San Bernardino Counties on Judicial Branch Statistical Information System reporting.

# **Meeting Details**

# **Advisory Committee for Audits and Financial Accountability**

 Approved a process whereby new court executives may request a shortened review of their court outside of the normal audit process, based on the court's prior completion of selfassessment checklists.

# **Appellate Indigent Defense Oversight Advisory Committee**

• Conducted a quarterly review of court appointed counsel program cases and reviewed data analysis reports that cover the audit pool, case length, out of contact cases, brief length, direct case assistance, cost per page, and other parameters.

#### **Bench-Bar Coalition**

- Confirmed new executive committee members: Mr. James O. Heiting, Cochair; Hon. Paul Bacigalupo, Member-at-Large; and Ms. Beti Tsai Bergman, Member-at-Large.
- Annual meeting: More than 75 members attended the meeting, which included a welcome by the Chief Justice, service awards to leadership of the California Judges Association and the Bench-Bar Coalition, a discussion on advocacy, and a presentation on court technology trends.

# **Civil and Small Claims Advisory Committee**

- Acted on rules and forms that have been circulated for comment to implement recently enacted law authorizing confidentiality of certain information regarding minors relating to protective orders.
- Finalized a legislative proposal to circulate for comment to further recommendations made by the Futures Commission relating to discovery in civil cases.

# **Collaborative Courts Advisory Committee**

- Discussed AB 1810 and SB 215 regarding mental health diversion, and collaborative court responses to the opioid crisis, including medically assisted treatment.
- *Juvenile Subcommittee:* Discussed implementing services to assist homeless youth, educational issues in juvenile court, and increasing awareness of the youth court project.

# **Court Executives Advisory Committee**

Approved the Judicial Branch Statistical Information System Dispute Resolution Process
with amendments, received an overview of grant contracting processes, discussed remote
case access and identity management, received updates concerning *Dynamex Operations*West, Inc. v. Superior Court of Los Angeles, the Interpreter Payment Policy Working Group,
and viewed a presentation on the draft Self-Help Assessment Tool.

- Ad Hoc Working Group on SB 384 Implementation: California Department of Justice conducted stakeholder meetings to discuss registrant termination requirements.
- Judicial Branch Statistical Information System Subcommittee: Discussed implementation of revised reporting standards, the updated manual, and proposed standards for data quality, data amendments, and dispute resolution.
- Joint Trial Court Presiding Judges Advisory Committee (TCPJAC)/Court Executives Advisory Committee (CEAC) Statewide meeting: Discussed the results of the court data analytics business need and demand survey, viewed a demonstration of the California Court Access App, and received updates on the Assigned Judges Program, the Courthouse Construction Program, self-represented litigants related initiatives, and innovations grant projects.
- *Joint TCPJAC/CEAC Legislation Subcommittee:* Reviewed seven bills, including AB 2185 (Chiu) Civil actions: party names; AB 1793 (Bonta) Cannabis convictions: resentencing; and AB 2988 (Weber) Criminal procedure: disposition of evidence.
- Joint TCPJAC/CEAC Emergency Response Workgroup: Created a resource page for the Judicial Resource Network on emergency situations, and finalized draft rule proposal comments.
- Joint TCPJAC/CEAC Working Group to Assess Issues Related to Body Cameras Worn by Law Enforcement: Developed a new resource page on policies governing body cameras for courts.

#### **Court Facilities Advisory Committee**

 Discussed methodology development for capital-outlay plan reassessment criteria required by SB 847 (2018 Budget Act Trailer Bill).

# **Criminal Law Advisory Committee**

• Discussed proposed legislation, including AB 1065 (Jones-Sawyer) Theft: aggregation: organized retail theft; SB 349 (Lara) Courthouses: privilege from civil arrest; SB 1437 (Skinner) Felony murder rule.

#### Family and Juvenile Law Advisory Committee

- Discussed vacatur of convictions related to human trafficking, preservation of extended foster care eligibility, protecting information of persons under 18, and allocation of Court Appointed Special Advocate programming augmentation in fiscal year 2018–19.
- Violence Against Women Education Project Subcommittee: Discussed grant objectives, selfhelp center funding for trial courts, and program development in the areas of domestic violence, stalking, sexual assault, and human trafficking.
- AB 1058 Funding Allocation Joint Subcommittee: Recommended implementing a new
  funding model following the format of the Workload Allocation Funding Methodology
  (including a five percent cap on any increases or decreases, maintaining current funding of
  Cluster 1 courts and shared services courts), and no change in funding for the Family Law
  Facilitator program pending analysis of the impact of the new self-help funding.

# **Futures Traffic Working Group**

Reviewed recommendations for moving traffic infraction cases to a civil model and
expanding online adjudication options, received a presentation by the California District
Attorneys Association on a prosecutorial perspective of the model, and discussed input from
the Family and Juvenile Law Advisory Committee on how the model will impact juveniles.

# Governing Committee of the Center for Judicial Education and Research

- Approved the Judicial College Steering Committee membership.
- Discussed the 2018–2020 Education Implementation Plan, distance delivery design for the Preventing and Responding to Sexual Harassment webinar, and development, support and succession planning for faculty.

#### **Information Technology Advisory Committee**

• Discussed progress on the Strategic Plan Workstream's update to the plan, initiatives that may be continued or removed from the Tactical Plan, reviewed final quarterly reports on technology initiatives of the Futures Commission directives, and considered proposed updates to the Judicial Branch Information Security Framework.

#### **Probate and Mental Health Advisory Committee**

 Discussed plans for the 2019 annual agenda, and proposed amendments to AB 2185 (Chiu), which provides for appointment of a guardian ad litem under a pseudonym in specific circumstances.

# **Trial Court Budget Advisory Committee**

- Finalized the Funding Methodology Subcommittee workplan.
- Recommended allocation methodologies for the \$75 million in new funding, self-help, one-time reduction for fund balances above the one percent reserve cap, and discussed the interpreter funding shortfall.

• Agreed to defer cancelation of the flood protection project for the Solano Hall of Justice and directed staff to submit it as a scope change for the October committee meeting.

# **Trial Court Presiding Judges Advisory Committee**

- Received an update on trailer bill language in AB 1810 regarding mental health diversion, and discussed how the bill impacts current criminal court practices.
- Discussed best practices for creating and retaining records of presiding judges, specifically those concerning complaints about judicial officers.
- Conducted a roundtable to discuss examples of handling difficult conversations with judges.

• Received an update about the judicial workload study and heard informational items about assessing the workload need for court reporters in family law.

The Chief Justice addressed participants, and council members—Associate Justice Ming Chin, Judge Marla Anderson, and Judge David Rubin—participated in a panel presentation on becoming a citizen of the judicial branch.

# **Becoming an Effective One-on-One Trainer**

Designed for leads and those who trains others, this course includes making the most of limited preparation and training time, using a variety of teaching approaches, and evaluating success.

#### **Budget and Fiscal Management (Institute for Court Management)**

Designed for court professionals with varying levels of involvement with court budget, this course defines the building blocks of finance and explains how to plan, prepare, review, present, execute, and monitor a budget.

# **California Access to Visitation Grant Program Training**

Three-day class for clerks in a lead role to build and improve their leadership and training skills while interacting with peers from other counties.

**Definitions:** 

Authorized Position (FTE) Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

**Filled Authorized Position** 

Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

(FTE)

Headcount The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or

Employment Agency Temporary Workers.

**Vacancy (FTE)** The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

Judicial Council Temporary

The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

Employees (909)

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participants in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do

receive CalPERS retirement service credit).

Employment Agency
Temporary Worker (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Contractor (FTE)

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.

Full Time Equivalency (FTE)

Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.

**Time Base** Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

**Regular Employee** Commonly referred to as "permanent employees" – They receive full benefits.

Limited Term Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.
