Executive Summary

The Executive and Planning Committee recommends amending California Rules of Court, rule 10.50 (Governing Committee of the Center for Judicial Education and Research) to change the name of the committee to the Center for Judicial Education and Research Advisory Committee. The amendment will align the name of the committee with those of other Judicial Council advisory committees.

Recommendation

The Executive and Planning Committee (E&P) recommends that the Judicial Council, effective January 1, 2019, amend rule 10.50 to change the name of the Governing Committee of the Center for Judicial Education and Research to the Center for Judicial Education and Research Advisory Committee to align the name with the names of the other Judicial Council standing advisory committees.

Relevant Previous Council Action

The Judicial Council adopted rule 6.50, effective January 1, 1999, and amended and renumbered it as rule 10.50, effective January 1, 2007.

Analysis/Rationale

E&P has determined that the recommended name change adheres to the naming convention of other Judicial Council standing advisory committees.

Rule 10.50 of the California Rules of Court is amended, effective January 1, 2019, to read:

Rule 10.50. ~~Governing Committee of the~~ Center for Judicial Education and Research Advisory Committee

(a) Establishment and purpose

In 1973, the Judicial Council of California and the California Judges Association created the Center for Judicial Education and Research (CJER). In 1993 the oversight body, Governing Committee of CJER, was made an advisory committee to the council through the adoption of former rule 1029. In 2001, the rule that specifies the ~~CJER Governing Committee's duties~~ of that advisory committee was made consistent with the rules pertaining to other Judicial Council advisory committees, ~~but it continues to acknowledge the historic participation of the California Judges Association.~~
