

State Rankings

- Ventura Superior Court's rank among the 58 Superior Courts based on the FY 2015-16 Court Statistics report:
 - 33 Judicial Officers, tied for 14th (with San Mateo)
 - 4,578 filings per judge, ranked 4th
 - 3,786 dispositions per judge, ranked 5th
 - 266 jury trials, ranked 9th
 - 10,819 court trials, misdemeanors, and infractions, ranked 9th



Judicial Officers


- 3.3 additional judges according to the Judicial Needs Study (33 to 36)




Collection Operations

- Ventura Superior Court contracts with Amador, Plumas, Santa Clara and Tulare counties to provide collection assistance.
- \$35 million collected by the Collections Unit.
- 160,000 in-bound telephone calls handled by the collections team.
- The automated call system left 6 million voicemail messages.

Case Management & Technology

- Ventura Superior Court is replacing its V3 case management system with eCourt deployment. The new case management system will allow for e-filing, and electronic document management and access.
- Small Claims is completed. Civil limited and unlimited, Probate and Mental Health are in development with an anticipated go-live in the first half of 2020.
- Family Law and Juvenile Dependency deployments are anticipated later in 2020.



Innovative Grant Funding Successes

Legal Self Help

- Webinars for Family Law and Civil (Spanish and English).
- Self represented litigants register online and interact with staff attorneys by video conference through their computers, tablets or mobile devices.
- Staff attorneys provide legal information, review forms and answer questions the same way as for walk-in services.
- With funding in the 2018 Budget Act earmarked for the expansion of Self Help services, 3 additional staff were hired.


Innovative Grant Funding Successes

Ability to Pay Pilot Project

Ventura County Court is one of five counties participating in the Ability to Pay Pilot Project to test the use of online adjudication technology in traffic cases.

Video Remote Interpretation

One of 3 counties participating in the Video Remote Interpreting (VRI) Pilot Project to test the efficacy of this technology.



Court Reporters

Two staff court reporters were hired with funding earmarked in the 2018 Budget Act for Court Reporter expansion into Family law.



Juvenile Justice

- Funded through an innovation grant, Juvenile Justice Family Engagement Workshops are aimed at educating parents and legal guardians who have youths entering the juvenile justice system for the first time.
- The project has produced a juvenile justice orientation video in English and Spanish posted on the Court's

 - Resource guide


