The following information outlines some of the many activities staff is engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's May meeting and is exclusive of issues on the July business meeting agenda.

## Trial Court HR and Payroll Management System Deployment

The Phoenix human resources and payroll management system was deployed to the Superior Court of Colusa County. They are the 16th court to adopt the system, which integrates with the branch's statewide financial system and provides full support for organizational management, personnel and benefits administration, time management, and all aspects of payroll and compliance reporting.

## **Court Interpreter Testing**

Following the Bilingual Interpreting Examination, the Judicial Council certified 26 interpreters in the following languages: Spanish (20 candidates), Russian (3 candidates), Korean (2 candidates), and Vietnamese (1 candidate). California has approximately 1,700 certified interpreters and 15 certified spoken languages.

#### **Self-Help Services**

- Court Self-Help Tracking and Reporting Survey: Visits were made to 11 courts to observe and train court staff in the implementation of the tracking and reporting survey in Self-Help Centers and Family Law Facilitator offices.
- Usability of Judicial Council Forms: Staff visited the Fairfield courthouse in Solano County to gather feedback from judicial officers and self-help center staff on usability of Judicial Council forms for revisions that would increase accessibility to the public.

#### AB 1058 Child Support Program Rolling Time Study

Eight courts began implementation of a newly-approved AB 1058 timekeeping methodology for Child Support Commissioner Program and Family Law Facilitator Programs. The study will improve reporting of time expended on reimbursable activities related to Title IV-D federal law that assists families in receiving child support.

## Fiscal Audit of the Judicial Council

The State Controller's Office concluded that the Judicial Council had complied with the State's financial rules for the revenues, expenditures, and fund balances under its control for fiscal year 2017–18. Government Code, Section 77206(i) requires independent, external audits of the Judicial Council biennially. The results, which were reported to the Legislature, positively reflects the council's commitment to financial accountability and transparency.

#### Labor and Employee Relations

Labor negotiations assistance was provided to eight trial courts.

• Fourteen additional real estate transactions were completed, including a new lease/license in Los Angeles County; lease renewals in Inyo (2), Orange, Sacramento, and Santa Barbara Counties; a lease termination at the Superior Court of Tulare County; and execution of six short-term event licenses.

#### Veterans Treatment Court Strategic Planning

California was one of five states (others being Maine, Ohio, Pennsylvania, and Virginia) invited by the New York-based Center for Court Innovation to participate in a two-day strategic planning meeting for veterans treatment courts. Stakeholders representing multiple state and county agencies including attorneys, law enforcement, and service providers focused on state capacity for meeting the needs of veterans and enhancement of these collaborative courts.

#### **International Visitor Program**

Staff met with a delegate from Northern Ireland's Civil Service Community Safety Division and coordinated a visit to the San Francisco Community Court. (Judicial Council staff periodically respond to briefing requests from justice representatives from other states and countries.)

Definitions: Authorized Position (FTE)	Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.
Filled Authorized Position (FTE)	Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.
Headcount	The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or Employment Agency Temporary Workers.
Vacancy (FTE)	The number of vacancies is the number of authorized positions minus the number of filled authorized positions.
Vacancy Rate (FTE)	Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees ("909" funded employees). See definition of temporary employees below.
Judicial Council Temporary Employees (909)	The "909 category is the State Controller code used to reference a temporary position or a temporary employee. 909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due tot he unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement service credit).
Employment Agency Temporary Worker (FTE)	These are workers from an employment agency. They are employees of the employment agency that provide short-term support.
Contractor (FTE)	Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.
Full Time Equivalency (FTE)	Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.
Time Base	Full time: Employee is scheduled to work 40 hours per week. Receives full benefits. Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits. Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.
Regular Employee	Commonly referred to as "permanent employees" – They receive full benefits.
Limited Term	Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.


