Executive Summary

Government Code section 69958 requires the Judicial Council to report to the Legislature semiannually on the purchase and lease of any electronic recording equipment that will be used to record superior court proceedings. Government Code 69957(a) allows the purchase and or lease of electronic recording equipment for limited civil, misdemeanor, infraction, and small claims cases. Additionally, Government Code section 69957(c) requires the courts to obtain advance approval from the Judicial Council before purchasing or leasing any such equipment. Approval is subject to the equipment being used only in the manner and for the purposes authorized under this section. During the July 1 through December 31, 2019 reporting period, five courts spent a combined total of \$160,937 for equipment or related items.

The Superior Court of Kern County spent \$34,800 to purchase electronic recording equipment and software. These purchases, which were approved by Judicial Council staff on March 16, 2019, are for official court records in limited civil, misdemeanor, infraction, and small claims case types. The Superior Court of Los Angeles County spent \$36,116 to purchase electronic recording equipment and For the Record (FTR) Gold software. These purchases, approved by Judicial Council staff on April 11, 2019, are for official court records in limited civil and infraction case types. The Superior Court of Orange County spent \$44,484 to purchase three FTR Gold hardware and software systems to be used in traffic and misdemeanor case types. These purchases were approved by Judicial Council staff on July 12, 2019. The Superior Court of San

Mateo County spent \$41,321 to purchase electronic recording equipment and software. These purchases, approved by Judicial Council staff on June 26, 2019, are for official court records in arraignments and pretrials. The Superior Court of Santa Barbara County spent \$4,216 to purchase an FTR Reporter Suite 6.2 software license, approved by Judicial Council staff. This software is used for small claims, infractions, misdemeanors, and limited civil case types.

Relevant Previous Council Action

These reports are submitted to the Legislature semiannually. Previous reports can be found at www.courts.ca.gov/7466.htm.

Analysis/Rationale

The semiannual submission of this report to the Legislature is required under Government Code section 69958. The statute requires that each superior court report to the Judicial Council the purchase and lease of all electronic recording equipment that will be used to record court proceedings, specifying all of the following:

- (a) The superior court in which the equipment will be used.
- (b) The types of trial court proceedings in which the equipment will be used.
- (c) The cost of purchasing, leasing, or upgrading the equipment.
- (d) The type of equipment purchased or leased.

Fiscal Impact and Policy Implications

The requirements of this report do not result in any additional costs or operational impact.

Dear Ms. Boyer-Vine, Ms. Contreras, and Ms. Parker:

Pursuant to Government Code section 69958, the Judicial Council is submitting the *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts*, for the reporting period of July 1 through December 31, 2019.

Government Code 69957(a) allows the purchase or lease of electronic recording equipment for limited civil, misdemeanor, infraction, and small claims cases. The report specifies the name of the court, types of proceedings for which the equipment will be used, cost of the equipment, and types of equipment purchased or leased.

Additionally, Government Code section 69957(c) requires the courts to obtain advance approval from the Judicial Council before purchasing or

leasing any such equipment. Approval is subject to the equipment being used only in the manner and for the purposes authorized under this section.

During the July 1 through December 31, 2019 reporting period, five courts spent a combined total of \$160,937 for equipment or related items.

The Superior Court of Kern County spent \$34,800 to purchase electronic recording equipment and software. These purchases, approved by Judicial Council staff, are for official court records in limited civil, misdemeanor, infraction, and small claims case types. An itemized list can be found in Attachment A.

The Superior Court of Los Angeles County spent \$36,116 to purchase electronic recording equipment and For the Record (FTR) Gold software. These purchases, approved by Judicial Council staff, are for official court records in limited civil and infraction case types. An itemized list can be found in Attachment B.

The Superior Court of Orange County spent \$44,484 to purchase three FTR Gold hardware and software systems. These purchases, approved by Judicial Council staff, are for official use in traffic and misdemeanor case types. An itemized list can be found in Attachment C.

The Superior Court of San Mateo County spent \$41,321 to purchase electronic recording equipment and software. These purchases, approved by Judicial Council staff, are for official court records in arraignments and pre-trials. An itemized list can be found in Attachment D.

The Superior Court of Santa Barbara County spent \$4,216 to purchase an FTR Reporter Suite 6.2 software license. These purchases, approved by Judicial Council staff, are for use in small claims, infractions, misdemeanors, and limited civil case types. An itemized list can be found in Attachment E.
