Executive Summary

Government Code section 77202.5(a) requires the Judicial Council to report to the Legislature annually on allocations and reimbursements to the trial courts. On September 30, 2020, Judicial Council staff submitted to the Legislature the report entitled *2019–20 Allocations and Reimbursements to the Trial Courts*.

Relevant Previous Council Action

These reports have been submitted to the Legislature annually. Previous reports are available at www.courts.ca.gov/7466.htm.

Analysis/Rationale

The allocations and reimbursements from state funds include (1) the fiscal year 2019–20 base allocations for court operations; (2) reimbursements for specific trial court expenditures including, but not limited to, jury, self-help center, court interpreter, and court-appointed dependency counsel costs; (3) fee revenue amounts that are distributed directly back to the reporting courts as authorized in statute or by the Judicial Council; and (4) funding awarded to individual trial courts from statewide programs, including state and federal grants. Funding was provided from the following funds:

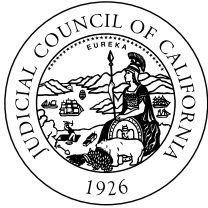
- Trial Court Trust Fund (\$2.360 billion);
- Immediate and Critical Needs Account, State Court Facilities Construction Fund (\$50 million);
- State Trial Court Improvement and Modernization Fund (\$8.215 million);
- General Fund (\$129.845 million); and
- Federal Trust Fund (\$744,030).



C	Self-Help in Base Budget	This adjustment reflects the portion of courts' ongoing base allocation that is provided to reimburse courts' self-help center costs. This amount is included in the courts' total amounts listed under "Self-Help Centers" (Column AD).
D	Self-Help in Base Budget Adjustment	This adjustment removes from the ongoing base the 3-year, limited-term Self-Help funding from 2018-19
E	Workload Formula Adjustment	This allocation reflects each court's share of the 2019-20 Workload Formula funding floor allocation adjustment.
F	Funding for Court Reporters in Family Law	This augmentation was provided in the 2019 Budget Act and was intended for courts to increase court reporters in family law.
