Executive Summary

The Center for Judicial Education and Research (CJER) Advisory Committee has completed its 2018–2020 Education Plan Final Report for the judicial branch (see Attachment A). The education plan, developed by the CJER Advisory Committee for all the judicial branch audiences that CJER serves, contains training and education programs and products that enable those audiences to fulfill the education requirements and expectations outlined in rules 10.451–10.491 of the California Rules of Court. This final report provides an overview of the education plan's execution.

Relevant Previous Council Action

Since 2009, the CJER Advisory Committee, working with its nine curriculum committees, has developed an education plan every two years for submission to the Judicial Council. The Judicial Council approved the 2018–2020 Education Plan on January 12, 2018.

Analysis/Rationale

The education plan was developed during months of work conducted by the CJER Advisory Committee's nine curriculum committees and included their prioritized recommendations for fiscal years 2018–19 and 2019–20, with additional analysis on all high-cost education programs. These recommendations were then assessed by staff to determine if funding and staffing

resources were sufficient to implement them. Finally, the CJER Advisory Committee reviewed, prioritized, and finalized the entire plan. The process ensures a high degree of transparency and review by judicial officers, as well as court leaders who serve on both the CJER Advisory Committee and the CJER curriculum committees.

The curriculum committees reviewed their respective curricula (civil, juvenile, family law, etc.) and determined if there were gaps, and, if so, the content that should be provided and the type of delivery method. The CJER Advisory Committee, in reviewing the education recommendations from its nine curriculum committees, considered several alternative content and delivery proposals. When the CJER Advisory Committee first met to begin reviewing the 2018–2020 education plan, staff noted that available resources were insufficient to deliver all of the committees' highest priorities. The programs that were unable to be resourced were noted and discussed thoroughly by the CJER Advisory Committee, before making determinations regarding priorities.

During the 2018–2020 Education Plan period, CJER staff followed reporting and tracking protocol to confirm that all of the items in the education plan (Attachment A) were being developed and delivered as scheduled and that any deviations from the plan, of either the delivery schedule or the delivery method, were noted, explained, and, where appropriate, brought to the attention of the relevant curriculum committee(s) and the CJER Advisory Committee for action.

Summary of findings

In sum, the development and delivery of education for the judicial branch as contained in the 2018–2020 Education Plan were highly successful. The vast majority of all the educational programs and products included in the 2018–2020 plan was delivered on schedule. These products included statewide live events, regional programming, online courses, broadcasts, webinars, podcasts, and CJER's extensive array of legal publications. The 2018–2020 Education Plan demonstrates the accountability and transparency of the development and delivery of education to the audiences within the judicial branch.

Toward the end of the 2018–2020 Education Plan period, a global pandemic caused by the COVID-19 virus began. Consequently, starting in mid-March 2020 and continuing through the end of the 2018–2020 Education Plan period, which concluded at the end of June 2020, all inperson education events were cancelled. Some in-person education events that had been scheduled to be offered during that time period were converted to a remote delivery format. And several new education products were added to the Education Plan to meet the changing needs of the courts.

Scale of the education plan. Over 200 separate statewide and regional in-person courses and programs for judicial branch audiences were delivered during 2018–2020, along with over 40 live and recorded, distance education events (webinars).

Nearly 60 distance education products—including videos, self-paced online courses, and online tutorials—were produced, as well as the updating of seven self-paced online courses.

Thirty-six new podcasts and podcasts repurposed from videos were posted. In addition, CJER updated 24 judicial publications during this period, and produced over 15 new bench tools, bench tool updates, and job aids.

The CJER Online website, where judicial branch audiences can find videos, podcasts, self-paced online courses, recorded webinars, job aids, and a range of publications, as well as register for upcoming live in-person courses and webinars, has become the most frequently used delivery mechanism for judicial branch education.

Scope of the education plan. The 2018–2020 Education Plan contains an enormous amount of variety in content and subject areas, including the standard programs and products CJER has delivered for many years: the Judicial College, the judicial institutes, the statewide and regional court staff classes, and videos.

The education plan introduced some new topics, such as "Digging In, Discovering and Dismantling Implicit Bias"; "Expanding Access to Justice for Self-Represented Litigants in Appellate Courts"; "Proper Use of Risk Assessments in Pretrial Detention Decisions"; and several new additions due to the COVID-19 pandemic, including "Initiating Remote Settlement Conferences." Videos produced during this plan and posted on CJER Online covered a number of timely topics, including *Electronic Civil Discovery, Protecting the Rights of Litigants with Mental Impairments, Gender Identity,* and *Capital Habeas Corpus Proceedings After Proposition 66.*

For court staff and leadership, education products were delivered on topics such as "Leading High Performing Teams"; "Making Difficult Conversations Productive"; "Death Penalty Habeas Corpus Petitions in the Trial Courts"; and several new additions due to the COVID-19 pandemic, including "Managing Remotely: Empathy, Effectiveness and Efficiency."

Fiscal Impact and Policy Implications

During the implementation of the plan, completed at the end of June 2020, the only change in fiscal impact resulted from the cancellation of all in-person programming between March and the end of June, which resulted in cost savings.
