Executive Summary

This report summarizes Judicial Council Court Innovations Grant Program activity for the first quarter of fiscal year 2020–21.

Relevant Previous Council Action

In March 2017, the council awarded \$23.5 million in total grants for projects designed to improve court efficiency and increase the public's access to justice. The council also allocated \$625,000—out of the statutorily authorized \$1.25 million—for administration costs and retained 3 to 4 percent of each category's funding for unforeseen expenses incurred by grant-funded projects.

In June 2017, the council delegated to the Judicial Branch Budget Committee authority to decide whether to approve funding adjustments.¹ The delegation requires the Budget Committee to use the same criteria used in deciding the original awards and to report quarterly to the council about any authorized adjustments.

Analysis/Rationale

Award and budget adjustments

The Budget Committee approved two types of award and budget adjustments in the first quarter of fiscal year (FY) 2020–21:

Award increases

- \$19,819.00 for the Collaborative Court Management Information System of the Superior Court of Alameda County for developer services to address additional identified program needs.
- \$53,250.31 for the Video Appearances and Remote Evidence Sharing project of the Superior Court of Placer County for continued efforts necessitated by the COVID-19 mitigation efforts.
- \$80,880.00 for the Remote Video-Conferencing Technology project of the Superior Court of Butte County to provide support to additional courts during COVID-19 mitigation efforts.
- \$404,066.63 for the Internet Based Self-Help Workshops project of the Superior Court of Ventura County to provide continued support and creation of webinars and online services during the mitigation efforts surrounding COVID-19.

Shifts between budget categories

- \$40,000.00 for the Improving Court Management Through the Use of Analytics project of the Superior Court of Orange County to provide continued consultant support toward the creation of the project dashboard.
- \$283,702.30 for the Community Supervision Court for the Superior Court of San Joaquin County to expand the number of participant services and use of an outside drug testing facility.
- \$22,429.18 for the Remote Video-Conferencing Technology project of the Superior Court of Butte County for continued support of the program during the grant extended timeline.
- \$150,908.56 for the Collaborative Justice System project of the Superior Court of Santa Cruz County to provide additional case manager support during the grant extended timeline and impact of COVID-19–related workload.
- \$52,200.22 for the Instant Family Law Orders project of the Superior Court of Santa Barbara County to address additional consultant support needed and the provision of additional functionality.

Contingency fund balance

As of the date of this report, the balance of the contingency fund is \$1,307,967.28, allocated as follows:

- \$1,198,900.17 for collaborative court projects;
- \$17,753.11 for self-help, family, and juvenile court projects; and
- \$91,314.00 for other efficiency projects.

The Budget Committee will continue to monitor the contingency fund closely and report on any changes.

Summary of findings

Of the 52 projects awarded grant funding, 49 projects are moving forward.² The amount awarded to the 52 projects totals just over \$22.9 million.³ As of the first quarter of FY 2020–21, a little over \$22.89 million has been distributed to the projects.⁴

Of the approximately \$22.89 million distributed to the awardee courts, a little under \$20 million was expended by the awardees through FY 2020–21, quarter 1, with approximately \$508,000 expended in quarter 1. To the extent feasible in the current environment, council staff continue to coordinate with awardee courts to view postimplementation project demonstrations and participate in project discussions. This engagement complements both the administration of the grant and future project specific reporting.

Fiscal Impact and Policy Implications

Next steps

The Budget Committee and council staff will continue to collect and review quarterly reports; track project budgets, expenditures, and implementation plans; and measure projects' outcome goals. Staff will also continue to work with the projects to help gauge the innovation, efficiency, accessibility, modernization, replicability, sustainability, and cost impact of each project. Judicial Council Audit Services staff will assist with monitoring the grant program by conducting periodic reviews of specific grant projects.
