The following information outlines some of the many activities staff are engaged in to further the Judicial Council's strategic goals and priorities for the judicial branch. The report focuses on action since the council's March meeting.

Judicial Branch Budget For Fiscal Year 2021–22

Following the release of the Governor's 2021–22 May Budget Revision on May 14, 2021, a briefing memo was disseminated branchwide and informational calls were held with judicial branch leadership. The proposed revision continues to support all judicial branch proposals introduced in the January budget and, with the revised proposal, provides a total of \$1.2 billion in new funding. Key proposals newly introduced include (1) a debt forgiveness program for low-income individuals, (2) additional deferred maintenance funding, (3) additional funding for pretrial services, (4) support for backlogs and case processing delays, (5) an Early Disposition Readiness Conference Program, and (6) new courthouse construction projects. As part of the ongoing advocacy related to the budget cycle for the 2021–22 fiscal year, senior Judicial Council staff and court representatives continue to participate in legislative budget hearings related to judicial branch budget proposals and programs. Staff also met with the Legislative Analyst's Office to respond to budget related questions.

Workgroup on Post-Pandemic Initiatives

The Ad Hoc Workgroup on Post-Pandemic Initiatives was established in March to examine successful court practices adopted during the pandemic and recommend those that demonstrate the most promise to increase access to justice, modernize services, and promote consistency and uniformity throughout the state. The workgroup, which is comprised of Judicial Council member, received input from presiding judge and court executive leadership about successful reforms occurring throughout the state court system in response to the pandemic. Input was also sought and received from stakeholders and justice systems partners, including from labor unions and legal trade associations.

COVID-19 and Wildfire Costs

- Monthly pandemic cost reports were submitted to the Department of Finance (DOF) on behalf of the courts and the Judicial Council for statewide reporting to the Legislature. A total of \$189.5 million in COVID-related costs has been reported by the Courts of Appeal, trial courts, and the council from March 2020 to March 30, 2021. The Administration and the Legislature considered these statewide COVID costs in development of the May Budget Revision.
- Monthly reports are also submitted on judicial branch expenditures in response to wildfires. To date, \$5.3 million in wildfire-related costs have been reported for fiscal year 2020–21.

MyCitations Deployment and Development

- Ability to Pay: The Superior Court of Monterey County became the seventh court to deploy the 'My Citations' Ability to Pay application and offer ability-to-pay determinations for addressing traffic violations.
- Online Trial By Declaration: Development is complete on the Online Trial by Declaration
 module of the 'MyCitations' application, which allows a litigant to request and submit
 evidence for an online trial by declaration. The new module includes the ability to send
 notices to the officer and receive secured Officer Declarations. Clerks and judicial officers
 have the functionality to manage requests, review submissions, issue decisions, and update
 the court case management system. The Superior Court of Santa Clara County is working to

add this new module to the common standards-based platform (CourtStack environment), which will ease onboarding of future courts. Testing will begin in summer for deployment in early fall of 2021.

Court Video Communications Licensing

The Judicial Council secured enterprise video communications licensing for Zoom to support trial courts' needs for video conferencing and meeting services, combining the branch's licensing needs to realize a volume discount. User licenses will be funded by the council for three years. The government version of this service provides a high level of security and may be used for court proceedings, mediation appointments, self-represented litigant appointments, online workshops, and other customer support.

Judicial Resources and Technical Assistance

Courtesy file reviews were conducted for juvenile cases at the Superior Courts of Glenn, Kern, Orange, and Riverside Counties to identify any legal issues and training needs.

Pretrial Pilot Program

The Pretrial Pilot Program hosted three virtual information sessions for the 16 pilot courts to discuss pretrial risk assessment research and raise awareness and generate discussion about what pilot courts could expect in partnering with an outside research institution.

Labor and Employee Relations

Labor negotiations assistance was provided to 16 trial courts. Services included impact bargaining, side letter negotiations, and successor memoranda of understanding negotiations. Support was also provided to courts on 32 labor and employee-related matters.

Facilities

- Court Construction Bond Sales: The Judicial Council completed documentation in consultation with the State Public Works Board and the State Treasurer's Office on two bond sales—one sale will refinance debt on the Superior Court of Madera County Courthouse project; the other will repay interim loans to fund construction of the new Sonora Courthouse project for the Superior Court of Tuolumne County.

• Eleven real estate transactions were completed, including expense lease renewals for courts in San Francisco and Placer Counties; revenue lease/license renewals and amendments in San Diego and Santa Clara Counties; a joint operating agreement amendment, a new lease, and an event license in Los Angeles County; and an estoppel in San Bernardino County.

- Authorized total expenditures of \$9,910,149 and an additional \$21,637 for security-related projects.
- Approved removal of the temporary hold on funding Priority 2 projects based on administrative savings and the state Department of Finance's support for the branch to request \$2.5 million in fiscal year 2020–21 from the State Court Facilities Construction Fund.
- Approved the draft Trial Court Facility Modifications Report for Quarter 3, and three security-related projects.

Definitions:

Authorized Position (FTE) Authorized positions include all regular ongoing positions approved in the Budget Act for that year. The number is based on the position's approved full time equivalency.

Filled Authorized Position

Filled authorized positions are the number of authorized positions filled based on the employee's full time equivalency.

(FTE)

Headcount The actual count of persons employed by the Judicial Council, regardless of FTE. This number could be more than the FTE count due to part-time employees being counted as "1". This count does not include Judicial Council Temporary Employees (909) or

Employment Agency Temporary Workers.

Vacancy (FTE) The number of vacancies is the number of authorized positions minus the number of filled authorized positions.

Vacancy Rate (FTE) Vacancy Rate is calculated by dividing the number of authorized positions by the number of vacant authorized positions. This number excludes temporary employees). See definition of temporary employees below.

Judicial Council Temporary

The "909 category is the State Controller code used to reference a temporary position or a temporary employee.

Employees (909)

909 Position - it is a position that may not be funded through the Budget Act and it is categorized by the Office of the State Controller as a temporary position used in the absence of an authorized position. 909 positions may be occupied by regular full-time employees due to the unavailability of an authorized vacant position. 909 Employee - An employee whose salary is not funded through the Budget Act. 909 employees may receive benefits if employed at least half-time and the term of employment is for more than six months. Types of "909" Temporary Employees include: Retired Annuitants: A retired annuitant is a retiree who is hired by his or her former employer or by another employer that participates in the same retirement system as the former employer. This includes a former participant in a state retirement system who has previously retired and who is currently receiving retirement benefits. Temporary: Employees employed on a temporary basis - they do not receive full benefits (but do receive CalPERS retirement service credit).

Employment Agency
Temporary Worker (FTE)

These are workers from an employment agency. They are employees of the employment agency that provide short-term support.

Contractor (FTE)

Individuals augmenting the work of the organization and providing services for a limited period of time or on a specific project, where a particular skill set is required that is either (1) not within an existing classification and/or job description or (2) where recruitment issues require the use of a contractor.

Full Time Equivalency (FTE)

Full Time Equivalency is the number of total maximum compensable hours designated in a year divided by actual hours worked in a year. For example, the work year is defined as 2,080 hours; one employee occupying a paid full time job all year would consume one FTE. One employee working for 1,040 hours each would consume .5 FTE.

Time Base Full time: Employee is scheduled to work 40 hours per week. Receives full benefits.

Part time: Employee is scheduled to work less than 40 hours per week. Employees that work more than 20 hours per week receive full benefits.

Intermittent: Employees have no established work schedule and work on an as-needed basis that varies from one pay period to the next. Eligibility for certain benefits may be limited for these employees.

Regular Employee Commonly referred to as "permanent employees" – They receive full benefits.

Limited Term Limited Term Position – It is a position that is funded through the Budget Act with a specific end date. The position is counted as an authorized position. Employee in limited term positions may be regular or temporary.
