## **Executive Summary**

Government Code section 69958 requires the Judicial Council to report to the Legislature semiannually on the purchase and lease of any electronic recording equipment that will be used to record superior court proceedings. During the reporting period of July 1 through December 31, 2020, five courts reported spending a combined total of \$242,214 for equipment or related items.

### **Relevant Previous Council Action**

## Analysis/Rationale

Government Code 69957(a) allows the purchase and/or lease of electronic recording equipment for limited civil, misdemeanor, infraction, and small claims cases. Additionally, Government Code section 69957(c) requires the courts to obtain advance approval from the Judicial Council before purchasing or leasing any such equipment. Approval is subject to the equipment being used in the manner and for the purposes authorized under this section.

From July 1 through December 31, 2020, five courts spent a combined total of \$242,214 for equipment or related items. All items were approved by Judicial Council staff.

The Superior Court of Mendocino County spent \$4,320 to purchase a For the Record (FTR) Gold software license for official court records in misdemeanor, infraction, limited civil, and small claims case types (see Attachment A).

The Superior Court of Nevada County spent \$10,590 to purchase two Notewise Audio Plus P306B 4 Channel bundles for official court records in misdemeanor and infraction case types (see Attachment B).

The Superior Court of San Bernardino County spent \$65,000 to purchase 41 Microsoft Surface GOs, 41 Surface docking stations, and 41 FTR Gold software licenses for official court records in misdemeanor, infraction, limited civil, traffic, and small claims case types (see Attachment C).

The Superior Court of San Francisco County spent \$104,373 to purchase 26 digital signal processors, recording software, and annotation modules for official court records in misdemeanor, infraction, limited civil, and small claims case types (see Attachment D).

The Superior Court of San Mateo County spent \$57,931 to purchase recording equipment and software for official court records in misdemeanor and unlawful detainer case types (see Attachment E).

The semiannual submission of this report to the Legislature is required under Government Code section 69958. The statute requires that each superior court report to the Judicial Council the purchase and lease of all electronic recording equipment that will be used to record court proceedings, specifying all of the following:

- The superior court in which the equipment will be used.
- The types of trial court proceedings in which the equipment will be used.
- The cost of purchasing, leasing, or upgrading the equipment.
- The type of equipment purchased or leased.

The requirements of this report do not result in any additional costs or operational impact.

Pursuant to Government Code 69958, the Judicial Council is submitting the semiannual *Report of Electronic Recording Equipment Purchased or Leased by Superior Courts*, for the reporting period of July 1 through December 31, 2020.

Government Code 69957(a) allows the purchase or lease of electronic recording equipment for limited civil, misdemeanor, infraction, and small claims cases. The report specifies the name of the court, types of proceedings for which the equipment will be used, cost of the equipment, and types of equipment purchased or leased.

Additionally, Government Code section 69957(c) requires the courts to obtain advance approval from the Judicial Council before purchasing or

leasing any such equipment. Approval is subject to the equipment's being used only in the manner and for the purposes authorized under this section.

During the July 1 through December 31, 2020, reporting period, five courts spent a combined total of \$242,214 for equipment or related items. All items were approved by Judicial Council staff.

The Superior Court of Mendocino County spent \$4,320 to purchase a For the Record (FTR) Gold software license. This purchase is for official court records in misdemeanor, infraction, limited civil, and small claims case types. An itemized list can be found in Attachment A.

The Superior Court of Nevada County spent \$10,590 to purchase two Notewise Audio Plus P306B 4 Channel bundles. These items are for official court records in misdemeanor and infraction case types. An itemized list can be found in Attachment B.

The Superior Court of San Bernardino County spent \$65,000 to purchase 41 Microsoft Surface GOs, 41 Surface docking stations, and 41 FTR Gold software licenses. These purchases are for official court records in misdemeanor, infraction, limited civil, traffic, and family law case types. An itemized list can be found in Attachment C.

The Superior Court of San Francisco County spent \$104,373 to purchase 26 digital signal processors, recording software, and annotation modules. These purchases are for official court records in misdemeanor, infraction, limited civil, and small claims case types. An itemized list can be found in Attachment D.

The Superior Court of San Mateo County spent \$57,931 to purchase recording equipment and software. These purchases are for official court records in misdemeanor and unlawful detainer case types. An itemized list can be found in Attachment E.
